Senate Concurrent Resolution No. 29—Relative to the Police Officer Daniel T. Fraembs Memorial Highway.

LEGISLATIVE COUNSEL'S DIGEST

SCR 29, as introduced, Soto. Police Officer Daniel Fraembs Memorial Highway.

This measure would dedicate State Highway Route 71 within the city limits of the City of Pomona, California, to the memory of City of Pomona Police Officer Daniel T. Fraembs and would specify that this portion of the State Highway Route 71 shall be known as the "Police Officer Daniel T. Fraembs Memorial Highway." The measure also would request the Department of Transportation to determine the cost of appropriate highway plaques and markers showing that special designation and, upon receiving donations from nonstate sources sufficient to cover that cost, to erect those highway markers and signs.

- 1 WHEREAS, Officer Daniel T. Fraembs, a City of Pomona
2 police officer, was killed in the line of duty while on patrol in the
3 City of Pomona on May 11, 1996; and
4 WHEREAS, Officer Daniel T. Fraembs, became the first officer
5 shot to death in the Pomona Police Department's 108 year-history;
6 and
7 WHEREAS, Officer Daniel T. Fraembs, was born an orphan in
8 Hong Kong and was adopted at the age of nine months by Donald
9 and Dorothy Fraembs of Cincinnati, Ohio; and

1 WHEREAS, Officer Daniel T. Fraembs became a citizen of the
2 United States in 1963, graduated from high school and Fullerton
3 Community College, and later joined the United States Marine
4 Corps; and

5 WHEREAS, Officer Daniel T. Fraembs was appointed to the
6 Orange County Sheriff’s Department in 1988, where he worked
7 for five years before joining the Pomona Police Department as a
8 police officer; and

9 WHEREAS, Officer David T. Fraembs was mortally wounded
10 when he was gunned down on an isolated street on May 11, 1996.
11 Now, therefore, be it

12 *Resolved by the Senate of the State of California, the Assembly*
13 *thereof concurring*, That the Legislature hereby dedicates State
14 Highway Route 71 within the city limits of the City of Pomona,
15 California, to the memory of Officer Daniel T. Fraembs; and be it
16 further

17 *Resolved*, That State Highway Route 71 within the city limits of
18 the City of Pomona, California, be officially dedicated the “Police
19 Officer Daniel T. Fraembs Memorial Highway”; and be it further

20 *Resolved*, That the Department of Transportation is requested to
21 determine the cost of appropriate plaques and markers consistent
22 with signing requirements of the State Highway System, showing
23 this special designation, and upon receiving donations from
24 nonstate sources sufficient to cover that cost, to erect those plaques
25 and markers; and be it further

26 *Resolved*, That the Chief Clerk of the Senate transmit copies of
27 this resolution to the Department of Transportation and to the
28 author for appropriate distribution.
