An act to add Section 51220.6 to the Education Code, *and* to amend and repeal Section 11101 of, ~~and to add Section 1686 to~~ the Vehicle Code, relating to instruction.

LEGISLATIVE COUNSEL'S DIGEST

SB 524, as amended, Vasconcellos. Instruction: automobile driver education.

(1) Existing law requires a driver's license issued to a person under 18 years of age to be issued under the provisional licensing program. Among the components of that program, an applicant for a provisional license is required to provide satisfactory completion of approved courses in automobile driver education and driver training maintained under the Education Code in a secondary school of this state or equivalent instruction in a secondary school of another state. Alternatively, existing law allows the applicant to satisfactorily complete an integrated driver education and training program, or the automobile driver education component may be satisfied through

satisfactory completion of equivalent professional instruction acceptable to the Department of Motor Vehicles.

This bill would provide that the satisfactory completion of a course in automobile driver education offered by a private secondary school satisfies the instructional component requirements of these provisions if specified conditions are met. ~~The bill would impose increased duties on the department regarding home study automobile driver education courses offered by private secondary schools.~~

(2) Existing law generally regulates driving schools and driving instructors. However, existing law provides, until a July 1, 2004, inoperative date, that those provisions are not to be construed to direct or restrict driver education courses offered by private secondary schools, as defined, or to require credentialed or certified instructors for courses offered by those private schools. Existing law repeals these provisions on January 1, 2005.

This bill would delete the July 1, 2004, inoperative date and the January 1, 2005, repeal date, thereby continuing these provisions indefinitely.

*The people of the State of California do enact as follows:*

1 SECTION 1. Section 51220.6 is added to the Education Code,  
2 to read:

3 51220.6. (a) For the purposes of subdivision (j) of Section  
4 51220, *Section 51220.1*, and subparagraph (A) or (C) of paragraph  
5 (3) of subdivision (a) of Section 12814.6 of the Vehicle Code, the  
6 satisfactory completion by a pupil of a course in automobile driver  
7 education offered by a private secondary school satisfies the *driver*  
8 *education* instructional requirements of those provisions *and the*  
9 *Department of Motor Vehicles shall issue certificates of*  
10 *satisfactory completion forms* if the following conditions are met:

11 (1) The private secondary school has a current affidavit or  
12 statement on file under Section 33190 ~~and has operated, using a~~

28 ~~representation that will cause monetary loss to a person taking~~  
29 ~~instruction from the school or monetary loss to the state or any~~

31 ~~(b) If a private secondary school is unable to meet the~~  
32 ~~requirements in paragraph (1) of subdivision (a), the private~~  
33 ~~secondary school shall meet the following requirements:~~

34 ~~(1) Submit its course for approval by the Department of Motor~~  
35 ~~Vehicles under subdivision (c) of Section 1686 of the Vehicle~~  
36 ~~Code. The Department of Motor Vehicles shall determine that the~~  
37 ~~course contains all topics from the Department of Motor Vehicles~~  
38 ~~driver education curriculum developed under subdivision (f) of~~  
39 ~~former Section 12814.8 of the Vehicle Code in providing the~~  
40 ~~automobile driver education course. In making this determination,~~

2 ~~methodologies of instruction, and the self-paced nature, and~~  
3 ~~interactive aspects of a home study program.~~

4 ~~(2) A home study-based course shall be submitted to the~~  
5 ~~department in its finalized format for which the school is seeking~~  
6 ~~approval. Course modes of instruction shall include, but are not~~  
7 ~~limited to, paper based, Internet based, CD, DVD, video, audio,~~  
8 ~~telecourse, or any combination. The Department of Motor~~  
9 ~~Vehicles shall approve each course mode of instruction by~~  
10 ~~reviewing the course in its finalized format and the delivery~~  
11 ~~method for each course shall be in full working order in the mode~~  
12 ~~intended for distribution to pupils.~~

13 ~~(3) A private secondary school that submits its home study~~  
14 ~~automobile driver education course for approval under this~~

3 SEC. 2. Section 11101 of the Vehicle Code, as amended by  
4 Section 2 of Chapter 774 of the Statutes of 2002, is amended to  
5 read:

6 11101. (a) This chapter does not apply to any of the  
7 following:

8 (1) Public schools or educational institutions in which driving  
9 instruction is part of the curriculum.

10 (2) Nonprofit public service organizations offering instruction  
11 without a tuition fee.

12 (3) Nonprofit organizations engaged exclusively in giving  
13 off-the-highway instruction in the operation of motorcycles, if the  
14 course of instruction is approved by the National Highway Traffic  
15 Safety Administration and is not designed to prepare students for  
16 examination by the department for a class 4 drivers license.

17 (4) Commercial schools giving only off-the-highway  
18 instruction in the operation of special construction equipment, as  
19 defined in this code.

20 (5) Vehicle dealers or their salesmen giving instruction without  
21 charge to purchasers of motor vehicles.

22 (6) Employers giving instruction to their employees.

23 (7) Commercial schools engaged exclusively in giving  
24 off-the-highway instruction in the operation of racing vehicles or  
25 in advanced driving skills to persons holding valid drivers'  
26 licenses, except whenever that instruction is given to persons who  
27 are being prepared for examination by the department for any class  
28 of driver's license.

29 (b) For purposes of this section, "racing vehicle" means a  
30 motor vehicle of a type that is used exclusively in a contest of speed  
31 and which is not intended for use on the highways.

32 (c) (1) Nothing in this chapter shall be construed to direct or  
33 restrict courses of instruction in driver education offered by  
34 private secondary schools or to require the use of credentialed or  
35 certified instructors in driver education courses offered by private  
36 secondary schools.

37 (2) For the purposes of this section, private secondary schools  
38 are those subject to Sections 33190 and 48222 of the Education  
39 Code.
