SENATE BILL

No. 594

Introduced by Senator Romero

February 22, 2007

An act to amend Sections 14020, 14024, and 14032 of the Penal Code, relating to witnesses, and making an appropriation therefor.

LEGISLATIVE COUNSEL'S DIGEST

SB 594, as amended, Romero. Witness Relocation and Assistance Program.

Existing law establishes the Witness Protection Program, and authorizes the Attorney General to reimburse state and local agencies for the provision of specified services to witnesses.

This bill would rename that program the Witness Relocation and Assistance Program, and would include support, advocacy, and other services for witnesses' safe, long-term ~~transition and well-being~~ *well-being and transition* into a new environment as part of the services to be reimbursed.

Existing law limits the costs of the Attorney General in administering this program to 5%.

This bill would increase that limit to 8%.

Existing law specifies that funding for the program will be appropriated in the annual Budget Act.

This bill would appropriate \$6,000,000 to the Attorney General for administration of the program.

The people of the State of California do enact as follows:

1 SECTION 1. Section 14020 of the Penal Code is amended to
2 read:

3 14020. There is hereby established the Witness Relocation and
4 Assistance Program.

5 SEC. 2. Section 14024 of the Penal Code is amended to read:

6 14024. The Attorney General shall coordinate the efforts of
7 state and local agencies to secure witness protection, relocation,
8 and assistance services and then reimburse those state and local
9 agencies for the costs of the services that he or she determines to
10 be necessary to protect a witness from bodily injury, *assure the*
11 *witness's safe and long-term well-being and transition into a new*
12 *environment*, and otherwise to assure the health, safety, and welfare
13 of the witness. The Attorney General may reimburse the state or
14 local agencies that provide witnesses with any of the following:

15 (a) Armed protection or escort by law enforcement officials or
16 security personnel before, during, or subsequent to, legal
17 proceedings.

18 (b) Physical relocation to an alternate residence.

19 (c) Housing expense.

20 (d) Appropriate documents to establish a new identity.

21 (e) Transportation or storage of personal possessions.

22 (f) Basic living expenses, including, but not limited to, food,
23 transportation, utility costs, and health care.

24 (g) Support, advocacy, and other services to provide for
25 witnesses' safe, ~~long-term transition and well-being~~ *and long-term*
26 *well-being and transition* into a new environment.

27 (h) Other services as needed and approved by the Attorney
28 General.

29 SEC. 3. Section 14032 of the Penal Code is amended to read:

30 14032. The administrative costs of the Attorney General for
31 the purposes of administering this title shall be limited to 8 percent
32 of all costs incurred pursuant to this title.

33 SEC. 4. Notwithstanding Section 14033 of the Penal Code, the
34 sum of six million dollars (\$6,000,000) is hereby appropriated
35 from the General Fund to the Attorney General for the purposes
36 of administering the Witness Relocation and Assistance Program

1 in Title 7.5 (commencing with Section 14020) of Part 4 of the
2 Penal Code.
