SENATE BILL

No. 1643

Introduced by Senator Torlakson

February 22, 2008

An act to add Section 44262.1 to the Education Code, relating to teacher credentialing.

LEGISLATIVE COUNSEL'S DIGEST

SB 1643, as amended, Torlakson. Teacher credentialing: eminence teaching credential.

Existing law authorizes the Commission on Teacher Credentialing, upon the recommendation of the governing board of a school district, to issue an eminence credential to a person who has achieved eminence in a field of endeavor taught or service practiced in the public schools of California. The eminence credential authorizes teaching in the public schools in the subject or subject area or the performance of services in the public schools at the level approved by the commission, as designated on the credential. An eminence credential is issued initially for a 2-year period and may be renewed for a 3-year period by the commission upon the request of the governing board of the school district. Upon completion of the 3-year renewal period, the holder of an eminence credential is eligible upon application for a professional clear teaching credential.

~~This bill would, in addition, authorize a county superintendent of schools, upon the recommendation of the governing board of a school district, would authorize a county board of education, upon the recommendation of a school district, to authorize a county superintendent of schools to issue an eminence credential to a person~~

who has demonstrated subject matter competence through an examination, college degree, or work experience and if the subject or service in which the person demonstrates eminence is one that the governing board wishes to have taught or practiced in the schools of the district. The decision to issue an eminence credential would be required to be based on a recommendation from the governing board of the school district, a statement of employment, and a verification of the eminence qualifications of the individual. The county board of education would be required to provide notice to the public of ~~those~~ *the* individuals ~~for~~ *to* whom it is considering issuing eminence credentials and would be authorized to charge a fee to recover costs incurred in processing eminence credential application. The eminence credential would authorize teaching in the public schools *of the issuing county* in the subject or subject area and at the level approved by the county superintendent of schools and would be issued initially for a 2-year period and renewable for a 3-year period. The holder of an eminence credential would be eligible to apply to the commission for a ~~professional~~ clear *eminence* teaching credential upon completion of the 3-year renewal period.

By increasing the duties of the county board of education, this bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

The people of the State of California do enact as follows:

- 1 SECTION 1. Section 44262.1 is added to the Education Code,
- 2 to read:
- 3 44262.1. (a) Upon the recommendation of ~~the governing board~~
- 4 ~~of~~ *a county board of education* ~~may~~ *authorize* a
- 5 county superintendent of schools ~~may~~ *to* issue an eminence
- 6 credential to a person who has demonstrated subject matter
- 7 competence through an examination, college degree, or work
- 8 experience and if the subject matter in which the person
- 9 demonstrates eminence is one that the governing board wishes to

1 have taught in the schools of the district. This credential shall
2 authorize teaching in the public schools in the subject or subject
3 area and at the level approved by the county superintendent of
4 schools. Each credential ~~so~~ issued shall be issued initially for a
5 two-year period and may be renewed by the county superintendent
6 of schools for a three-year period upon the ~~request of the governing~~
7 ~~board~~ *recommendation* of the school district. Upon completion of
8 the three-year renewal period, the holder of an eminence credential
9 shall be eligible to apply to the commission for a ~~professional clear~~
10 *clear eminence* teaching credential.

11 (b) When considering an application for an eminence credential,
12 the county board of education shall be guided by the following
13 definition of an eminent individual. “Eminent individual” means
14 a person *who is* recognized as eminent beyond the boundaries of
15 his or her community, has demonstrably advanced his or her field,
16 and has been acknowledged by his or her peers beyond the norm
17 for others in the specific endeavor.

18 (c) The requesting school district shall demonstrate how the
19 eminent individual will enrich the educational quality of the school
20 district and not how he or she will fill an employment need.

21 (d) A decision to issue an eminence credential shall be based
22 on a recommendation from the governing board of the school
23 district, a statement of proposed employment, and a verification
24 of the eminence qualifications of the individual as follows:

25 (1) The statement of employment in the district shall include
26 the proposed assignment of the credential applicant and a
27 certification of the intention of the district to employ the applicant
28 if granted an eminence credential.

29 (2) The verification of eminence qualifications of an applicant
30 for an eminence credential shall include:

31 (A) Recommendations from any of the following:

32 (i) Professional associations.

33 (ii) Former employers.

34 (iii) Professional colleagues.

35 (iv) Individuals or groups whose evaluations would support
36 eminence.

37 (B) Documentation of achievement, which may include, but
38 need not be limited to, any of the following:

39 (i) Advanced degrees earned.

40 (ii) Distinguished employment.

- 1 (iii) Evidence of related study or experience.
- 2 (iv) Publications.
- 3 (v) Professional achievement.
- 4 (vi) Recognition attained for contributions to his or her field of
- 5 endeavor.

6 (3) The county board of education shall provide notice to the
 7 public of ~~those individuals for~~ *the individuals to* whom it is
 8 considering issuing eminence credentials. Any association, group,
 9 or individual may provide the county board of education with a
 10 written statement regarding the qualifications of an individual
 11 under consideration for an eminence credential.

12 (4) A county office of education may charge a fee to recover,
 13 and not to exceed, costs incurred in processing eminence credential
 14 applications.

15 (e) A county office of education shall renew an eminence
 16 credential for three years upon receipt of an application for renewal
 17 with a written statement of support from the governing board of
 18 the school district adopted in a public meeting.

19 (f) The commission ~~shall issue a professional~~ *may issue a* clear
 20 eminence teaching credential at the end of five years of possession
 21 of the eminence credential pursuant to this section with a written
 22 statement of support from the governing board of the school district
 23 adopted in a public meeting and submission of an application and
 24 the application fee prescribed in regulations.

25 SEC. 2. No reimbursement is required by this act pursuant to
 26 Section 6 of Article XIII B of the California Constitution because
 27 a local agency or school district has the authority to levy service
 28 charges, fees, or assessments sufficient to pay for the program or
 29 level of service mandated by this act, within the meaning of Section
 30 17556 of the Government Code.
