An act to add Section 89013 to the Education Code, relating to the California State University.

LEGISLATIVE COUNSEL'S DIGEST

AB 24, as amended, Block. California State University: feasibility study: Chula Vista.

Existing law establishes the various segments of the public higher education system in the state. These segments include the University of California, which is administered by the Regents of the University of California, the California State University, which is administered by the Trustees of the California State University, and the California Community Colleges, which is administered by the Board of Governors of the California Community Colleges.

This bill would require the ~~Trustees of the California State University~~ *Chancellor of the California State University, within 18 months of a certification by the trustees that funds are available, to conduct complete and submit to the trustees a study about the feasibility of a California State University satellite program, and ultimately, an independent California State University campus, at Chula Vista.*

State-mandated local program: no.

*The people of the State of California do enact as follows:*

1 SECTION 1. Section 89013 is added to the Education Code,  
2 to read:  
3 89013. (a) ~~The Trustees of the California State University~~  
4 ~~shall by January 1, 2011, Chancellor of the California State~~  
5 *University shall* conduct a study about the feasibility of a California  
6 State University satellite program, and ultimately, an independent  
7 California State University campus, at Chula Vista. The study shall  
8 include all of the following:  
9 (1) Ten-year enrollment projections and physical capacity  
10 analysis.  
11 (2) Regional workforce needs.  
12 (3) Prospective economic impact and job creation in the region.  
13 (4) Infrastructure availability.  
14 (5) The potential alleviation of overcrowding and traffic at the  
15 San Diego State University campus.  
16 (6) Considerations of plausible alternatives.  
17 (7) Academic planning and program justification.  
18 (8) A description of proposed student services and student  
19 outreach programs.  
20 (9) Support and capital outlay budget projections.  
21 (10) Geographic and physical accessibility.  
22 (11) Environmental and social impacts.  
23 (12) Effects on other educational institutions.  
24 (b) Funding for the study required by subdivision (a) shall be  
25 derived solely from private sources.  
26 (c) *The chancellor shall complete and submit the study to the*  
27 *trustees within 18 months after the date that the trustees certify*  
28 *that sufficient funds are available to conduct the study.*
