LEGISLATIVE COUNSEL'S DIGEST

AB 44, as amended, Evans. ~~Budget Act of 2009.~~ *Health.*

~~This bill would express the intent of the Legislature to enact statutory changes relating to the Budget Act of 2009.~~

Existing law provides for the licensure and regulation of health facilities by the State Department of Public Health, including an intermediate care facility/developmentally disabled-nursing. Violation of these provisions is a misdemeanor.

This bill would create as a new category of health facility for, and require the department to license and regulate, intermediate care facility/developmentally disabled-continuous nursing (ICF/DD-CN) facilities, as defined. This bill would require facilities providing continuous skilled nursing services to persons with developmental disabilities pursuant to the above-described provisions to apply for licensure as an ICF/DD-CN within 90 days after licensing regulations become effective. This bill would make other conforming changes. By creating a new crime, this bill would impose a state-mandated local program.

Existing law, until January 1, 2010, authorizes the State Department of Social Services and the State Department of Developmental Services, to jointly establish and administer a pilot project for licensing and regulating Adult Residential Facilities for Persons with Special Health Care Needs (ARFPSHN), to the extent that funds are appropriated for this purpose in the annual Budget Act. Under existing law, a licensed ARFPSHN may provide 24-hour services to up to 5 adults with developmental disabilities who have special health care and intensive support needs.

This bill would extend the pilot project until January 1, 2011, and would make other conforming changes. This bill would impose a state-mandated local program by changing the definition of crimes provided for under the California Community Care Facilities Act.

Existing law authorizes local sponsors, as defined, to offer community dental disease prevention programs to schoolchildren in preschool through 6th grade, and in classes for individuals with exceptional needs. Existing law requires the program to include educational programs focused on the development of personal practices by pupils, as specified, and preventative services. Existing law requires any acts performed or services provided pursuant to the program that constitute the practice of dentistry to be performed or provided by a licensed dentist.

Existing law provides that it is the intent of the Legislature that the above-described program shall be funded according to customary budget procedures.

This bill would, instead, require that the above-described program be funded according to customary budget procedures and that it only be implemented upon appropriation of funds by the Legislature.

Existing law requires the State Department of Public Health to implement and administer a program to meet the requirements of the federal Residential Lead-Based Paint Hazard Reduction Act of 1992.

The department is required to establish fees for the accreditation of training providers, the certification of individuals, and the licensing of entities engaged in lead-related occupations.

This bill would, effective July 1, 2010, require the collected fees to be deposited in the Lead-Related Construction Fund, which would be established by the bill. These moneys would be available to the department upon appropriation by the Legislature for purposes of the program, and would be available for borrowing in accordance with prescribed provisions.

Existing law establishes the Occupational Lead Poisoning Prevention Account, into which fees are paid by employers in prescribed industries that have documented evidence of potential poisoning. Moneys in this account are expended for purposes of the Lead Poisoning Prevention Program, which is conducted by the State Department of Public Health in accordance with prescribed requirements.

This bill would provide that of the funds appropriated from this account in the Budget Act of 2009, \$500,000 would be used for purposes of administration of the residential lead-based paint program during the 2009–10 fiscal year. It would express the intent of the Legislature that funds shall be repaid to the account upon a determination by the Department of Finance that sufficient moneys are available in the Lead-Related Construction Fund.

Existing law, the Calderon-Sher Safe Drinking Water Act of 1996, requires the State Department of Public Health to adopt regulations covering water testing, the monitoring of contaminants, the frequency and method of sampling and testing, the reporting of results, and other matters as may be necessary to determine and ensure the quality of domestic water supplies. Existing law defines “public water system” to mean a system for the provision of water for human consumption through pipes or other constructed conveyances that has 15 or more service connections or regularly serves at least 25 individuals daily at least 60 days out of the year.

Existing law requires public water systems serving 1,000 or more service connections and public water systems that treat water on behalf of one or more water systems, as specified, to reimburse the department for the actual cost incurred by the department in conducting its required activities relating to public water systems, as provided. Existing law further requires public water systems serving less than 1,000 service connections to pay an annual drinking water operating fee to the department for costs incurred by the department in conducting its

required activities relating to public water systems, as provided. Existing law contains limitations on maximum fee amounts that may be imposed on public water systems under these provisions.

This bill would, instead, require these water systems to pay specified fees per service connection, subject to prescribed minimum amounts. This bill would authorize the department to increase the fees, as specified, subject to approval by the Legislature.

Existing law requires the State Department of Health Care Services to establish and administer the Genetically Handicapped Persons Program (GHPP) for the provision of health services to genetically handicapped persons.

This bill would provide that a person who is found eligible for GHPP services whose employer-sponsored health coverage is later terminated or a person who applies for GHPP services whose employer-sponsored health coverage was terminated during the 6-month period prior to the date he or she applies for services shall be ineligible for GHPP services, unless certain exceptions apply. The bill would require an applicant for GHPP services to certify, at the time of application, under penalty of perjury, that he or she was not covered by employer-sponsored health coverage during the 6-month period prior to the date of his or her application or, if he or she was covered by employer-sponsored health coverage, attest to why one of the exceptions to ineligibility applies and provide documentation from the employer-sponsored health coverage that supports his or her attestation. Because the bill would require representations in the statement by the applicant to be made under penalty of perjury, thus changing the definition of a crime, it would impose a state-mandated local program by expanding the crime of perjury.

This bill would also provide that persons who have been found eligible for GHPP services whose employer-sponsored health coverage is thereafter terminated to notify the GHPP within 45 days of the effective date of the termination of their employer-sponsored health coverage and, when applicable, provide the program with the same certification required of applicants for GHPP services.

This bill would authorize the director, on a case-by-case basis, to waive determinations of ineligibility made pursuant to the above-described provisions, or reduce certain time periods as set forth above, if the director determines that the determination of ineligibility or the time periods will result in undue hardship.

This bill would authorize the department to require a client under the GHPP to apply to enroll or otherwise participate in any other state or federal program or other contractual or legal entitlement that would provide services to the client that would otherwise be reimbursed under the GHPP.

This bill would authorize the department, when it determines it to be cost effective, to pay for 3rd-party health coverage for persons eligible for GHPP services in certain circumstances.

Existing law requires the department to determine and establish an enrollment fee for GHPP services that shall be a sliding scale based upon family size and income.

The bill would, with certain exceptions, retroactive to July 1, 2009, instead, base the annual enrollment fee on the client's or, if the client is a minor, the client's parents' or legal guardians' combined adjusted gross income as reported on the relevant state or federal income tax forms for the previous tax year. The bill would require the enrollment fee to be 1½% of adjusted gross income when the reported adjusted gross income was between 200% and 299%, inclusive, of the federal poverty level and to be 3% of adjusted gross income when the reported adjusted gross income was equal to or greater than 300% of the federal poverty level.

The bill would also provide that in the event the annual enrollment fee determined pursuant to the above provisions exceeds the cost of care incurred during the applicable year, the department shall reduce the enrollment fee by refund or credit to an amount equal to the cost of care. The bill would also make conforming changes.

Existing law establishes the California Discount Prescription Drug Program, which is administered by the State Department of Health Care Services. Existing law requires, on August 1, 2010, the department to determine whether pharmaceutical manufacturer participation in the program has been sufficient to meet certain benchmarks. It also requires the department, on and after that date, to reassess program outcomes, at least once every year, consistent with the benchmarks.

This bill would provide that the California Discount Prescription Drug Program become operative on or after July 1, 2010, and would extend the above-described deadlines to August 1, 2013.

Existing law creates the California Major Risk Medical Insurance Program (MRMIP), which is administered by the Managed Risk Medical Insurance Board, to arrange for major risk medical coverage for eligible residents of the state who are unable to secure adequate private health

care coverage. Existing law creates the continuously appropriated Major Risk Medical Insurance Fund within the MRMIP where revenue, including \$18,000,000 from the Hospital Services Account in the Cigarette and Tobacco Products Surtax Fund is deposited annually for the operation of the program.

This bill would, instead, for the 2009–10 fiscal year, prohibit the Controller from depositing any amount into the Major Risk Medical Insurance Fund from the Hospital Services Account in the Cigarette and Tobacco Products Surtax Fund.

Existing law establishes the State Department of Developmental Services and sets forth its duties and responsibilities, including, but not limited to, administration and oversight of the state developmental centers and programs relating to persons with developmental disabilities. Existing law, the Lanterman Developmental Disabilities Services Act, requires the department to allocate funds to private nonprofit regional centers for the provision of community services and support for persons with developmental disabilities and their families.

Existing law provides that the State Department of Mental Health shall house no more than 1,336 patients at Patton State Hospital. However, until September 2009, up to 1,530 patients may be housed at the hospital.

This bill would extend the date that 1,530 patients may be housed at the hospital to September 2012.

Existing law prohibits the total number of developmental center residents in the secure treatment facility at Porterville Developmental Center from exceeding 297.

This bill would include residents receiving services in the center's transition treatment program for purposes of this limit.

Existing law establishes the federal Medicaid program, administered by each state, California's version of which is the Medi-Cal program. The Medi-Cal program, administered by the State Department of Health Care Services, provides basic health care services to qualified low-income persons.

Existing federal and state law contain requirements relating to the establishment of United States citizenship or national status for purposes of establishing Medi-Cal eligibility. Existing Medi-Cal provisions implementing these requirements specify that, except as prescribed, no Medi-Cal services shall be available to any person who fails to comply with these documentation requirements.

This bill would, to the extent that federal financial participation is available and all agreements with the federal government have been obtained, permit the department to exercise a prescribed federal option relating to health care benefits for children.

This bill would require the department, pursuant to, and only to the extent required by, federal law and subject to the provisions described below, to implement an asset verification program for the purpose of determining or redetermining the eligibility of an applicant for, or recipient of, Medi-Cal benefits on the basis of being aged, blind, or disabled.

This bill would require any applicant or recipient described above, and any other person whose resources are required by law to be disclosed to determine the eligibility of the applicant or recipient, to provide authorization for the department to obtain from any financial institution, as defined, any financial record, as defined, held by the institution with respect to the applicant or recipient, and any other person, as applicable, whenever the department determines the record is needed in connection with a determination with respect to eligibility for, or the amount or extent of, medical assistance. The bill would provide that the obtaining of financial records by the department, or its designee, shall be at no cost to the applicant, recipient, or any other person whose resources are required to be disclosed. The bill would authorize the department to determine that an applicant or recipient is ineligible for medical assistance if the applicant or recipient, or any other person, as applicable, refuses to provide, or revokes, any authorization made pursuant to the above-described provisions. The bill would require the department to provide the applicant or recipient with notice of the asset verification requirement prior to the applicant or recipient being required to provide authorization.

This bill would require an officer of a financial institution, as defined, to furnish the department or its designee with information in the possession of the bank or company regarding the assets of any person who is applying for, or is receiving assistance or benefits from, the department and has provided authorization pursuant to the above-described provisions.

Existing law allows the California Medical Assistance Commission to negotiate exclusive contracts with any county that seeks to provide, or arrange for the provision of, Medi-Cal health care services. The system of services provided by or through a county pursuant to these provisions is known as a county-organized health system. Existing law

permits a combination of counties to contract with the department pursuant to these provisions for the provision of services on a regional basis.

This bill would delete the regional basis limitation.

Existing law requires the reimbursement to Medi-Cal pharmacy providers for legend and nonlegend drugs, as defined, to consist of the estimated acquisition cost of the drug, as defined, plus a professional fee for dispensing.

Existing law requires the department to establish a list of maximum allowable ingredient costs (MAIC) for generically equivalent drugs for purposes of establishing the acquisition cost for legend and nonlegend drugs, as provided. Existing law requires the department to update the list of, and establish new, MAICs, and to base the MAIC on the mean of the average manufacturer's price of drugs generically equivalent to the particular innovator drug, plus a percent markup determined by the department to be necessary for the MAIC to represent the average purchase price paid by retail pharmacies in California.

This bill would require the department to establish an MAIC only when 3 or more generically equivalent drugs are available for purchase and dispensing by retail pharmacies in California.

This bill would provide that if average manufacturer's prices are unavailable, the department shall establish the MAIC, either (1) based on the volume weighted average, as defined, of the wholesaler acquisition costs, as defined, of drugs generically equivalent to the particular innovator drug plus a percent markup determined by the department to be necessary for the MAIC to represent the average purchase price paid by retail pharmacies in California or (2) pursuant to a contract with a vendor for the purpose of surveying drug price information, collecting data, and calculating a proposed MAIC.

This bill would require the department to establish a process for providers to seek a change to a specific MAIC when the providers believe the MAIC does not reflect current available market prices.

Under existing law, the State Department of Mental Health is required to implement managed mental health care for Medi-Cal recipients through fee-for-service or capitated contracts with counties, counties acting jointly, qualified individuals or organizations, or nongovernmental entities. The State Department of Mental Health is responsible for assuming specified program oversight authority formerly provided by the State Department of Health Care Services, including, but not limited to, oversight of certain utilization controls.

This bill would, if federal approval is obtained, authorize public agencies that meet certain conditions to, in addition to reimbursement or other payments that the agency would otherwise receive for Medi-Cal specialty mental health services, receive supplemental Medi-Cal reimbursement equal to the amount of federal financial participation received as a result of claims submitted by the State Department of Health Care Services for certain expenditures related to specialty mental health services that are allowable expenditures under federal law.

Existing law authorizes the State Department of Social Services to enter into contracts with manufacturers of single source and multiple source drugs on a bid or nonbid basis and to maintain a list of contract drugs for purposes of the Medi-Cal program. Existing law prescribes conditions under which certain drugs for use in the treatment of acquired immunodeficiency syndrome (AIDS) or an AIDS-related condition or cancer are deemed approved for addition to the Medi-Cal list of contract drugs or considered a Medi-Cal benefit.

Existing law requires, commencing July 1, 2002, all pharmaceutical manufacturers to provide to the department a state rebate, in addition to rebates pursuant to other provisions of state or federal laws, for any drug products that have been added to the Medi-Cal list of contract drugs pursuant to the above-described provisions related to drugs used to treat AIDS and cancer and reimbursed through the Medi-Cal outpatient fee-for-service drug program. Existing law requires the state rebate to be negotiated as necessary between the department and pharmaceutical manufacturers.

This bill would, retroactive to July 1, 2009, and until January 1, 2010, require pharmaceutical manufacturers to provide to the department a state rebate, in addition to rebates pursuant to other provisions of state or federal law, for certain drug products used to treat AIDS and cancer that have been added to the Medi-Cal list of contract drugs, as specified.

Existing federal law requires the United States Secretary of Health and Human Services to enter into an agreement with each manufacturer of covered drugs that are not subject to a rebate under an agreement between the state Medicaid program and the manufacturer under which the amount required to be paid to the manufacturer for covered drugs, with certain exceptions, purchased by a covered entity, as defined, does not exceed an amount equal to the average manufacturer price for the drug under the federal Medicaid program in the preceding calendar quarter, reduced by the rebate received pursuant to the Medicaid agreement.

This bill would provide that a covered entity shall dispense only the above-described drugs to Medi-Cal beneficiaries. This bill provides that if a covered entity is unable to purchase the above-described drugs, the covered entity may dispense a drug purchased at regular drug wholesale rates to a Medi-Cal beneficiary, but that it is required to maintain documentation of their inability to obtain the drugs.

Existing law requires the reimbursement to Medi-Cal pharmacy providers for legend and nonlegend drugs, as defined, to consist of the estimated acquisition cost of the drug, as defined, plus a professional fee for dispensing.

This bill would require pharmacy providers to submit their usual and customary charge, as defined, when billing the Medi-Cal program for prescribed drugs. The bill would require that payment to pharmacy providers be the lower of the pharmacy's usual and customary charge or the above-described reimbursement rate for legend and nonlegend drugs.

Existing law, the Medi-Cal Long-Term Reimbursement Act, requires the department to implement a cost-based reimbursement rate methodology for freestanding skilled nursing facilities, excluding skilled nursing facilities that are a distinct part of a facility that is licensed as a general acute care hospital. Reimbursement rates for these facilities are funded by a combination of federal funds and moneys collected pursuant to the above-described uniform quality assurance fees. Existing law provides that this rate methodology shall cease to be implemented on July 31, 2011, with these provisions to be repealed on January 1, 2012. Existing law provides, for the 2009–10 and 2010–11 rate years, that the maximum annual increase in the weighted average Medi-Cal reimbursement rate required for purposes of the above-described provisions shall not exceed 5% of the weighted average Medi-Cal reimbursement rate for the prior fiscal year.

This bill would, instead, provide that for the 2009–10 and 2010–11 rate years, the weighted average Medi-Cal reimbursement rate required for purposes of the above-described provisions shall not be increased with respect to the weighted average Medi-Cal reimbursement rate for the 2008–09 rate year.

Existing law requires the director to reduce provider payments for certain classes of health facilities for dates of service on and after March 1, 2009, by 5% for Medi-Cal fee-for-service benefits.

This bill would prohibit Medi-Cal reimbursement rates applicable to the classes of providers to which the above-described payment

reduction applies for services rendered during the 2009–10 rate year and each rate year thereafter from exceeding the reimbursement rates that were applicable to those classes of facilities in the 2008–09 rate year, with certain exceptions.

Existing law requires the department to establish a pilot program to provide continuous skilled nursing care as a benefit under the Medi-Cal program when those services are provided pursuant to a federal waiver. This provision is repealed as of January 1, 2010.

This bill would instead, repeal the pilot program if and when the federal Centers for Medicare and Medicaid Services approve a federal waiver or approve a Medicaid State Plan amendment to make the pilot program a permanent program. The bill would set forth provisions for the permanent program that are similar to the provisions of the pilot program and would make these permanent program provisions operative upon the date federal approval is obtained. The bill would make other conforming changes.

Existing law provides for the State Supplementary Program for the Aged, Blind, and Disabled (SSP), which requires the State Department of Social Services to contract with the United States Secretary of Health and Human Services to make payments to SSP recipients to supplement supplemental security income (SSI) payments made available pursuant to the federal Social Security Act.

Under existing law, benefit payments under the SSP program are calculated by establishing the maximum level of nonexempt income and federal (SSI) and state (SSP) benefits for each category of eligible recipient. The state SSP payment is the amount, when added to the nonexempt income and SSI benefits available to the recipient, which would be required to provide the maximum benefit payment.

Existing law authorizes the State Department of Health Care Services, to the extent that federal financial participation is available, to exercise options under federal law to implement a program to provide Medi-Cal benefits for designated aged, blind, and disabled persons who meet specified income standards.

This bill would require the State Department of Health Care Services, to the extent that federal financial participation is available, to exercise an option under federal law to extend full-scope Medi-Cal benefits to individuals who are ineligible to receive those benefits under certain aid programs, including SSI/SSP, as a result of a specified July 1, 2009, reduction in SSI/SSP maximum aid payments. This bill would identify the applicable income and resource standards and methodologies to

be utilized for its purposes, and would require an income disregard to be applied, as specified, to adjust the applicable income standard to that which was in place on May 1, 2009.

This bill would authorize the department to implement these revised Medi-Cal eligibility provisions through all-county letters or similar instructions, and would cease implementation of these provisions when SSI/SSP program payment levels increase beyond those in effect on May 1, 2009. The bill would require the department to seek any approvals from the federal Centers for Medicare and Medicaid Services necessary to implement these provisions.

Existing law provides for the county-administered In-Home Supportive Services (IHSS) program, under which qualified aged, blind, and disabled persons are provided with services in order to permit them to remain in their own homes and avoid institutionalization. Existing law permits services to be provided under the IHSS program either through the employment of individual providers, a contract between the county and an entity for the provision of services, the creation by the county of a public authority, or a contract between the county and a nonprofit consortium. Under existing law, personal care services provided to an individual who is eligible for Medi-Cal benefits as a categorically needy person are a Medi-Cal covered benefit. Personal care services are also a covered benefit under the IHSS program.

Existing law provides for the payment of a supplementary benefit under the IHSS program to any eligible aged, blind, or disabled person who is receiving Medi-Cal personal care services and who would otherwise be deemed a categorically needy recipient under the IHSS program. Existing law extends application of this provision to any aged, blind, or disabled person who is receiving Medi-Cal benefits and eligible for services under a federal waiver program known as the IHSS Plus waiver, and who would otherwise be deemed a categorically needy recipient under the IHSS program.

This bill would require the State Department of Health Care Services to seek approval of the IHSS Plus option, an amendment to the Medicaid state plan to provide self-directed personal assistance services under the state plan, to the extent that federal financial participation is available, in order to provide IHSS services as a Medi-Cal benefit. The bill would require these services to be rendered under the administrative direction of the State Department of Social Services, as specified.

This bill would exclude residents of designated health and care facilities from receiving the services provided pursuant to the bill. It

would authorize the State Department of Health Care Services to implement the IHSS Plus option provisions through all-county letters or similar instructions, and to adopt emergency regulations.

This bill would require the Director of Health Care Services to notify the Legislature of any modifications to IHSS benefits, eligibility, and operational requirements necessary for the state plan amendment to become effective.

Existing law, the Medi-Cal Hospital/Uninsured Care Demonstration Project Act authorizes the director to, pursuant to a federal waiver, use modified funding methodologies to maximize the use of federal funds to resolve Medi-Cal reimbursement inequities experienced by public and private disproportionate share hospitals. The demonstration project provides for specified stabilization funding to be provided for prescribed purposes.

This bill would, notwithstanding those provisions, require that for each of the 2008–09 and 2009–10 fiscal years, the amount available for these purposes shall be reduced by prescribed amounts which sum shall be retained in, or transferred to, the General Fund. This bill would authorize the department to increase federal claiming from the safety net care pool for state-funded programs if necessary to achieve prescribed savings.

It would also, for the 2009–10 fiscal years, make a prescribed reduction from allocations to distressed hospitals, as defined, and would transfer the amount of this transfer to the General Fund.

Under existing law, the State Department of Mental Health is required to implement managed mental health care for Medi-Cal recipients through fee-for-service or capitated contracts with counties, counties acting jointly, qualified individuals or organizations, or nongovernmental entities. The State Department of Mental Health is responsible for assuming specified program oversight authority, including, but not limited to, oversight of certain utilization controls.

This bill would, if federal approval is obtained, authorize public agencies that meet certain conditions to, in addition to reimbursement or other payments that the agency would otherwise receive for Medi-Cal specialty mental health services, receive supplemental Medi-Cal reimbursement equal to the amount of federal financial participation received as a result of claims submitted by the State Department of Health Care Services for certain expenditures related to specialty mental health services that are allowable expenditures under federal law.

Under existing law, one of the benefits provided for under the Medi-Cal program is adult day health care services. Existing law contains eligibility criteria for these services, and requires that adult day health care center provide core services, as defined.

This bill would provide that, commencing 30 days after the effective date of the bill, adult day health care is covered for a maximum of three days per week, until the date that the Director of Health Care Services executes a declaration specifying that provisions described below relating to adult day health care services, are operative, at which time these services are covered for a maximum of 5 days per week.

Under existing law, treatment authorization requests may be granted for adult day health care services for up to 6 months.

Under existing law, one of the eligibility criteria applicable to adult day health care services is that the Medi-Cal beneficiary requires assistance and supervision in performing prescribed activities.

This bill, subject to federal approval, would permit treatment authorization requests for a period of up to 12 months, would modify eligibility criteria to require, with certain exceptions, that the beneficiary need substantial human assistance in performing the prescribed activities, and would modify certain elements of the core services, with all of these provisions to be operative upon the execution of a declaration by the director that all necessary methods and procedures necessary to implement the treatment authorization request provisions have been met.

This bill would require the State Department of Mental Health, by no later than March 1, 2011, to provide the legislative budget and policy committees with an analysis of selected county and subcontractor costs for the 2009–10 fiscal year that are not wholly reimbursed by the schedule of maximum allowances rates, as specified.

This bill would require the California Health and Human Services Agency to develop an action plan regarding coordination of core programmatic functions between the State Department of Mental Health and the State Department of Health Care Services.

Under existing law, for certain hospitals that receive Medi-Cal reimbursement from the State Department of Health Care Services and that are not under contract with the department pursuant to specified existing law, interim payments and cost report settlements for inpatient hospital services provided on and after July 1, 2008, are reduced by 10%, as specified. Existing law revises the amount of these payments, beginning on October 1, 2008, pursuant to a specified formula. Existing

law exempts certain small and rural hospitals and certain open health facility planning areas from this revised formula. Existing law, for purposes of interim payments, specifically provides that open health facility planning areas with 3 or more hospitals with licensed general acute care beds are not exempt from this revised formula. Existing law, for purposes of the cost report settlements, specifically provides that open health facility planning areas with more than 3 hospitals with licensed general acute care beds are not exempt from this revised formula.

This bill would revise both of the above provisions to prohibit a state-owned or state-operated hospital from being included in determining the number of hospitals in an open health facility planning area.

This bill would revise the cost report settlement provision by requiring that an open health facility planning area have 3 or more specified hospitals, instead of more than 3 specified hospitals.

This bill would revise the exemption for small and rural hospitals, as specified.

The bill would require the state Department of Health Care Services to provide the Legislature with a quarterly update regarding the implementation of the federal American Recovery and Reinvestment Act of 2009, as specified. It would also require the department to provide, in a timely manner, the applicable fiscal and policy committees of the Legislature with copies of all federal audits and their findings that pertain to the Medi-Cal program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

The California Constitution authorizes the Governor to declare a fiscal emergency and to call the Legislature into special session for that purpose. The Governor issued a proclamation declaring a fiscal emergency, and calling a special session for this purpose, on December 19, 2008.

This bill would state that it addresses the fiscal emergency declared by the Governor by proclamation issued on December 19, 2008, pursuant to the California Constitution.

36 (5) A congregate living health facility shall have a
37 noninstitutional, homelike environment.

38 (j) (1) “Correctional treatment center” means a health facility
39 operated by the Department of Corrections *and Rehabilitation*, the
40 Department of the Youth Authority *Corrections and Rehabilitation*,

1 *Division of Juvenile Facilities*, or a county, city, or city and county
2 law enforcement agency that, as determined by the state
3 department, provides inpatient health services to that portion of
4 the inmate population who do not require a general acute care level
5 of basic services. This definition shall not apply to those areas of
6 a law enforcement facility that houses inmates or wards that may
7 be receiving outpatient services and are housed separately for

21 facilities with findings of immediate jeopardy, substandard quality
22 of care, or actual harm, as determined by the certification survey
23 of each freestanding skilled nursing facility conducted prior to the
24 implementation of this article.

25 (E) The number of freestanding skilled nursing facilities that
26 received state citations and the number and class of citations issued
27 during calendar year 2004.

28 (F) The average wage and benefits for employees prior to the
29 implementation of this article.

30 (4) Not later than January 1, 2009, the department shall provide
31 a report to the Legislature that does both of the following:

32 (A) Compares the information required in paragraph (2) to that
33 same information two years after the implementation of this article.

34 (B) Reports on the extent to which residents who had expressed
35 a preference to return to the community, as provided in Section
36 1418.81 of the Health and Safety Code, were able to return to the
37 community.

38 (5) The department may contract for the reports required under
39 this subdivision.

1 (d) This section shall become inoperative on July 31, 2011, and
2 as of January 1, 2012, is repealed, unless a later enacted statute,
3 that is enacted before January 1, 2012, deletes or extends the dates
4 on which it becomes inoperative and is repealed.

5 *SEC. 42. Section 14132 of the Welfare and Institutions Code*
6 *is amended to read:*

7 14132. The following is the schedule of benefits under this
8 chapter:

9 (a) Outpatient services are covered as follows:

10 Physician, hospital or clinic outpatient, surgical center,
11 respiratory care, optometric, chiropractic, psychology, podiatric,
12 occupational therapy, physical therapy, speech therapy, audiology,
13 acupuncture to the extent federal matching funds are provided for
14 acupuncture, and services of persons rendering treatment by prayer
15 or healing by spiritual means in the practice of any church or
16 religious denomination insofar as these can be encompassed by
17 federal participation under an approved plan, subject to utilization
18 controls.

19 (b) Inpatient hospital services, including, but not limited to,
20 physician and podiatric services, physical therapy and occupational
21 therapy, are covered subject to utilization controls.

22 (c) Nursing facility services, subacute care services, and services
23 provided by any category of intermediate care facility for the
24 developmentally disabled, including podiatry, physician, nurse
25 practitioner services, and prescribed drugs, as described in
26 subdivision (d), are covered subject to utilization controls.
27 Respiratory care, physical therapy, occupational therapy, speech
28 therapy, and audiology services for patients in nursing facilities
29 and any category of intermediate care facility for the
30 developmentally disabled are covered subject to utilization controls.

31 (d) (1) Purchase of prescribed drugs is covered subject to the
32 Medi-Cal List of Contract Drugs and utilization controls.

33 (2) Purchase of drugs used to treat erectile dysfunction or any
34 off-label uses of those drugs are covered only to the extent that
35 federal financial participation is available.

36 (3) (A) To the extent required by federal law, the purchase of
37 outpatient prescribed drugs, for which the prescription is executed
38 by a prescriber in written, nonelectronic form on or after April 1,
39 2008, is covered only when executed on a tamper resistant
40 prescription form. The implementation of this paragraph shall

1 conform to the guidance issued by the federal Centers of Medicare
2 and Medicaid Services but shall not conflict with state statutes on
3 the characteristics of tamper resistant prescriptions for controlled
4 substances, including Section 11162.1 of the Health and Safety
5 Code. The department shall provide providers and beneficiaries
6 with as much flexibility in implementing these rules as allowed
7 by the federal government. The department shall notify and consult
8 with appropriate stakeholders in implementing, interpreting, or
9 making specific this paragraph.

10 (B) Notwithstanding Chapter 3.5 (commencing with Section
11 11340) of Part 1 of Division 3 of Title 2 of the Government Code,
12 the department may take the actions specified in subparagraph (A)
13 by means of a provider bulletin or notice, policy letter, or other
14 similar instructions without taking regulatory action.

15 (e) Outpatient dialysis services and home hemodialysis services,
16 including physician services, medical supplies, drugs and
17 equipment required for dialysis, are covered, subject to utilization
18 controls.

19 (f) Anesthesiologist services when provided as part of an
20 outpatient medical procedure, nurse anesthetist services when
21 rendered in an inpatient or outpatient setting under conditions set
22 forth by the director, outpatient laboratory services, and X-ray
23 services are covered, subject to utilization controls. Nothing in
24 this subdivision shall be construed to require prior authorization
25 for anesthesiologist services provided as part of an outpatient
26 medical procedure or for portable X-ray services in a nursing
27 facility or any category of intermediate care facility for the
28 developmentally disabled.

29 (g) Blood and blood derivatives are covered.

30 (h) (1) Emergency and essential diagnostic and restorative
31 dental services, except for orthodontic, fixed bridgework, and
32 partial dentures that are not necessary for balance of a complete
33 artificial denture, are covered, subject to utilization controls. The
34 utilization controls shall allow emergency and essential diagnostic
35 and restorative dental services and prostheses that are necessary
36 to prevent a significant disability or to replace previously furnished
37 prostheses which are lost or destroyed due to circumstances beyond
38 the beneficiary's control. Notwithstanding the foregoing, the
39 director may by regulation provide for certain fixed artificial
40 dentures necessary for obtaining employment or for medical

1 conditions that preclude the use of removable dental prostheses,
2 and for orthodontic services in cleft palate deformities administered
3 by the department's California Children Services Program.

4 (2) For persons 21 years of age or older, the services specified
5 in paragraph (1) shall be provided subject to the following
6 conditions:

7 (A) Periodontal treatment is not a benefit.

8 (B) Endodontic therapy is not a benefit except for vital
9 pulpotomy.

10 (C) Laboratory processed crowns are not a benefit.

11 (D) Removable prosthetics shall be a benefit only for patients
12 as a requirement for employment.

13 (E) The director may, by regulation, provide for the provision
14 of fixed artificial dentures that are necessary for medical conditions
15 that preclude the use of removable dental prostheses.

16 (F) Notwithstanding the conditions specified in subparagraphs
17 (A) to (E), inclusive, the department may approve services for
18 persons with special medical disorders subject to utilization review.

19 (3) Paragraph (2) shall become inoperative July 1, 1995.

20 (i) Medical transportation is covered, subject to utilization
21 controls.

22 (j) Home health care services are covered, subject to utilization
23 controls.

24 (k) Prosthetic and orthotic devices and eyeglasses are covered,
25 subject to utilization controls. Utilization controls shall allow
26 replacement of prosthetic and orthotic devices and eyeglasses
27 necessary because of loss or destruction due to circumstances
28 beyond the beneficiary's control. Frame styles for eyeglasses
29 replaced pursuant to this subdivision shall not change more than
30 once every two years, unless the department so directs.

31 Orthopedic and conventional shoes are covered when provided
32 by a prosthetic and orthotic supplier on the prescription of a
33 physician and when at least one of the shoes will be attached to a
34 prosthesis or brace, subject to utilization controls. Modification
35 of stock conventional or orthopedic shoes when medically
36 indicated, is covered subject to utilization controls. When there is
37 a clearly established medical need that cannot be satisfied by the
38 modification of stock conventional or orthopedic shoes,
39 custom-made orthopedic shoes are covered, subject to utilization
40 controls.

1 Therapeutic shoes and inserts are covered when provided to
2 beneficiaries with a diagnosis of diabetes, subject to utilization
3 controls, to the extent that federal financial participation is
4 available.

5 (l) Hearing aids are covered, subject to utilization controls.
6 Utilization controls shall allow replacement of hearing aids
7 necessary because of loss or destruction due to circumstances
8 beyond the beneficiary's control.

9 (m) Durable medical equipment and medical supplies are
10 covered, subject to utilization controls. The utilization controls
11 shall allow the replacement of durable medical equipment and
12 medical supplies when necessary because of loss or destruction
13 due to circumstances beyond the beneficiary's control. The
14 utilization controls shall allow authorization of durable medical
15 equipment needed to assist a disabled beneficiary in caring for a
16 child for whom the disabled beneficiary is a parent, stepparent,
17 foster parent, or legal guardian, subject to the availability of federal
18 financial participation. The department shall adopt emergency
19 regulations to define and establish criteria for assistive durable
20 medical equipment in accordance with the rulemaking provisions
21 of the Administrative Procedure Act (Chapter 3.5 (commencing
22 with Section 11340) of Part 1 of Division 3 of Title 2 of the
23 Government Code).

24 (n) Family planning services are covered, subject to utilization
25 controls.

26 (o) Inpatient intensive rehabilitation hospital services, including
27 respiratory rehabilitation services, in a general acute care hospital
28 are covered, subject to utilization controls, when either of the
29 following criteria are met:

30 (1) A patient with a permanent disability or severe impairment
31 requires an inpatient intensive rehabilitation hospital program as
32 described in Section 14064 to develop function beyond the limited
33 amount that would occur in the normal course of recovery.

34 (2) A patient with a chronic or progressive disease requires an
35 inpatient intensive rehabilitation hospital program as described in
36 Section 14064 to maintain the patient's present functional level as
37 long as possible.

38 (p) (I) Adult day health care is covered in accordance with
39 Chapter 8.7 (commencing with Section 14520).

1 (2) Commencing 30 days after the effective date of the act that
2 added this paragraph, and notwithstanding the number of days
3 previously approved through a treatment authorization request,
4 adult day health care is covered for a maximum of three days per
5 week.

6 (3) As provided in accordance with paragraph (4), adult day
7 health care is covered for a maximum of five days per week.

8 (4) As of the date that the director makes the declaration
9 described in subdivision (g) of Section 14525.1, paragraph (2)
10 shall become inoperative and paragraph (3) shall become
11 operative.

12 (q) (1) Application of fluoride, or other appropriate fluoride
13 treatment as defined by the department, other prophylaxis treatment
14 for children 17 years of age and under, are covered.

15 (2) All dental hygiene services provided by a registered dental
16 hygienist in alternative practice pursuant to Sections 1768 and
17 1770 of the Business and Professions Code may be covered as
18 long as they are within the scope of Denti-Cal benefits and they
19 are necessary services provided by a registered dental hygienist
20 in alternative practice.

21 (r) (1) Paramedic services performed by a city, county, or
22 special district, or pursuant to a contract with a city, county, or
23 special district, and pursuant to a program established under Article
24 3 (commencing with Section 1480) of Chapter 2.5 of Division 2
25 of the Health and Safety Code by a paramedic certified pursuant
26 to that article, and consisting of defibrillation and those services
27 specified in subdivision (3) of Section 1482 of the article.

28 (2) All providers enrolled under this subdivision shall satisfy
29 all applicable statutory and regulatory requirements for becoming
30 a Medi-Cal provider.

31 (3) This subdivision shall be implemented only to the extent
32 funding is available under Section 14106.6.

33 (s) In-home medical care services are covered when medically
34 appropriate and subject to utilization controls, for beneficiaries
35 who would otherwise require care for an extended period of time
36 in an acute care hospital at a cost higher than in-home medical
37 care services. The director shall have the authority under this
38 section to contract with organizations qualified to provide in-home
39 medical care services to those persons. These services may be
40 provided to patients placed in shared or congregate living

1 arrangements, if a home setting is not medically appropriate or
2 available to the beneficiary. As used in this section, “in-home
3 medical care service” includes utility bills directly attributable to
4 continuous, 24-hour operation of life-sustaining medical equipment,
5 to the extent that federal financial participation is available.

6 As used in this subdivision, in-home medical care services,
7 include, but are not limited to:

8 (1) Level of care and cost of care evaluations.

9 (2) Expenses, directly attributable to home care activities, for
10 materials.

11 (3) Physician fees for home visits.

12 (4) Expenses directly attributable to home care activities for
13 shelter and modification to shelter.

14 (5) Expenses directly attributable to additional costs of special
15 diets, including tube feeding.

16 (6) Medically related personal services.

17 (7) Home nursing education.

18 (8) Emergency maintenance repair.

19 (9) Home health agency personnel benefits which permit
20 coverage of care during periods when regular personnel are on
21 vacation or using sick leave.

22 (10) All services needed to maintain antiseptic conditions at
23 stoma or shunt sites on the body.

24 (11) Emergency and nonemergency medical transportation.

25 (12) Medical supplies.

26 (13) Medical equipment, including, but not limited to, scales,
27 gurneys, and equipment racks suitable for paralyzed patients.

28 (14) Utility use directly attributable to the requirements of home
29 care activities which are in addition to normal utility use.

30 (15) Special drugs and medications.

31 (16) Home health agency supervision of visiting staff which is
32 medically necessary, but not included in the home health agency
33 rate.

34 (17) Therapy services.

35 (18) Household appliances and household utensil costs directly
36 attributable to home care activities.

37 (19) Modification of medical equipment for home use.

38 (20) Training and orientation for use of life-support systems,
39 including, but not limited to, support of respiratory functions.

1 (21) Respiratory care practitioner services as defined in Sections
2 3702 and 3703 of the Business and Professions Code, subject to
3 prescription by a physician and surgeon.

4 Beneficiaries receiving in-home medical care services are entitled
5 to the full range of services within the Medi-Cal scope of benefits
6 as defined by this section, subject to medical necessity and
7 applicable utilization control. Services provided pursuant to this
8 subdivision, which are not otherwise included in the Medi-Cal
9 schedule of benefits, shall be available only to the extent that
10 federal financial participation for these services is available in
11 accordance with a home- and community-based services waiver.

12 (t) Home- and community-based services approved by the
13 United States Department of Health and Human Services may be
14 covered to the extent that federal financial participation is available
15 for those services under waivers granted in accordance with Section
16 1396n of Title 42 of the United States Code. The director may
17 seek waivers for any or all home- and community-based services
18 approvable under Section 1396n of Title 42 of the United States
19 Code. Coverage for those services shall be limited by the terms,
20 conditions, and duration of the federal waivers.

21 (u) Comprehensive perinatal services, as provided through an
22 agreement with a health care provider designated in Section
23 14134.5 and meeting the standards developed by the department
24 pursuant to Section 14134.5, subject to utilization controls.

25 The department shall seek any federal waivers necessary to
26 implement the provisions of this subdivision. The provisions for
27 which appropriate federal waivers cannot be obtained shall not be
28 implemented. Provisions for which waivers are obtained or for
29 which waivers are not required shall be implemented
30 notwithstanding any inability to obtain federal waivers for the
31 other provisions. No provision of this subdivision shall be
32 implemented unless matching funds from Subchapter XIX
33 (commencing with Section 1396) of Chapter 7 of Title 42 of the
34 United States Code are available.

35 (v) Early and periodic screening, diagnosis, and treatment for
36 any individual under 21 years of age is covered, consistent with
37 the requirements of Subchapter XIX (commencing with Section
38 1396) of Chapter 7 of Title 42 of the United States Code.

39 (w) Hospice service which is Medicare-certified hospice service
40 is covered, subject to utilization controls. Coverage shall be

1 available only to the extent that no additional net program costs
2 are incurred.

3 (x) When a claim for treatment provided to a beneficiary
4 includes both services which are authorized and reimbursable
5 under this chapter, and services which are not reimbursable under
6 this chapter, that portion of the claim for the treatment and services
7 authorized and reimbursable under this chapter shall be payable.

8 (y) Home- and community-based services approved by the
9 United States Department of Health and Human Services for
10 beneficiaries with a diagnosis of AIDS or ARC, who require
11 intermediate care or a higher level of care.

12 Services provided pursuant to a waiver obtained from the
13 Secretary of the United States Department of Health and Human
14 Services pursuant to this subdivision, and which are not otherwise
15 included in the Medi-Cal schedule of benefits, shall be available
16 only to the extent that federal financial participation for these
17 services is available in accordance with the waiver, and subject to
18 the terms, conditions, and duration of the waiver. These services
19 shall be provided to individual beneficiaries in accordance with
20 the client’s needs as identified in the plan of care, and subject to
21 medical necessity and applicable utilization control.

22 The director may under this section contract with organizations
23 qualified to provide, directly or by subcontract, services provided
24 for in this subdivision to eligible beneficiaries. Contracts or
25 agreements entered into pursuant to this division shall not be
26 subject to the Public Contract Code.

27 (z) Respiratory care when provided in organized health care
28 systems as defined in Section 3701 of the Business and Professions
29 Code, and as an in-home medical service as outlined in subdivision
30 (s).

31 (aa) (1) There is hereby established in the department, a
32 program to provide comprehensive clinical family planning
33 services to any person who has a family income at or below 200
34 percent of the federal poverty level, as revised annually, and who
35 is eligible to receive these services pursuant to the waiver identified
36 in paragraph (2). This program shall be known as the Family
37 Planning, Access, Care, and Treatment (Family PACT) Waiver
38 Program.

39 (2) The department shall seek a waiver for a program to provide
40 comprehensive clinical family planning services as described in

1 paragraph (8). The program shall be operated only in accordance
2 with the waiver and the statutes and regulations in paragraph (4)
3 and subject to the terms, conditions, and duration of the waiver.
4 The services shall be provided under the program only if the waiver
5 is approved by the federal Centers for Medicare and Medicaid
6 Services in accordance with Section 1396n of Title 42 of the United
7 States Code and only to the extent that federal financial
8 participation is available for the services.

9 (3) Solely for the purposes of the waiver and notwithstanding
10 any other provision of law, the collection and use of an individual's
11 social security number shall be necessary only to the extent
12 required by federal law.

13 (4) Sections 14105.3 to 14105.39, inclusive, 14107.11, 24005,
14 and 24013, and any regulations adopted under these statutes shall
15 apply to the program provided for under this subdivision. No other
16 provision of law under the Medi-Cal program or the State-Only
17 Family Planning Program shall apply to the program provided for
18 under this subdivision.

19 (5) Notwithstanding Chapter 3.5 (commencing with Section
20 11340) of Part 1 of Division 3 of Title 2 of the Government Code,
21 the department may implement, without taking regulatory action,
22 the provisions of the waiver after its approval by the federal Health
23 Care Financing Administration and the provisions of this section
24 by means of an all-county letter or similar instruction to providers.
25 Thereafter, the department shall adopt regulations to implement
26 this section and the approved waiver in accordance with the
27 requirements of Chapter 3.5 (commencing with Section 11340) of
28 Part 1 of Division 3 of Title 2 of the Government Code. Beginning
29 six months after the effective date of the act adding this
30 subdivision, the department shall provide a status report to the
31 Legislature on a semiannual basis until regulations have been
32 adopted.

33 (6) In the event that the Department of Finance determines that
34 the program operated under the authority of the waiver described
35 in paragraph (2) is no longer cost effective, this subdivision shall
36 become inoperative on the first day of the first month following
37 the issuance of a 30-day notification of that determination in
38 writing by the Department of Finance to the chairperson in each
39 house that considers appropriations, the chairpersons of the
40 committees, and the appropriate subcommittees in each house that

1 considers the State Budget, and the Chairperson of the Joint
2 Legislative Budget Committee.

3 (7) If this subdivision ceases to be operative, all persons who
4 have received or are eligible to receive comprehensive clinical
5 family planning services pursuant to the waiver described in
6 paragraph (2) shall receive family planning services under the
7 Medi-Cal program pursuant to subdivision (n) if they are otherwise
8 eligible for Medi-Cal with no share of cost, or shall receive
9 comprehensive clinical family planning services under the program
10 established in Division 24 (commencing with Section 24000) either
11 if they are eligible for Medi-Cal with a share of cost or if they are
12 otherwise eligible under Section 24003.

13 (8) For purposes of this subdivision, “comprehensive clinical
14 family planning services” means the process of establishing
15 objectives for the number and spacing of children, and selecting
16 the means by which those objectives may be achieved. These
17 means include a broad range of acceptable and effective methods
18 and services to limit or enhance fertility, including contraceptive
19 methods, federal Food and Drug Administration approved
20 contraceptive drugs, devices, and supplies, natural family planning,
21 abstinence methods, and basic, limited fertility management.
22 Comprehensive clinical family planning services include, but are
23 not limited to, preconception counseling, maternal and fetal health
24 counseling, general reproductive health care, including diagnosis
25 and treatment of infections and conditions, including cancer, that
26 threaten reproductive capability, medical family planning treatment
27 and procedures, including supplies and followup, and
28 informational, counseling, and educational services.
29 Comprehensive clinical family planning services shall not include
30 abortion, pregnancy testing solely for the purposes of referral for
31 abortion or services ancillary to abortions, or pregnancy care that
32 is not incident to the diagnosis of pregnancy. Comprehensive
33 clinical family planning services shall be subject to utilization
34 control and include all of the following:

35 (A) Family planning related services and male and female
36 sterilization. Family planning services for men and women shall
37 include emergency services and services for complications directly
38 related to the contraceptive method, federal Food and Drug
39 Administration approved contraceptive drugs, devices, and

1 supplies, and followup, consultation, and referral services, as
2 indicated, which may require treatment authorization requests.

3 (B) All United States Department of Agriculture, federal Food
4 and Drug Administration approved contraceptive drugs, devices,
5 and supplies that are in keeping with current standards of practice
6 and from which the individual may choose.

7 (C) Culturally and linguistically appropriate health education
8 and counseling services, including informed consent, that include
9 all of the following:

- 10 (i) Psychosocial and medical aspects of contraception.
- 11 (ii) Sexuality.
- 12 (iii) Fertility.
- 13 (iv) Pregnancy.
- 14 (v) Parenthood.
- 15 (vi) Infertility.
- 16 (vii) Reproductive health care.
- 17 (viii) Preconception and nutrition counseling.
- 18 (ix) Prevention and treatment of sexually transmitted infection.
- 19 (x) Use of contraceptive methods, federal Food and Drug
20 Administration approved contraceptive drugs, devices, and
21 supplies.
- 22 (xi) Possible contraceptive consequences and followup.
- 23 (xii) Interpersonal communication and negotiation of
24 relationships to assist individuals and couples in effective
25 contraceptive method use and planning families.

26 (D) A comprehensive health history, updated at the next periodic
27 visit (between 11 and 24 months after initial examination) that
28 includes a complete obstetrical history, gynecological history,
29 contraceptive history, personal medical history, health risk factors,
30 and family health history, including genetic or hereditary
31 conditions.

32 (E) A complete physical examination on initial and subsequent
33 periodic visits.

34 (ab) Purchase of prescribed enteral formulae is covered, subject
35 to the Medi-Cal list of enteral formulae and utilization controls.

36 (ac) Diabetic testing supplies are covered when provided by a
37 pharmacy, subject to utilization controls.

38 *SEC. 43. Section 14132.20 is added to the Welfare and*
39 *Institutions Code, to read:*

1 14132.20. (a) The department shall establish a program to
2 provide continuous skilled nursing care to persons with
3 developmental disabilities as a benefit of the Medi-Cal program,
4 when those services are provided in accordance with an approved
5 federal waiver or Medi-Cal State Plan amendment meeting the
6 requirements of subdivision (b). “Continuous skilled nursing care”
7 means medically necessary care provided by, or under the
8 supervision of, a registered nurse within his or her scope of
9 practice, seven days a week, 24 hours per day, in a facility
10 participating in the program. Continuous skilled nursing care
11 shall include a minimum of eight hours per day provided by or
12 under the direct supervision of a registered nurse. Each facility
13 providing continuous skilled nursing care in the program shall
14 have a minimum of one registered nurse or one licensed vocational
15 nurse awake and in the facility at all times when a consumer is
16 present.

17 (b) The department shall submit to the federal Centers for
18 Medicare and Medicaid Services, a request, developed in
19 consultation with the State Department of Public Health, the State
20 Department of Developmental Services, and the Association of
21 Regional Center Agencies, to provide continuous skilled nursing
22 care services under a federal waiver pursuant to Section 1915(c)
23 of the federal Social Security Act (42 U.S.C. Sec. 1396n(c)) or
24 pursuant to a Medi-Cal State Plan amendment.

25 (c) (1) The program shall provide continuous skilled nursing
26 care to persons with developmental disabilities in the least
27 restrictive home-like setting.

28 (2) Participation in the program shall be restricted to facilities
29 that meet all eligibility requirements. The facilities shall be
30 approved by the department, in consultation with the State
31 Department of Public Health, the State Department of
32 Developmental Services, and the appropriate regional center
33 agencies, and shall meet the requirements of subdivision (f).

34 (d) Under the program established by this section, a person
35 with developmental disabilities shall be eligible to receive
36 continuous skilled nursing care if all of the following conditions
37 are met:

38 (1) The person with developmental disabilities meets the criteria
39 specified in the federal waiver or the Medi-Cal State Plan
40 amendment.

1 (2) *The person with developmental disabilities resides in a*
2 *facility that meets the provider participation criteria as specified*
3 *in the federal waiver or the Medi-Cal State Plan amendment.*

4 (3) *The continuous skilled nursing care services are provided*
5 *in accordance with the federal waiver or the Medi-Cal State Plan*
6 *amendment.*

7 (e) *The services provided to persons with developmental*
8 *disabilities under the program, pursuant to Section 1915(c) of the*
9 *federal Social Security Act (42 U.S.C. Sec. 1396n(c)), shall not*
