ASSEMBLY BILL

No. 495

Introduced by Assembly Member Davis

February 24, 2009

An act to add Article 14 (commencing with Section 32436) to Chapter 3 of Part 19 of Division 1 of Title 1 of the Education Code, relating to preschool.

LEGISLATIVE COUNSEL'S DIGEST

AB 495, as amended, Davis. Preschool: data collection.

Existing law provides for the licensure of child day care centers, including centers that provide preschool services. Existing law states the intent of the Legislature that all families have access to child care and development services, through resource and referral services, where appropriate, regardless of ethnic status, cultural background, or special needs.

This bill would require the State Department of Education, *in consultation with the State Department of Social Services and the Legislative Analyst's Office*, to annually determine the number of ~~three-~~ 3- and ~~four-year-old~~ 4-year-old children in the state and in each county, the number of licensed providers offering preschool services, and the number of children that each licensed provider could accommodate with respect to preschool services. The bill would require the department to post this data on the most appropriate of its Internet Web sites, and to update *this data* on the Internet Web site ~~as soon as practicable after obtaining new data annually~~.

The people of the State of California do enact as follows:

1 SECTION 1. The Legislature finds and declares all of the
2 following:

3 (a) A child’s participation in a quality preschool educational
4 program plays a critical role in his or her educational development
5 and success in school. Studies have shown that children who
6 participate in quality preschool programs are more likely to become
7 proficient readers by the third grade, graduate from high school,
8 and attend college than their peers who do not attend quality
9 preschool educational programs.

10 (b) Scientific knowledge about ~~how children’s brains develop~~
11 *child brain development* confirms the importance of participation
12 in quality preschool educational programs. Ninety percent of brain
13 growth occurs before age five, before most children enroll in
14 kindergarten.

15 (c) Quality preschool education provides a crucial opportunity
16 to engage parents in the education of their children, and to create
17 a habit of parental involvement that will last throughout a child’s
18 academic career.

19 (d) Studies have shown that early education and intervention
20 for children with special needs in preschool reduce the need for
21 costly special education services in later years.

22 (e) Quality preschool education helps English learners develop
23 their English language skills and meet school readiness goals.

24 (f) There is a severe shortage of quality, affordable preschool
25 education providers in California, and California lags behind the
26 nation in preschool enrollment.

27 SEC. 2. Article 14 (commencing with Section 32436) is added
28 to Chapter 3 of Part 19 of Division 1 of Title 1 of the Education

33 32436. (a) The department, *in consultation with the State*
34 *Department of Social Services and the Legislative Analyst’s Office,*
