An act to add Section 44257.3 to the Education Code, relating to linked learning.

LEGISLATIVE COUNSEL'S DIGEST

AB 1223, as amended, Block. Linked learning.

Existing law authorizes the Commission on Teacher Credentialing to issue various types of teaching credentials and authorizations. Existing law establishes multiple pathway programs, which are multi-year comprehensive high school programs of integrated academic and technical study that are organized around a broad theme, interest area, or industry sector. Multiple pathway programs are comprised, among other things, of an integrated core curriculum that meets the eligibility requirements for admission to the University of California and the California State University and is delivered through project-based learning and other engaging instructional strategies that intentionally bring real-world context and relevance to the curriculum where broad themes, interest areas, and career technical education are emphasized.

This bill would define “linked learning programs,” and would authorize the commission to convene a workgroup consisting of specified members to develop program standards for the issuance of a recognition of study *in linked learning*, as defined, for linked learning competence for holders of a single subject teaching credential who will be teaching pupils enrolled in linked learning programs, as specified. The bill would authorize the commission to work with the Superintendent of Public Instruction to gather and post, on an appropriate Internet Web site, best practices from school districts and schools on curriculum development and professional development relating to implementing and sustaining multiple pathway programs.

16 (1) "Recognition of study in linked learning" is a statement
17 added to a single subject teaching credential recognizing that the
18 credential holder has completed a commission-approved program
19 in linked learning teaching methods that can be applied to the
20 academic instruction authorized by their credential. A recognition
21 of study in linked learning teacher preparation program may be
22 offered as part of an initial teacher preparation program or as a
23 separate program for previously credentialed teachers.

24 (2) "Linked learning programs" are programs and pathways
25 described in Section 52372.5 and may include, but are not limited
26 to, California partnership academies.

27 (b) The commission may convene a workgroup to develop
28 program standards for the issuance of a recognition of study for
29 linked learning competence for holders of a single subject teaching
30 credential who will be teaching pupils enrolled in linked learning
31 programs pursuant to Section 52372.5.

32 (c) Members of the workgroup shall include, but are not limited
33 to, representatives from:

36 one representative from the California State University, the
37 University of California, and independent institutions of higher
38 education. To the extent practicable, representatives should have
39 an academic interest or prior experience in preparing teachers to

13 *convened pursuant to subdivision (b). Within the context of the*
14 *academic content standards in kindergarten and any of grades 1*
15 *to 12, inclusive, this knowledge may include, but is not limited to,*
16 *an understanding of the following:*

17 (1) *How to develop and maintain industry and postsecondary*
18 *educational partnerships.*

19 (2) *Ongoing professional learning.*

20 (3) *Work-based learning strategies.*

21 (4) *Career exposure and development.*

22 (5) *Interdisciplinary collaboration and project-based teaching*
23 *methods.*

24 (6) *California Career Technical Education Model Curriculum*
25 *Standards adopted by the State Board of Education.*

26 (e) *With respect to any recognition of study for linked learning*
