An act to amend Section 84203.5 of the Government Code, relating to the Political Reform Act of 1974.

LEGISLATIVE COUNSEL'S DIGEST

AB 1257, as introduced, Hagman. Political Reform Act of 1974: independent expenditure reports.

Existing law, the Political Reform Act of 1974, requires a candidate or committee who has made independent expenditures totaling \$1,000 or more in a calendar year, as specified, to file an independent expenditure report containing certain information about person to whom an expenditure of \$100 or more was made during the period covered by the report and about a person who provided consideration for such an expenditure during that period.

This bill would increase the expenditure threshold amount for reporting this information from \$100 to \$400 and would require the Commission to adjust this amount periodically, as specified, in accordance with any increase in the California Consumer Price Index.

The Political Reform Act of 1974, an initiative measure, provides that the Legislature may amend the act to further the act's purposes upon a $\frac{2}{3}$ vote of each house and compliance with specified procedural requirements.

This bill would declare that it furthers the purposes of the act.

Vote: $\frac{2}{3}$. Appropriation: no. Fiscal committee: yes.

The people of the State of California do enact as follows:

1 SECTION 1. Section 84203.5 of the Government Code is
2 amended to read:

3 84203.5. (a) In addition to any campaign statements required
4 by this article, if a candidate or committee has made independent
5 expenditures totaling one thousand dollars (\$1,000) or more in a
6 calendar year to support or oppose a candidate, a measure, or
7 qualification of a measure, it shall file independent expenditure
8 reports at the same time, covering the same periods, and in the
9 places where the candidate or committee would be required to file
10 campaign statements under this article, as if it were formed or
11 existing primarily to support or oppose the candidate or measure
12 or qualification of the measure. No independent expenditure report
13 need be filed to cover a period for which there has been no activity
14 to report.

15 (b) An independent expenditure report shall contain the
16 following information:

17 (1) The name, street address, and telephone number of the
18 candidate or committee making the expenditure and of the
19 committee's treasurer, and the number assigned to the committee
20 by the Secretary of State.

21 (2) If the report is related to a candidate, the full name of the
22 candidate and the office and district for which the candidate seeks
23 nomination or election. If the report is related to a measure or
24 qualification of a measure, the number or letter of the measure, or
25 if none has yet been assigned, a brief description of the subject
26 matter of the measure, and the jurisdiction in which the measure
27 is to be voted on or would be voted on if it qualified.

28 (3) The total amount of expenditures related to the candidate or
29 measure during the period covered by the report made to persons
30 who have received less than one hundred dollars (\$100).

31 (4) The total amount of expenditures related to the candidate or
32 measure during the period covered by the report made to persons
33 who have received one hundred dollars (\$100) or more.

34 (5) (A) For each person to whom an expenditure of ~~one~~ *four*
35 hundred dollars ~~(\$100)~~ *(\$400)* or more related to the candidate or
36 measure has been made during the period covered by the report
37 and for each person who has provided consideration for an

4 (i) His or her full name.

6 (ii) His or her street address.

9 the number assigned to the committee by the Secretary of State,
10 or if no number has been assigned, the full name and street address
11 of the treasurer of the committee.

15 (v) The amount of the expenditure.

17 (vi) A brief description of the consideration for which each
18 expenditure was made and the value of the consideration if less
19 than the total amount of the expenditure.

21 (vii) The cumulative amount of expenditures to such person.

22 (B) *On or before January 1 of each odd-numbered year, the*
23 *Commission shall increase the expenditure threshold for reporting*
24 *the information required by this paragraph in an amount equal to*
25 *any increase in the California Consumer Price Index, as*
26 *determined by the Department of Industrial Relations.*

27 (6) A list of all the filing officers with whom the committee
28 filed its most recent campaign statement.

29 (c) Filing officers shall maintain paper reports filed pursuant to
30 this section under the name of the candidate or measure supported
31 or opposed by the independent expenditure.

32 SEC. 2. The Legislature finds and declares that this bill furthers
33 the purposes of the Political Reform Act of 1974 within the
34 meaning of subdivision (a) of Section 81012 of the Government
35 Code.
