An act to add Chapter 7.5 (commencing with Section 6750) to Division 7 of Title 1 of the Government Code, relating to the Ronald Reagan Centennial Commission, and declaring the urgency thereof, to take effect immediately.

LEGISLATIVE COUNSEL'S DIGEST

AB 1911, as amended, Garrick. Ronald Reagan Centennial Commission.

Existing law provides for the establishment of various commissions within state government.

This bill would, *until January 1, 2012*, establish the Ronald Reagan Centennial Commission in state government to celebrate the 100th anniversary of Ronald Reagan's birth. The bill would require the commission to recommend appropriate means to allow Californians to celebrate Ronald Reagan's life by honoring, promoting, and remembering his achievements for this state and country. The bill would

prohibit the commission from using public funds and would require the commission to be solely supported by private funds.

This bill would declare that it is to take effect immediately as an urgency statute.

The people of the State of California do enact as follows:

1 SECTION 1. Chapter 7.5 (commencing with Section 6750) is
2 added to Division 7 of Title 1 of the Government Code, to read:

4 CHAPTER 7.5. RONALD REAGAN CENTENNIAL COMMISSION

6 6750. (a) The Ronald Reagan Centennial Commission is
7 hereby established in state government to celebrate the 100th
8 anniversary of the birth of Ronald Reagan, the 40th President of
9 the United States and 33rd Governor of California. The commission
10 shall be composed of nine members as follows:

11 (1) Four members shall be the President pro Tempore of the
12 Senate, the Minority Leader of the Senate, the Speaker of the
13 Assembly, and the Minority Leader of the Assembly, or his or her
14 respective designee.

15 (2) One member shall be appointed by the Governor.

16 (3) Four members shall be appointed by the Ronald Reagan
17 Presidential Foundation. Of the four members, one member shall
18 be an individual that served in Ronald Reagan’s presidential
19 administration, one member shall be an individual that served in
20 Ronald Reagan’s gubernatorial administration, and one member
21 shall be a former Governor of the state.

22 (b) The commission shall recommend appropriate means to
23 allow Californians to celebrate the life of Ronald Reagan by
24 honoring, promoting, and remembering his achievements for this
25 state and country.

26 (c) The commission shall not use public funds and shall be
27 solely supported by private funds.

28 6751. *This chapter shall remain in effect only until January 1,*
29 *2012, and as of that date is repealed, unless a later enacted statute,*
30 *that is enacted before January 1, 2012, deletes or extends that*
31 *date.*

1 SEC. 2. This act is an urgency statute necessary for the
2 immediate preservation of the public peace, health, or safety within
3 the meaning of Article IV of the Constitution and shall go into
4 immediate effect. The facts constituting the necessity are:

5 In order for the Ronald Reagan Centennial Commission to
6 recommend appropriate means to allow Californians to celebrate
7 Ronald Reagan's life in time for the 100th anniversary of Ronald
8 Reagan's birth it is necessary that this act take effect immediately.
