An act to add Section 11349.95 to the Government Code, relating to regulations.

LEGISLATIVE COUNSEL'S DIGEST

AB 1949, as amended, Logue. Regulations: ~~five-year~~ *5-year* review and report.

The Administrative Procedure Act generally sets forth the requirements for the adoption, publication, review, and implementation of regulations by state agencies.

This bill would additionally require ~~the California Environmental Protection Agency, the Division of Occupational Safety and Health in the Department of Industrial Relations, and the State Air Resources Board~~ *a state agency* to review and report on regulations that it adopts or amends on and after January 1, 2011, ~~five~~ *5* years after adoption, as specified. The bill would require that the review and report include 10 specified factors, including a summary of the written criticisms of the regulation received by the agency within the immediately preceding ~~five~~ *5* years and the estimated economic, small business, and consumer impact of the regulation. The bill would require the Office of Administrative Law to make the review and report available on the office's Internet Web site.

The people of the State of California do enact as follows:

17 *(b) The review and report required by this section shall include*
18 *all of the following factors:*
19 *(1) The general and specific statutes authorizing the regulation.*
20 *(2) The objective of the regulation.*
21 *(3) The effectiveness of the regulation in achieving the objective.*
22 *(4) The consistency of the regulation with state and federal*
23 *statutes and regulations and a listing of the statutes or regulations*
24 *used in determining the consistency.*
25 *(5) The agency enforcement policy, including whether the*
26 *regulation is currently being enforced and, if so, whether there are*
27 *any problems with enforcement.*
28 *(6) The agency view regarding current wisdom of the regulation.*
29 *(7) The clarity, conciseness, and understandability of the*
30 *regulation.*
31 *(8) A summary of the written criticisms of the regulation*
32 *received by the agency within the five years immediately preceding*
33 *the five-year review report, including letters, memoranda, reports,*
34 *and written allegations made in litigation or administrative*
35 *proceedings, to which the agency was a party, that the regulation*

1 is discriminatory, unfair, unclear, inconsistent with statute, or
2 beyond the authority of the agency to enact, and the result of the
3 litigation or administrative proceedings.

4 (9) The estimated economic, small business, and consumer
5 impact of the regulation as compared to the economic, small
6 business, and consumer impact statement prepared on the last
7 making of the regulation, or, if no economic, small business, and
8 consumer impact statement was prepared on the last making of
9 the rule, an assessment of the actual economic, small business,
10 and consumer impact of the regulation.

11 (10) Course of action the agency proposes to take regarding
12 each regulation, including the month and year in which the agency
13 anticipates submitting the rules to the office if the agency
14 determines it is necessary to amend or repeal an existing rule, or
15 to make a new rule.
