LEGISLATIVE COUNSEL'S DIGEST

SB 75, as amended, Committee on Budget and Fiscal Review. ~~Budget Act of 2009.~~ *Judiciary.*

(1) The Public Employees' Retirement System provides pension benefits based in part upon credited service. The Public Employees' Retirement Law provides that credit for service generally is accrued based upon service rendered and compensated in a fiscal year, and that time during which a member is absent without compensation is not allowed for computing service. Existing law, in effect until July 1, 2010, authorizes the Judicial Council to provide that the courts be closed for the transaction of judicial business for one day per month, which would be treated as a holiday, and to adopt court rules to implement these provisions, subject to specified conditions.

This bill would require that, for all retirement purposes, credit for service and compensation earnable for members of the Public Employees' Retirement System employed by a trial court that are subject to mandatory furloughs be based on the amount that would have been credited had the employee not been subject to mandatory furloughs. The bill would define mandatory furloughs and trial court employee in these regards.

(2) Existing law sets the fees for filing first papers and other filing fees in civil actions, including various probate proceedings.

This bill would make technical, conforming changes in related provisions specifying the distribution of the proceeds of those fees.

(3) Existing law authorizes a court to use electronic recording equipment for the internal personnel purpose of monitoring judicial officer performance, if notice is provided to litigants that the proceeding may be recorded for that purpose, as specified.

This bill would modify that provision to authorize a court to use electronic recording equipment for the internal personnel purpose of monitoring the performance of subordinate judicial officers, hearing officers, and temporary judges while proceedings are conducted in the courtroom, if notice is provided to the subordinate judicial officer, hearing officer, or temporary judge, and to the litigants, that the proceeding may be recorded for that purpose, as specified.

(4) Existing law permits the referral of fines, state or local penalties, forfeitures, restitution fines, or restitution orders imposed by specified courts upon a person for criminal offenses under certain conditions to the Franchise Tax Board for collection. Existing law requires a board of supervisors to provide that disbursements of amounts collected by the Franchise Tax Board be made in accordance with specified priorities of payment. Existing law provides, until January 1, 2012, that any statute that takes effect after January 1, 2009, that increases the amount of any item that would be subject to disbursement under these provisions shall not be disbursed until all specified reimbursable costs have been disbursed.

Existing law imposes a fee of \$30, until July 1, 2011, and thereafter, a fee of \$20, upon every conviction for a criminal offense, other than parking offenses, for funding of court security.

This bill would provide that the court security fees collected pursuant to the latter provision shall be disbursed in accordance with the specified priorities of payment described above, and not first be subject to disbursement for those specified reimbursable costs.

The people of the State of California do enact as follows:

1 SECTION 1. Section 20969.1 is added to the Government Code,
2 to read:

3 20969.1. (a) For all retirement purposes, including benefit
4 eligibility and calculations of retirement allowances for members
5 employed by a trial court that are subject to mandatory furloughs,
6 as defined in subdivision (c), credit for service and compensation
7 earnable shall be based on the amount of service that would have
8 been credited had the employee not been subject to mandatory
9 furloughs.

10 (b) A trial court shall notify the board of the terms and
11 conditions of any mandatory furlough, including, but not limited
12 to, the amount of mandatory furlough time imposed on employees
13 during a reporting period, and the date on which the mandatory
14 furlough ends. A trial court and a county in which the trial court
15 is located that participates in this system by joint contract pursuant
16 to Section 20460.1 shall provide that additional information as
17 the board may require to implement this section.

18 (c) For the purposes of this section, “mandatory furloughs” is
19 limited to the time during which a trial court employee is directed
20 to be absent from work without pay in the 2009–10 fiscal year on
21 the day designated by the Judicial Council for closure of the courts
22 as authorized in Section 68106.

23 (d) For purposes of this section, “trial court employee” means
24 a trial court employee, as that term is defined in Section 71601,
25 whose employer has contracted for its employees to become
26 members of the California Public Employees’ Retirement System.

27 SEC. 2. Section 68085.3 of the Government Code is amended
28 to read:

29 68085.3. (a) Fees collected under Sections 70611, 70612,
30 70650, 70651, 70652, 70653, 70655, 70658, and 70670 shall be
31 deposited in a bank account established by the Administrative
32 Office of the Courts for deposit of fees collected by the courts.

8 69957. (a) ~~Whenever~~ *If* an official reporter or an official
9 reporter pro tempore is unavailable to report an action or
10 proceeding in a court, subject to the availability of approved
11 equipment and equipment monitors, the court may order that, in
12 a limited civil case, or a misdemeanor or infraction case, the action
13 or proceeding be electronically recorded, including all the
14 testimony, the objections made, the ruling of the court, the
15 exceptions taken, all arraignments, pleas, and sentences of
16 defendants in criminal cases, the arguments of the attorneys to the
17 jury, and all statements and remarks made and oral instructions
18 given by the judge. A transcript derived from an electronic
19 recording may be utilized whenever a transcript of court
20 proceedings is required. The electronic recording device and
21 appurtenant equipment shall be of a type approved by the Judicial
22 Council for courtroom use and shall only be purchased for use as
23 provided by this section. A court shall not expend funds for or use
24 electronic recording technology or equipment to make an unofficial
25 record of an action or proceeding, including for purposes of judicial
26 notetaking, or to make the official record of an action or proceeding
27 in circumstances not authorized by this section.

28 (b) Notwithstanding subdivision (a), a court may use electronic
29 recording equipment for the internal personnel purpose of
30 ~~monitoring judicial officer performance~~ *the performance of*
31 *subordinate judicial officers, as defined in Section 71601 of the*
32 *Government Code, hearing officers, and temporary judges while*
33 *proceedings are conducted in the courtroom, if notice is provided*
34 *to the subordinate judicial officer, hearing officer, or temporary*
35 *judge, and to the litigants, that the proceeding may be recorded*
36 *for that purpose. An electronic recording made for the purpose of*
37 *monitoring judicial officer that performance shall not be used for*
38 *any other purpose and shall not be made publicly available. Any*
39 *recording made pursuant to this subdivision shall be destroyed two*
40 *years after the date of the proceeding unless a personnel matter is*

1 pending relating to performance of the *subordinate* judicial officer,
2 *hearing officer, or temporary judge.*

3 (c) Prior to purchasing or leasing any electronic recording
4 technology or equipment, a court shall obtain advance approval
5 from the Judicial Council, which may grant that approval only if
6 the use of the technology or equipment will be consistent with this
7 section.

8 *SEC. 5. Section 1465.8 of the Penal Code, as amended by*
9 *Section 29 of Chapter 22 of the Fourth Extraordinary Session of*
10 *the Statutes of 2009, is amended to read:*

11 1465.8. (a) (1) To ensure and maintain adequate funding for
12 court security, a fee of thirty dollars (\$30) shall be imposed on
13 every conviction for a criminal offense, including a traffic offense,
14 except parking offenses as defined in subdivision (i) of Section
15 1463, involving a violation of a section of the Vehicle Code or
16 any local ordinance adopted pursuant to the Vehicle Code.

17 (2) For the purposes of this section, “conviction” includes the
18 dismissal of a traffic violation on the condition that the defendant
19 attend a court-ordered traffic violator school, as authorized by
20 Sections 41501 and 42005 of the Vehicle Code. This security fee
21 shall be deposited in accordance with subdivision (d), and may
22 not be included with the fee calculated and distributed pursuant to
23 Section 42007 of the Vehicle Code.

24 (b) This fee shall be in addition to the state penalty assessed
25 pursuant to Section 1464 and may not be included in the base fine
26 to calculate the state penalty assessment as specified in subdivision
27 (a) of Section 1464. The penalties authorized by Chapter 12
28 (commencing with Section 76000) of Title 8 of the Government
29 Code, and the state surcharge authorized by Section 1465.7, do
30 not apply to this fee.

31 (c) When bail is deposited for an offense to which this section
32 applies, and for which a court appearance is not necessary, the
33 person making the deposit shall also deposit a sufficient amount
34 to include the fee prescribed by this section.

36 collected pursuant to subdivision (a) shall all be deposited in a
37 special account in the county treasury and transmitted therefrom
