SENATE BILL

No. 1475

Introduced by Senator Simitian

February 19, 2010

An act to amend Sections 12804.9, 12810.3, 23123, 23123.5, and 23124 of, and to add Section 23124.5 to, the Vehicle Code, relating to vehicles.

LEGISLATIVE COUNSEL'S DIGEST

SB 1475, as amended, Simitian. Vehicles: electronic wireless communications devices: prohibitions.

(1) Existing law requires the Department of Motor Vehicles to examine applicants for specific driver's licenses and requires that the examination include, among other things, a test of the applicant's knowledge and understanding of the provisions of the Vehicle Code governing the operation of vehicles upon the highways.

This bill would require the department to include a test of the applicant's understanding of the distractions and dangers of handheld cell phone use and text messaging while operating a motor vehicle.

(2) Existing law establishes that specified convictions and violations under the Vehicle Code and traffic-related incidents count as points against a driver's record for purposes of the suspension or revocation of the privilege to drive.

Under existing law, it is an infraction for any person to drive a motor vehicle while using a wireless telephone, unless that telephone is designed and configured to allow hands-free listening and talking

operation, and is used in that manner while driving, except as otherwise provided. A person under 18 years of age is prohibited from driving a motor vehicle while using a wireless telephone, even if equipped with a hands-free device, or while using a mobile service device.

Under existing law, a person is also prohibited from driving a motor vehicle while using an electronic wireless communications device to write, send, or read a text-based communication, except as specified.

A violation of these provisions is an infraction and a violation point is not given for a violation of these provisions.

This bill would delete the exemption from the violation point count that would be given for a conviction of the 3 provisions specified above, except for a violation committed by a person riding a bicycle. The bill would increase the base fines for a conviction under each of the first 2 provisions from \$20 to \$50 and the fine for a 2nd or subsequent offense from \$50 to \$100 and would also apply these prohibitions to a person riding a bicycle. The bill would also increase the base fine for driving while using an electronic wireless communications device to write, send, or read a text-based communication from \$20 to \$50 for a first offense and from \$50 to \$100 for each subsequent offense and would apply this prohibition to a person riding a bicycle. The bill would also impose a total fine amount of \$20 for a first offense and \$50 for each subsequent offense for a violation of the above prohibitions when the offense is committed while riding a bicycle. By expanding the scope of existing crimes, the bill would impose a state-mandated local program.

(3) Existing law prohibits a law enforcement officer from stopping a vehicle for the sole purpose of determining whether the driver is violating the prohibition of driving a motor vehicle while using a wireless telephone.

This bill would delete that prohibition.

(4) Existing law requires that the base fines collected from violations of the Vehicle Code for crimes other than parking offenses are subject to distribution to specified funds of a state or local agency as set forth by statute or to the proper funds of a city or county, as applicable.

This bill would require the ~~Controller~~ county treasurer to ~~deposit~~ submit \$10 from each fine collected under (2) above to the Controller, for deposit into a special account in the State Treasury for an education program on the dangers of cell phone use and text messaging while driving, thereby imposing a state-mandated local program by imposing

a new duty on local officials. The bill would require the Legislature, upon appropriation in the Budget Bill, to allocate this money to the Office of Traffic Safety in the Business, Transportation and Housing Agency for this purpose.

~~(4) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.~~

~~This bill would provide that no reimbursement is required by this act for a specified reason.~~

(5) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that with regard to certain mandates no reimbursement is required by this act for a specified reason.

With regard to any other mandates, this bill would provide that, if the Commission on State Mandates determines that the bill contains costs so mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

1 SECTION 1. Section 12804.9 of the Vehicle Code is amended
2 to read:

3 12804.9. (a) (1) The examination shall include all of the
4 following:

5 (A) A test of the applicant’s knowledge and understanding of
6 the provisions of this code governing the operation of vehicles
7 upon the highways.

8 (B) A test of the applicant’s ability to read and understand
9 simple English used in highway traffic and directional signs.

10 (C) A test of the applicant’s understanding of traffic signs and
11 signals, including the bikeway signs, markers, and traffic control
12 devices established by the Department of Transportation.

13 (D) A test of the applicant’s understanding of the distractions
14 and dangers of handheld cell phone use and text messaging while
15 operating a motor vehicle.

1 (E) An actual demonstration of the applicant's ability to exercise
2 ordinary and reasonable control in operating a motor vehicle by
3 driving it under the supervision of an examining officer. The
4 applicant shall submit to an examination appropriate to the type
5 of motor vehicle or combination of vehicles he or she desires a
6 license to drive, except that the department may waive the driving
7 test part of the examination for any applicant who submits a license
8 issued by another state, territory, or possession of the United States,
9 the District of Columbia, or the Commonwealth of Puerto Rico if
10 the department verifies through any acknowledged national driver
11 record data source that there are no stops, holds, or other
12 impediments to its issuance. The examining officer may request
13 to see evidence of financial responsibility for the vehicle prior to
14 supervising the demonstration of the applicant's ability to operate
15 the vehicle. The examining officer may refuse to examine an
16 applicant who is unable to provide proof of financial responsibility
17 for the vehicle, unless proof of financial responsibility is not
18 required by this code.

19 (F) A test of the hearing and eyesight of the applicant, and of
20 other matters that may be necessary to determine the applicant's
21 mental and physical fitness to operate a motor vehicle upon the
22 highways, and whether any grounds exist for refusal of a license
23 under this code.

24 (2) The examination for a class A or class B driver's license
25 under subdivision (b) shall also include a report of a medical
26 examination of the applicant given not more than two years prior
27 to the date of the application by a health care professional. As used
28 in this paragraph, "health care professional" means a person who
29 is licensed, certified, or registered in accordance with applicable
30 state laws and regulations to practice medicine and perform
31 physical examinations in the United States. Health care
32 professionals are doctors of medicine, doctors of osteopathy,
33 physician assistants, and registered advanced practice nurses, or
34 doctors of chiropractic who are clinically competent to perform
35 the medical examination presently required of motor carrier drivers
36 by the federal Department of Transportation. The report shall be
37 on a form approved by the department, the federal Department of
38 Transportation, or the Federal Aviation Administration. In
39 establishing the requirements, consideration may be given to the

1 standards presently required of motor carrier drivers by the Federal
2 Highway Administration.

3 (3) A physical defect of the applicant that, in the opinion of the
4 department, is compensated for to ensure safe driving ability shall
5 not prevent the issuance of a license to the applicant.

6 (b) In accordance with the following classifications, an applicant
7 for a driver's license shall be required to submit to an examination
8 appropriate to the type of motor vehicle or combination of vehicles
9 the applicant desires a license to drive:

10 (1) Class A includes the following:

11 (A) A combination of vehicles, if a vehicle being towed has a
12 gross vehicle weight rating of more than 10,000 pounds.

13 (B) A vehicle towing more than one vehicle.

14 (C) A trailer bus.

15 (D) The operation of all vehicles under class B and class C.

16 (2) Class B includes the following:

17 (A) A single vehicle with a gross vehicle weight rating of more
18 than 26,000 pounds.

19 (B) A single vehicle with three or more axles, except any
20 three-axle vehicle weighing less than 6,000 pounds.

21 (C) A bus except a trailer bus.

22 (D) A farm labor vehicle.

23 (E) A single vehicle with three or more axles or a gross vehicle
24 weight rating of more than 26,000 pounds towing another vehicle
25 with a gross vehicle weight rating of 10,000 pounds or less.

26 (F) A house car over 40 feet in length, excluding safety devices
27 and safety bumpers.

28 (G) The operation of all vehicles covered under class C.

29 (3) Class C includes the following:

30 (A) A two-axle vehicle with a gross vehicle weight rating of
31 26,000 pounds or less, including when the vehicle is towing a
32 trailer or semitrailer with a gross vehicle weight rating of 10,000
33 pounds or less.

34 (B) Notwithstanding subparagraph (A), a two-axle vehicle
35 weighing 4,000 pounds or more unladen when towing a trailer
36 coach not exceeding 9,000 pounds gross.

37 (C) A house car of 40 feet in length or less.

38 (D) A three-axle vehicle weighing 6,000 pounds gross or less.

39 (E) A house car of 40 feet in length or less or vehicle towing
40 another vehicle with a gross vehicle weight rating of 10,000 pounds

1 or less, including when a tow dolly is used. A person driving a
 2 vehicle may not tow another vehicle in violation of Section 21715.
 3 (F) (i) A two-axle vehicle weighing 4,000 pounds or more
 4 unladen when towing either a trailer coach or a fifth-wheel travel
 5 trailer not exceeding 10,000 pounds gross vehicle weight rating,
 6 when the towing of the trailer is not for compensation.
 7 (ii) A two-axle vehicle weighing 4,000 pounds or more unladen
 8 when towing a fifth-wheel travel trailer exceeding 10,000 pounds,
 9 but not exceeding 15,000 pounds, gross vehicle weight rating,
 10 when the towing of the trailer is not for compensation, and if the
 11 person has passed a specialized written examination provided by
 12 the department relating to the knowledge of this code and other
 13 safety aspects governing the towing of recreational vehicles upon
 14 the highway.
 15 (iii) The authority to operate combinations of vehicles under
 16 this subparagraph may be granted by endorsement on a class C
 17 license upon completion of that written examination.
 18 (G) A vehicle or combination of vehicles with a gross
 19 combination weight rating or a gross vehicle weight rating, as
 20 those terms are defined in subdivisions (j) and (k), respectively,
 21 of Section 15210, of 26,000 pounds or less, if all of the following
 22 conditions are met:
 23 (i) Is operated by a farmer, an employee of a farmer, or an
 24 instructor credentialed in agriculture as part of an instructional
 25 program in agriculture at the high school, community college, or
 26 university level.
 27 (ii) Is used exclusively in the conduct of agricultural operations.
 28 (iii) Is not used in the capacity of a for-hire carrier or for
 29 compensation.
 30 (H) A motorized scooter.
 31 (I) Class C does not include a two-wheel motorcycle or a
 32 two-wheel motor-driven cycle.
 33 (4) Class M1. A two-wheel motorcycle or a motor-driven cycle.
 34 Authority to operate a vehicle included in a class M1 license may
 35 be granted by endorsement on a class A, B, or C license upon
 36 completion of an appropriate examination.
 37 (5) (A) Class M2 includes the following:
 38 (i) A motorized bicycle or moped, or a bicycle with an attached
 39 motor, except a motorized bicycle described in subdivision (b) of
 40 Section 406.

1 (ii) A motorized scooter.

2 (B) Authority to operate vehicles included in class M2 may be
3 granted by endorsement on a class A, B, or C license upon
4 completion of an appropriate examination, except that no
5 endorsement is required for a motorized scooter. Persons holding
6 a class M1 license or endorsement may operate vehicles included
7 in class M2 without further examination.

8 (c) A driver's license or driver certificate is not valid for
9 operating a commercial motor vehicle, as defined in subdivision
10 (b) of Section 15210, any other motor vehicle defined in paragraph
11 (1) or (2) of subdivision (b), or any other vehicle requiring a driver
12 to hold any driver certificate or any driver's license endorsement
13 under Section 15275, unless a medical certificate approved by the
14 department, the federal Department of Transportation, or the
15 Federal Aviation Administration, that has been issued within two
16 years of the date of the operation of that vehicle, is within the
17 licensee's immediate possession, and a copy of the medical
18 examination report from which the certificate was issued is on file
19 with the department. Otherwise, the license is valid only for
20 operating class C vehicles that are not commercial vehicles, as
21 defined in subdivision (b) of Section 15210, and for operating class
22 M1 or M2 vehicles, if so endorsed, that are not commercial
23 vehicles, as defined in subdivision (b) of Section 15210.

24 (d) A license or driver certificate issued prior to the enactment
25 of Chapter 7 (commencing with Section 15200) is valid to operate
26 the class or type of vehicles specified under the law in existence
27 prior to that enactment until the license or certificate expires or is
28 otherwise suspended, revoked, or canceled.

29 (e) The department may accept a certificate of driving skill that
30 is issued by an employer, authorized by the department to issue a
31 certificate under Section 15250, of the applicant, in lieu of a driving
32 test, on class A or B applications, if the applicant has first qualified
33 for a class C license and has met the other examination
34 requirements for the license for which he or she is applying. The
35 certificate may be submitted as evidence of the applicant's skill
36 in the operation of the types of equipment covered by the license
37 for which he or she is applying.

38 (f) The department may accept a certificate of competence in
39 lieu of a driving test on class M1 or M2 applications, when the
40 certificate is issued by a law enforcement agency for its officers

1 who operate class M1 or M2 vehicles in their duties, if the applicant
2 has met the other examination requirements for the license for
3 which he or she is applying.

4 (g) The department may accept a certificate of satisfactory
5 completion of a novice motorcyclist training program approved
6 by the commissioner pursuant to Section 2932 in lieu of a driving
7 test on class M1 or M2 applications, if the applicant has met the
8 other examination requirements for the license for which he or she
9 is applying. The department shall review and approve the written
10 and driving test used by a program to determine whether the
11 program may issue a certificate of completion.

12 (h) Notwithstanding subdivision (b), a person holding a valid
13 California driver's license of any class may operate a short-term
14 rental motorized bicycle without taking any special examination
15 for the operation of a motorized bicycle, and without having a
16 class M2 endorsement on that license. As used in this subdivision,
17 "short-term" means 48 hours or less.

18 (i) A person under 21 years of age shall not be issued a class
19 M1 or M2 license or endorsement unless he or she provides
20 evidence satisfactory to the department of completion of a
21 motorcycle safety training program that is operated pursuant to
22 Article 2 (commencing with Section 2930) of Chapter 5 of Division
23 2.

24 (j) A driver of a vanpool vehicle may operate with a class C
25 license but shall possess evidence of a medical examination
26 required for a class B license when operating vanpool vehicles. In
27 order to be eligible to drive the vanpool vehicle, the driver shall
28 keep in the vanpool vehicle a statement, signed under penalty of
29 perjury, that he or she has not been convicted of reckless driving,
30 drunk driving, or a hit-and-run offense in the last five years.

31 (k) A class M license issued between January 1, 1989, and
32 December 31, 1992, shall permit the holder to operate any
33 motorcycle, motor-driven cycle, or motorized bicycle until the
34 expiration of the license.
