Assembly Concurrent Resolution No. 140—Relative to the Donald Mark Lichliter Memorial Highway.

LEGISLATIVE COUNSEL'S DIGEST

ACR 140, as introduced, Huber. Donald Mark Lichliter Memorial Highway.

This measure would designate a portion of State Highway Route 99, in the County of San Joaquin, as the Donald Mark Lichliter Memorial Highway. This measure would also request the Department of Transportation to determine the cost of appropriate signs showing this special designation and, upon receiving donations from nonstate sources covering those costs, to erect those signs.

Fiscal committee: yes.

- 1 WHEREAS, Donald Mark Lichliter was born in Minneapolis,  
2 Minnesota, and resided there until he joined the United States Air  
3 Force at 18 years of age; and  
4 WHEREAS, The Air Force brought Donald to the Sacramento  
5 area, and from that time forward he called California home; and  
6 WHEREAS, Donald was a member of Chapter 263 of the  
7 American Legion Riders, and enjoyed golfing, motorcycling,  
8 hunting, and fishing; and  
9 WHEREAS, Donald was a devoted and hard-working public  
10 servant, who worked for Caltrans for over 27 years; and

1 WHEREAS, Donald met his wife, Mandy, in 1987 and they  
2 were married on September 17, 1988; and

3 WHEREAS, Each Tuesday, Donald and Mandy met with their  
4 church congregation where they worked to feed the homeless; and

5 WHEREAS, On July 23, 2009, Donald was working as a  
6 Caltrans tree maintenance leadworker when he was struck by a  
7 truck as he worked next to his vehicle, and was killed in the line  
8 of duty; and

9 WHEREAS, Donald is survived by his wife of 21 years, Mandy,  
10 his children Allyson, Nicole Lewis, Jollene Kelley, John Lewis,  
11 two grandchildren, his parents, and 3 siblings; now, therefore, be  
12 it

13 *Resolved by the Assembly of the State of California, the Senate*  
14 *thereof concurring,* That the Legislature hereby designates the  
15 portion of State Highway Route 99, from East Victor Road to East  
16 Kettleman Lane, in the County of San Joaquin, as the Donald Mark  
17 Lichliter Memorial Highway; and be it further

18 *Resolved,* That the Department of Transportation is requested  
19 to determine the cost of appropriate signs consistent with the  
20 signing requirements for the state highway system showing this  
21 special designation and, upon receiving donations from nonstate  
22 sources sufficient to cover the cost, to erect those signs; and be it  
23 further

24 *Resolved,* That the Chief Clerk of the Assembly transmit copies  
25 of this resolution to the Department of Transportation and to the  
26 author for appropriate distribution.
