An act to add *and repeal* Section 66025.9~~to~~ of the Education Code, relating to postsecondary education.

LEGISLATIVE COUNSEL'S DIGEST

AB 194, as amended, Beall. Public postsecondary education: priority enrollment: foster youth.

Existing law requires the California State University and each community college district, and requests the University of California, with respect to each campus in their respective jurisdictions that administers a priority enrollment system, to grant priority for registration for enrollment to any member or former member of the Armed Forces of the United States, as defined, for any academic term attended at one of these institutions within 2 years of leaving active duty.

This bill, *until January 1, 2017*, would require the California State University and each community college district, and requests the University of California, with respect to each campus in their respective jurisdictions that administers a priority enrollment system, to grant priority for registration for enrollment to foster youth or former foster youth, as defined.

By revising requirements relating to student eligibility for priority registration at community college districts, the bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to these statutory provisions.

The people of the State of California do enact as follows:

1 SECTION 1. Section 66025.9 is added to the Education Code,
 2 to read:
 3 66025.9. (a) The California State University and each
 4 community college district shall, and the University of California
 5 is requested to, with respect to each campus in their respective
 6 jurisdictions that administers a priority enrollment system, grant
 7 priority in that system for registration for enrollment to a foster
 8 youth or former foster youth.
 9 (b) For purposes of this section, “foster youth” means a person
 10 who is currently in foster care, and “former foster youth” means
 11 a person who is an emancipated foster youth and who is up to 24
 12 years of age.
 13 (c) *This section shall remain in effect only until January 1, 2017,*
 14 *and as of that date is repealed, unless a later enacted statute, that*
 15 *is enacted before January 1, 2017, deletes or extends that date.*
 16 SEC. 2. If the Commission on State Mandates determines that
 17 this act contains costs mandated by the state, reimbursement to
 18 local agencies and school districts for those costs shall be made

- 1 pursuant to Part 7 (commencing with Section 17500) of Division
- 2 4 of Title 2 of the Government Code.
