

Introduced by Senator DuttonFebruary 17, 2011

An act to amend and repeal Section 130105 of, to repeal Sections 130110, 130115, 130120, 130125, 130130, 130135, 130140, 130140.1, 130145, 130150, 130151, and 130155 of, and to repeal and add Section 130100 of, the Health and Safety Code, and to amend Section 31031.4 of the Revenue and Taxation Code, relating to state government and public health, and declaring the urgency thereof, to take effect immediately.

LEGISLATIVE COUNSEL'S DIGEST

SB 486, as introduced, Dutton. California Children and Families Program: funding.

The California Children and Families Act of 1998, an initiative measure, requires that the California Children and Families Program, established by the act, be funded by certain taxes imposed on the sale and distribution of cigarettes and tobacco products that are deposited into the continuously appropriated California Children and Families Trust Fund, and that the fund be used for the implementation of comprehensive early childhood development and smoking prevention programs. Existing law requires that specified percentages of moneys allocated and appropriated from the trust shall be deposited in various accounts for expenditure by the California Children and Families Commission, also known as First 5 California, for various subjects relating to, and furthering the goals and purposes of, the act.

Existing law prohibits amendment of this initiative measure by the Legislature unless the amendment is approved by the voters, or the amendment is accomplished by a vote of $\frac{2}{3}$ of the membership of both

houses of the Legislature and the amendment furthers the act and is consistent with its purposes.

This bill, subject to voter approval, would eliminate those percentages for allocations to various accounts and would, instead, provide that those funds, with specified exceptions, shall be transferred to the General Fund for appropriation by the Legislature for purposes of the Healthy Families Program and the Medi-Cal program. The bill would provide for the distribution, as prescribed, of funds held by county children and families commissions and by the California Children and Families Commission that remain unencumbered on the date that the bill's provisions are approved by the voters. This bill would abolish the California Children and Families Commission and the county children and families commissions, effective 90 days after the bill's provisions are approved by the voters, and would repeal related provisions. This bill would require that its provisions be submitted to the voters for approval at the next statewide election.

This bill would declare that it is to take effect immediately as an urgency statute.

The people of the State of California do enact as follows:

38 subject to subdivision (c). These reimbursements shall occur at
39 any time as determined necessary to further the intent of this
40 subdivision.

37 ~~(b) The voting members shall be selected, pursuant to Section~~
38 ~~130115, from persons with knowledge, experience, and expertise~~
39 ~~in early child development, child care, education, social services,~~
40 ~~public health, the prevention and treatment of tobacco and other~~

1 substance abuse, behavioral health, and medicine (including, but

17 Governor, one shall serve for a term of four years, and two for a
18 term of two years. Of the members appointed by the Speaker of
19 the Assembly and the Senate Rules Committee, one appointed by

30 the voters at the next statewide election in accordance with
31 provisions of the Government Code and the Elections Code
32 governing the submission of a statewide measure to the voters.

33 SEC. 21. The provisions of this act are severable. If any
34 provision of this act or its application is held invalid, that invalidity
35 shall not affect other provisions or applications that can be given
36 effect without the invalid provision or application.

37 SEC. 22. This act is an urgency statute necessary for the
38 immediate preservation of the public peace, health, or safety within
39 the meaning of Article IV of the Constitution and shall go into
40 immediate effect. The facts constituting the necessity are:

1 In order to provide critical funding for health care services that
2 have been jeopardized by the current budgetary crisis, it is
3 necessary that this act take effect immediately.
