SENATE BILL

An act to-amend Section 16700 of the Penal Code, repeal Section 53071.5 of the Government Code, relating to imitation firearms.

LEGISLATIVE COUNSEL'S DIGEST

SB 798, as amended, De León. Firearms: BB devices: imitation firearms.

Existing law provides that the Legislature occupies the whole field of regulation of the manufacture, sale, or possession of imitation firearms, as defined, and that those provisions shall preempt and be exclusive of all regulations relating to the manufacture, sale, or possession of imitation firearms, including regulations governing the manufacture, sale, or possession of BB devices and air rifles, as specified.

This bill would repeal those provisions.

Existing law defines "BB device" to mean any instrument that expels a projectile, such as a BB or a pellet, through the force of air pressure, gas pressure, or spring action, or any spot marker gun. Existing law defines "imitation firearm" to mean any BB device, toy gun, replica of a firearm, or other device that is so substantially similar in coloration and overall appearance to an existing firearm as to lead a reasonable person to perceive that the device is a firearm but provides that a BB

device is not an imitation firearm in regard to a provision imposing a eivil fine on the sale, manufacture, transportation, receipt, or distribution of imitation firearms for commercial purposes.

This bill would make the provision imposing a civil fine on the sale, manufacture, transportation, receipt, or distribution of imitation firearms for commercial purposes applicable to BB devices.

The bill would also provide that a spot marker gun that expels a projectile of greater than 10 mm caliber would not be an imitation firearm in regard to the provision imposing a civil fine on the sale, manufacture, transportation, receipt, or distribution of imitation firearms for commercial purposes.
