SENATE BILL

~~An act to add Section 60902 to the Education Code, relating to pupil data.~~ *An act relating to public employees' retirement.*

LEGISLATIVE COUNSEL'S DIGEST

SB 827, as amended, ~~Lowenthal~~ *Simitian*. ~~Pupil data: California Longitudinal Pupil Achievement Data System Advisory Committee.~~ *Public employees' retirement.*

The State Teachers' Retirement System, the Public Employees' Retirement System, the Judges' Retirement System, and the Judges Retirement System II provide pension benefits based in part upon credited service. Under existing law, counties and districts, as defined, may provide retirement benefits to their employees pursuant to the County Employees Retirement Law of 1937.

This bill would declare the intent of the Legislature to convene a conference committee to craft responsible, comprehensive legislation to reform state and local pension systems in a manner that reflects both

the legitimate needs of public employees and the fiscal circumstances of state and local governments.

Existing law establishes the California Education Information System, which consists of the California Longitudinal Pupil Achievement Data System (CALPADS) and the California Longitudinal Teacher Integrated Data Education System. Existing law requires the State Department of Education to contract for the development of proposals that will provide for the retention and analysis of longitudinal pupil achievement data, known as CALPADS.

This bill would require the Superintendent of Public Instruction to establish a California Longitudinal Pupil Achievement Data System Advisory Committee to advise, and provide recommendations to, the Governor, Superintendent, State Board of Education, and Legislature on matters relating to CALPADS, as specified. The bill would require the advisory committee to consist of 23 members, as specified, and to be cochaired by the president of the state board and the Superintendent, or their respective designees. The bill would provide that advisory committee members shall serve without compensation or reimbursement for travel or any other costs associated with service on the advisory committee. The bill would require the advisory committee to report its recommendations regarding CALPADS to the Governor, Legislature, Superintendent, and state board by January 1, 2013.

The people of the State of California do enact as follows:

35 ~~(6) Four members shall be appointed by the Senate Committee~~
