~~An act to amend Section 120440 of the Health and Safety Code, relating to public health. An act to add Chapter 2.8 (commencing with Section 2500) to Part 1 of Division 2 of the Public Contract Code, relating to public contracts.~~

LEGISLATIVE COUNSEL'S DIGEST

SB 922, as amended, Negrete McLeod. ~~Immunizations: disclosure of information: tuberculosis screening.~~ *Public contracts: public entities: project labor agreements.*

*Existing law sets forth the requirements for the solicitation and evaluation of bids and the awarding of contracts by public entities.*

*This bill would authorize a public entity to use, enter into, or require contractors to enter into, a project labor agreement for a construction project, if the agreement includes specified taxpayer protection provisions.*

*This bill would authorize the members of the governing board of a local public entity to choose by majority vote whether to use, enter into, or require contractors to enter into a project labor agreement for a specific project or projects awarded by that entity and whether to allocate funding to a specific project covered by such an agreement. This bill would prohibit a charter provision, initiative, or ordinance*

*from preventing the governing board of a local public entity, other than a charter city, from exercising this authority on a project-specific basis.*

*This bill would also provide that if a charter provision, initiative, or ordinance of a charter city prohibits the governing board's consideration of a project labor agreement for a project to be awarded by the city, or prohibits the governing board from considering whether to allocate funds to a city-funded project covered by such an agreement, then state funding or financial assistance may not be used to support that project, as specified.*

~~Existing law regulates the sharing of a patient's or client's immunization information between a health care provider, local health department, the State Department of Public Health, and other agencies. Existing law prescribes the process by which a patient or client, or parent or guardian of a patient or client, may refuse to allow the information to be shared and requires the health care provider administering the immunization to provide the patient with designated notice. Existing law permits local health departments and the department to share the name of a patient or client, or parent or guardian of a patient or client, with a state, local health department, health care provider, immunization information system, or any representative of an entity designated by federal or state law to receive this information, and authorizes the department to enter into written agreements to share this information with other states for specified purposes, unless the patient or client, or parent or guardian of the patient or client, refuses to allow the information to be shared. Under existing law, the patient or client, or parent or guardian of the patient or client, has the right to examine shared immunization-related information and to correct errors in it.~~

~~Under existing law, if the patient or client, or parent or guardian of a patient or client, refuses the sharing of immunization information, the patient's or client's physician is allowed to maintain access to this information for the purpose of patient care or protecting the public health. Existing law also allows the local health department and the department to maintain access to this information for the purpose of protecting the public health.~~

~~This bill would include tuberculosis screening, as defined, in the above immunization information provisions.~~

*The people of the State of California do enact as follows:*

1     *SECTION 1. The Legislature finds and declares all of the*  
2 *following:*

3     *(a) Project labor agreements can provide significant benefits*  
4 *to taxpayers by insulating construction projects against*  
5 *uncertainties, promoting transparent competition, and ensuring*  
6 *a reliable supply of labor.*

7     *(b) Projects differ and project labor agreements differ. All*  
8 *taxpayers' interests are best served by ensuring that:*

9         *(1) All project labor agreements used for public projects must*  
10 *contain fundamental taxpayer protections.*

11         *(2) Local governments are free to choose whether to adopt or*  
12 *not to adopt project labor agreements containing these taxpayer*  
13 *projections for a particular project or projects.*

14     *SEC. 2. Chapter 2.8 (commencing with Section 2500) is added*  
15 *to Part 1 of Division 2 of the Public Contract Code, to read:*

17             *CHAPTER 2.8. PROJECT LABOR AGREEMENTS*

19     2500. *(a) A public entity may use, enter into, or require*  
20 *contractors to enter into, a project labor agreement for a*  
21 *construction project only if the agreement includes all of the*  
22 *following taxpayer protection provisions:*

23         *(1) The agreement prohibits discrimination based on race,*  
24 *national origin, religion, sex, sexual orientation, political*  
25 *affiliation, or membership in a labor organization in hiring and*  
26 *dispatching workers for the project.*

27         *(2) The agreement permits all qualified contractors and*  
28 *subcontractors to bid for and be awarded work on the project*  
29 *without regard to whether they are otherwise parties to collective*  
30 *bargaining agreements.*

31         *(3) The agreement contains an agreed-upon protocol concerning*  
32 *drug testing for workers who will be employed on the project.*

33         *(4) The agreement contains guarantees against work stoppages,*  
34 *strikes, lockouts, and similar disruptions of the project.*

35         *(5) The agreement provides that disputes arising from the*  
36 *agreement shall be resolved by a neutral arbitrator.*

37     *(b) For purposes of this chapter, both of the following definitions*  
38 *apply:*

1 (1) “Project labor agreement” means a prehire collective  
 2 bargaining agreement that establishes terms and conditions of  
 3 employment for a specific construction project or projects and is  
 4 an agreement described in Section 158(f) of Title 29 of the United  
 5 States Code.

6 (2) “Public entity” means a public entity as defined in Section  
 7 1100.

8 2501. The members of the governing board of a local public  
 9 entity may choose by majority vote whether to use, enter into, or  
 10 require contractors to enter into a project labor agreement that  
 11 includes all the taxpayer protection provisions of Section 2500 for  
 12 a specific project or projects awarded by that entity and whether  
 13 to allocate funding to a specific project covered by such an  
 14 agreement. A charter provision, initiative, or ordinance shall not  
 15 prevent the governing board of a local public entity, other than a  
 16 charter city, from exercising this authority on a project-specific  
 17 basis.

18 2502. If a charter provision, initiative, or ordinance of a  
 19 charter city prohibits the governing board’s consideration of a  
 20 project labor agreement that includes all the taxpayer protection  
 21 provisions of Section 2500 for a project to be awarded by the city,

 23 allocate funds to a city-funded project covered by such an  
 24 agreement, then state funding or financial assistance shall not be  
 25 used to support that project. This section shall not be applicable  
 26 until January 1, 2015, for charter cities in which a charter
