SENATE BILL

No. 1366

Introduced by Senator DeSaulnier

February 24, 2012

An act to amend Sections 16520, 26835, and 27535 of, and to add Division 4.5 (commencing with Section 25250) to Title 4 of Part 6 of, the Penal Code, relating to firearms.

LEGISLATIVE COUNSEL'S DIGEST

SB 1366, as amended, DeSaulnier. Firearms: lost or stolen: reports.

(1) Existing law requires each sheriff or police chief executive to submit descriptions of serialized property, or nonserialized property that has been uniquely inscribed, which has been reported stolen, lost, or found directly into the appropriate Department of Justice automated property system for firearms, stolen bicycles, stolen vehicles, or other property. Existing law requires that information about a firearm entered into the automated system for firearms remain in the system until the reported firearm has been found. Existing law requires the Department of Justice to implement an electronic system to receive comprehensive tracing information from each local law enforcement agency and to forward the information to the National Tracing Center.

This bill would require every person, with exceptions, to report the theft or loss of a firearm he or she owns or possesses to a local law enforcement agency in the jurisdiction in which the theft or loss occurred within 48 hours of the time he or she knew or reasonably should have known that the firearm had been stolen or lost, and requires every person who has reported a firearm lost or stolen to notify the local law enforcement agency within 48 hours if the firearm is subsequently

recovered. The bill would make a violation of these provisions an infraction punishable by a fine not to exceed \$100 for a first offense, *an infraction punishable by a fine not to exceed \$1,000 for a 2nd offense*, and a misdemeanor, punishable by imprisonment in a county jail not exceeding 6 months, or by a fine not to exceed \$1,000, or both that fine and imprisonment, for a *3rd or* subsequent offense. The bill would make it a misdemeanor for any person to make a report to a local law enforcement agency that a firearm has been lost or stolen, knowing the report to be false. By creating new crimes, this bill would impose a state-mandated local program.

The bill would require every sheriff or police chief to submit a description of each firearm that has been reported lost or stolen directly to the Department of Justice automated property system for firearms. By imposing new duties on local agencies, this bill would impose a state-mandated local program.

The bill would also require that persons licensed to sell firearms post a warning within the licensed premises in block letters stating the requirement that a lost or stolen firearm be reported to a local law enforcement agency, as specified.

(2) Existing law prohibits a person from making an application to purchase more than one handgun within any 30-day period. Existing law makes an exception for the replacement of a handgun when the person's handgun was lost or stolen and the person reported the firearm lost or stolen prior to the completion of the application to purchase.

This bill would instead make the exception for the replacement of a lost or stolen handgun applicable when the person has reported the handgun lost or stolen pursuant to the provisions of this bill.

(3) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that with regard to certain mandates no reimbursement is required by this act for a specified reason.

With regard to any other mandates, this bill would provide that, if the Commission on State Mandates determines that the bill contains costs so mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

The people of the State of California do enact as follows:

SECTION 1. Section 16520 of the Penal Code is amended to read:

16520. (a) As used in this part, “firearm” means any device, designed to be used as a weapon, from which is expelled through a barrel, a projectile by the force of any explosion or other form of combustion.

(c) As used in the following provisions, “firearm” also includes any rocket, rocket propelled projectile launcher, or similar device containing any explosive or incendiary material whether or not the device is designed for emergency or distress signaling purposes:

25 includes the unfinished frame or receiver of a weapon that can be
26 readily converted to the functional condition of a finished frame
27 or receiver.
28 SEC. 2. Division 4.5 (commencing with Section 25250) is
29 added to Title 4 of Part 6 of the Penal Code, to read:

31 DIVISION 4.5. LOST OR STOLEN FIREARMS
32
33 25250. (a) Commencing January 1, 2013, every person shall
34 report the theft or loss of a firearm he or she owns or possesses to
35 a local law enforcement agency in the jurisdiction in which the
36 theft or loss occurred within 48 hours of the time he or she knew
37 or reasonably should have known that the firearm had been stolen
38 or lost.
39 (b) Every person who has reported a firearm lost or stolen under
40 subdivision (a) shall notify the local law enforcement agency in

1 the jurisdiction in which the theft or loss occurred within 48 hours
2 if the firearm is subsequently recovered by the person.

3 25251. Section 25250 shall not apply to the following:

4 (a) Any law enforcement agency or peace officer acting within
5 the course and scope of his or her employment or official duties
6 if he or she reports the loss or theft to his or her employing agency.

7 (b) Any United States Marshal or member of the Armed Forces
8 of the United States or the National Guard, while engaged in his

18 25252. Pursuant to Section 11108, every sheriff or police chief
19 shall submit a description of each firearm which has been reported
20 lost or stolen directly into the Department of Justice automated
21 property system for firearms.

22 25253. (a) Every person who violates Section 25250 is, for a
23 first violation, guilty of an infraction punishable by a fine not to
24 exceed one hundred dollars (\$100).

25 (b) Every person who violates Section 25250 is, for a second
26 ~~or subsequent violation, guilty of a misdemeanor or an infraction,~~
27 ~~punishable by imprisonment in a county jail not exceeding six~~
28 ~~months, or by a fine not exceeding one thousand dollars (\$1,000);~~
29 ~~or by both that fine and imprisonment.~~

30 *(c) Every person who violates Section 25250 is, for a third or*
31 *subsequent violation, guilty of a misdemeanor, punishable by*
32 *imprisonment in a county jail not exceeding six months, or by a*
33 *fine not exceeding one thousand dollars (\$1,000), or by both that*
34 *fine and imprisonment.*

35 25255. Every person reporting a lost or stolen firearm pursuant
36 to Section 25250 shall report the make, model, and serial number
37 of the firearm, if known by the person.

38 25256. Commencing January 1, 2013, no person shall report
39 to a local law enforcement agency that a firearm has been lost or

1 stolen, knowing the report to be false. A violation of this section
2 shall be a misdemeanor.

3 SEC. 3. Section 26835 of the Penal Code is amended to read:
4 26835. A licensee shall post conspicuously within the licensed
5 premises the following warnings in block letters not less than one
6 inch in height:

8 (a) “IF YOU KEEP A LOADED FIREARM WITHIN ANY
9 PREMISES UNDER YOUR CUSTODY OR CONTROL, AND
10 A PERSON UNDER 18 YEARS OF AGE OBTAINS IT AND
11 USES IT, RESULTING IN INJURY OR DEATH, OR CARRIES
12 IT TO A PUBLIC PLACE, YOU MAY BE GUILTY OF A
13 MISDEMEANOR OR A FELONY UNLESS YOU STORED
14 THE FIREARM IN A LOCKED CONTAINER OR LOCKED
15 THE FIREARM WITH A LOCKING DEVICE, TO KEEP IT
16 FROM TEMPORARILY FUNCTIONING.”

17 (b) “IF YOU KEEP A PISTOL, REVOLVER, OR OTHER
18 FIREARM CAPABLE OF BEING CONCEALED UPON THE
19 PERSON, WITHIN ANY PREMISES UNDER YOUR CUSTODY
20 OR CONTROL, AND A PERSON UNDER 18 YEARS OF AGE
21 GAINS ACCESS TO THE FIREARM, AND CARRIES IT
22 OFF-PREMISES, YOU MAY BE GUILTY OF A
23 MISDEMEANOR, UNLESS YOU STORED THE FIREARM IN
24 A LOCKED CONTAINER, OR LOCKED THE FIREARM WITH
25 A LOCKING DEVICE, TO KEEP IT FROM TEMPORARILY
26 FUNCTIONING.”

27 (c) “IF YOU KEEP ANY FIREARM WITHIN ANY
28 PREMISES UNDER YOUR CUSTODY OR CONTROL, AND
29 A PERSON UNDER 18 YEARS OF AGE GAINS ACCESS TO
30 THE FIREARM, AND CARRIES IT OFF-PREMISES TO A
31 SCHOOL OR SCHOOL-SPONSORED EVENT, YOU MAY BE
32 GUILTY OF A MISDEMEANOR, INCLUDING A FINE OF UP
33 TO FIVE THOUSAND DOLLARS (\$5,000), UNLESS YOU
34 STORED THE FIREARM IN A LOCKED CONTAINER, OR
35 LOCKED THE FIREARM WITH A LOCKING DEVICE.”

36 (d) “DISCHARGING FIREARMS IN POORLY VENTILATED
37 AREAS, CLEANING FIREARMS, OR HANDLING
38 AMMUNITION MAY RESULT IN EXPOSURE TO LEAD, A
39 SUBSTANCE KNOWN TO CAUSE BIRTH DEFECTS,
40 REPRODUCTIVE HARM, AND OTHER SERIOUS PHYSICAL

1 INJURY. HAVE ADEQUATE VENTILATION AT ALL TIMES.
2 WASH HANDS THOROUGHLY AFTER EXPOSURE.”

3 (e) “FEDERAL REGULATIONS PROVIDE THAT IF YOU
4 DO NOT TAKE PHYSICAL POSSESSION OF THE FIREARM
5 THAT YOU ARE ACQUIRING OWNERSHIP OF WITHIN 30
6 DAYS AFTER YOU COMPLETE THE INITIAL
7 BACKGROUND CHECK PAPERWORK, THEN YOU HAVE
8 TO GO THROUGH THE BACKGROUND CHECK PROCESS
9 A SECOND TIME IN ORDER TO TAKE PHYSICAL
10 POSSESSION OF THAT FIREARM.”

11 (f) “NO PERSON SHALL MAKE AN APPLICATION TO
12 PURCHASE MORE THAN ONE PISTOL, REVOLVER, OR
13 OTHER FIREARM CAPABLE OF BEING CONCEALED UPON
14 THE PERSON WITHIN ANY 30-DAY PERIOD AND NO
15 DELIVERY SHALL BE MADE TO ANY PERSON WHO HAS
16 MADE AN APPLICATION TO PURCHASE MORE THAN ONE
17 PISTOL, REVOLVER, OR OTHER FIREARM CAPABLE OF
18 BEING CONCEALED UPON THE PERSON WITHIN ANY
19 30-DAY PERIOD.”

20 (g) “IF A FIREARM YOU OWN OR POSSESS IS LOST OR
21 STOLEN, YOU MUST REPORT THE LOSS OR THEFT TO A
22 LOCAL LAW ENFORCEMENT AGENCY WHERE THE LOSS
23 OR THEFT OCCURRED WITHIN 48 HOURS OF THE TIME
24 YOU KNEW OR REASONABLY SHOULD HAVE KNOWN
25 THAT THE FIREARM HAD BEEN LOST OR STOLEN.”

26
27 SEC. 4. Section 27535 of the Penal Code is amended to read:
28 27535. (a) No person shall make an application to purchase
29 more than one handgun within any 30-day period.

30 (b) Subdivision (a) shall not apply to any of the following:

31 (1) Any law enforcement agency.

32 (2) Any agency duly authorized to perform law enforcement
33 duties.

34 (3) Any state or local correctional facility.

35 (4) Any private security company licensed to do business in
36 California.

37 (5) Any person who is properly identified as a full-time paid
38 peace officer, as defined in Chapter 4.5 (commencing with Section
39 830) of Title 3 of Part 2, and who is authorized to, and does carry

1 a firearm during the course and scope of employment as a peace
2 officer.

3 (6) Any motion picture, television, or video production company
4 or entertainment or theatrical company whose production by its
5 nature involves the use of a firearm.

6 (7) Any person who may, pursuant to Article 2 (commencing
7 with Section 27600), Article 3 (commencing with Section 27650),
8 or Article 4 (commencing with Section 27700), claim an exemption
9 from the waiting period set forth in Section 27540.

10 (8) Any transaction conducted through a licensed firearms dealer
11 pursuant to Chapter 5 (commencing with Section 28050).

12 (9) Any person who is licensed as a collector pursuant to Chapter
13 44 (commencing with Section 921) of Title 18 of the United States
14 Code and the regulations issued pursuant thereto, and has a current
15 certificate of eligibility issued by the Department of Justice
16 pursuant to Article 1 (commencing with Section 26700) of Chapter
17 2.

18 (10) The exchange of a handgun where the dealer purchased
19 that firearm from the person seeking the exchange within the
20 30-day period immediately preceding the date of exchange or
21 replacement.

22 (11) The replacement of a handgun when the person's handgun
23 was lost or stolen, and the person reported that firearm lost or
24 stolen pursuant to Section 25250 prior to the completion of the
25 application to purchase the replacement handgun.

26 (12) The return of any handgun to its owner.

27 (13) A community college that is certified by the Commission
28 on Peace Officer Standards and Training to present the law
29 enforcement academy basic course or other commission-certified
30 law enforcement training.

31 SEC. 5. No reimbursement is required by this act pursuant to
32 Section 6 of Article XIII B of the California Constitution for certain
33 costs that may be incurred by a local agency or school district
34 because, in that regard, this act creates a new crime or infraction,
35 eliminates a crime or infraction, or changes the penalty for a crime
36 or infraction, within the meaning of Section 17556 of the
37 Government Code, or changes the definition of a crime within the
38 meaning of Section 6 of Article XIII B of the California
39 Constitution.

1 However, if the Commission on State Mandates determines that
2 this act contains other costs mandated by the state, reimbursement
3 to local agencies and school districts for those costs shall be made
4 pursuant to Part 7 (commencing with Section 17500) of Division
5 4 of Title 2 of the Government Code.
