An act to add Item 0250-491 to Section 2.00 of the Budget Act of 2012, relating to the state budget, and making an appropriation therefor, to take effect immediately, budget bill.

LEGISLATIVE COUNSEL'S DIGEST

AB 24, as amended, Buchanan. Budget Act of 2012.

The Budget Act of 2012 made appropriations for the support of state government for the 2012–13 fiscal year.

This bill would amend the Budget Act of 2012 by reappropriating an item of appropriation from the Budget Act of 2010 for the purpose of acquiring equity or other real property interests in the New East County Courthouse in the County of Alameda.

This bill would declare that it is to take effect immediately as a Budget Bill.

Vote: majority. Appropriation: yes. Fiscal committee: yes.  
State-mandated local program: no.

*The people of the State of California do enact as follows:*

- 1 SECTION 1. Item 0250-491 is added to Section 2.00 of the
- 2 Budget Act of 2012, to read:

1 0250-491—Reappropriation, Capital Outlay, Judicial Branch. The appropriation  
 2 provided in the following citation is reappropriated for the purpose of ac-  
 3 quiring equity or other real property interests in the New East County  
 4 Courthouse in the County of Alameda and *is* subject to the limitations,  
 5 unless otherwise specified, provided for in the appropriation:

6 3138—Immediate and Critical Needs Account

7 (1) Item 0250-301-3138, Budget Act of 2010 (Ch. 712,  
 8 Statutes of 2010)

9 (1) 91.01.001 – Alameda County: New East County  
 10 Courthouse—Construction.

11 Provisions:

12 1. The Judicial Branch may enter into a lease-purchase  
 13 agreement with the County of Alameda for the New  
 14 East County Courthouse project that will provide lease  
 15 payments to the county subject to approval by the Di-  
 16 rector of Finance. At least 30 days prior to entering  
 17 into any agreement, the Judicial Council shall notify  
 18 the chairpersons of the committees in each house of  
 19 the Legislature that consider appropriations and the  
 20 Joint Legislative Budget Committee of the terms and  
 21 conditions of the agreement. If the Joint Legislative  
 22 Budget Committee does not express any opposition,  
 23 the Judicial Council may proceed with the agreement  
 24 after 30 days from when the Judicial Branch gave no-  
 25 tice to the chairpersons.

 27 SEC. 2. This act is a Budget Bill within the meaning of  
 28 subdivision (e) of Section 12 of Article IV of the California  
 29 Constitution and shall take effect immediately.
