Assembly Joint Resolution No. 3—Relative to immigration.

#### LEGISLATIVE COUNSEL'S DIGEST

AJR 3, as introduced, Alejo. Immigration.

This measure would specify principles for repairing the nation's broken immigration system, and would urge Congress and the President of the United States to take a comprehensive and workable approach to improving the nation's immigration system using those principles.

1 WHEREAS, The United States of America was founded by

- 2 immigrants who came from around the world seeking a better life;3 and
- 4 WHEREAS, The current immigration system is broken. It 5 separates families, reduces the effectiveness of national security

6 programs, contributes to labor abuses, and creates long backlogs

7 for families seeking naturalization. Further, it neglects the hard

- 8 work and financial contributions immigrants make to our country;9 and
- 10 WHEREAS, It is estimated that about 11 million undocumented 11 immigrants are in the United States; and
- 12 WHEREAS, California has one of the biggest populations of
- 13 immigrants, both legal and undocumented; and

1 WHEREAS, Immigrants and their children constitute nearly 2 one-half of California's population and contribute to local 3 economies. In the San Francisco Bay area, immigrants contribute 4 22 percent of the region's economic activity. In Santa Clara 5 County, immigrants contribute 44 percent of the region's economic activity. In Fresno, immigrants contribute 27 percent of the region's 6 7 economic activity. In Orange County, immigrants contribute 33 8 percent of the region's economic activity. In the Inland Empire, 9 immigrants contribute 28 percent of the region's economic activity. In San Diego, immigrants contribute 25 percent of the region's 10 economic activity. In Los Angeles County, immigrants contribute 11 12 43 percent of the region's economic activity. In Kern County, 13 immigrants contribute 24 percent of the region's economic activity. 14 In San Joaquin County, immigrants contribute 29 percent of the 15 region's economic activity. In Santa Barbara County, immigrants contribute 25 percent of the region's economic activity. In Tulare 16 17 County, immigrants contribute 32 percent of the region's economic 18 activity; and 19 WHEREAS, Approximately 77 percent of undocumented 20 immigrants that reside in California live with family members who 21 are legal United States residents and citizens; and 22 WHEREAS, One in eleven workers in California is an 23 undocumented immigrant, and immigrants are a vibrant, productive, and vital part of the state's growing economy, diverse 24 25 cultural fabric, and changing demographics. Immigrant worker 26 populations in California are concentrated in a variety of sectors, 27 including leisure and hospitality, construction, food and agriculture, 28 service, transportation, and textile sectors. Many immigrants 29 throughout the state have even started their own small businesses; 30 and 31 WHEREAS, The integration of immigrants and the development 32 of a comprehensive approach to fix our broken immigration system 33 are critical to ensure that our state continues to have a strong 34 economy; and 35 WHEREAS, Fixing our broken immigration system would have

a positive impact on the economy because moving workers out of
a vulnerable underground status produces both short- and long-term
economic gains. Doing so will strengthen the ability of working

39 families to become more productive, with higher levels of income

and job-generating consumption, and will increase their net 1 2 contributions to tax revenues: and 3 WHEREAS, Fixing our broken immigration system would have 4 a positive impact on the economy in the short and long term. 5 Recent data released by the University of California, Los Angeles, 6 indicates that legalizing the status of undocumented immigrants 7 working and living in the United States would create roughly \$1.5 8 trillion in additional GDP growth over 10 years and increase wages 9 for all workers; and 10 WHEREAS, A study released by the University of Southern 11 California estimates that the immediate and long-term effects of 12 enacting comprehensive immigration reform would result in a \$16 13 billion boost to California's economy; and 14 WHEREAS, Modernizing our antiquated and dysfunctional 15 immigration system will uphold our nation's basic values of 16 fairness, equal opportunity, and respect for the law; and

17 WHEREAS, A comprehensive approach to repair our broken 18 immigration system, one that works for all communities and 19 families in America, should include the following elements: (1) a 20 plan for providing legal status with a path to citizenship to 21 undocumented immigrants who are working and living in the 22 United States, which should include the AgJOBS Act of 2011 and 23 DREAM Act of 2011, (2) improvement of the economic situation 24 of all workers in the United States, (3) the reform of visa programs 25 in order to keep families together, protect workers' rights, and 26 ensure that future immigration is regulated and controlled rather 27 than illegal and chaotic, (4) the implementation of smart, effective 28 enforcement measures targeted at the worst violators of immigration and labor laws, (5) prioritizing immigrant integration 29 30 into our communities and country, and (6) respect for the due 31 process rights of everyone in the United States; now, therefore, be 32 it

Resolved by the Assembly and the Senate of the State of California, jointly, That the Legislature urges the President and the Congress of the United States to take a comprehensive and workable approach to solving our nation's broken immigration system, using the principles described in this resolution; and be it further
