ASSEMBLY BILL

No. 206

Introduced by Assembly Member Dickinson

January 30, 2013

An act to add Section 35400.8 to the Vehicle Code, relating to vehicles.

LEGISLATIVE COUNSEL'S DIGEST

AB 206, as amended, Dickinson. Vehicles: length limitations: buses: bicycle transportation devices.

Existing law imposes a 40-foot limitation on the length of vehicles that may be operated on the highways, with specified exemptions. Existing law exempts from this limitation an articulated bus or trolley and a bus, except a schoolbus, that is operated by a public agency or passenger stage corporation that is used in a transit system if it is equipped with a folding device attached to the front of the vehicle that is designed and used exclusively for transporting bicycles, does not materially affect efficiency or visibility of vehicle safety equipment, and does not extend more than 36 inches from the front of the body of the bus or trolley when fully deployed. In addition, existing law prohibits a bicycle that is transported on the above-described device from having the bicycle handlebars extend more than 42 inches from the front of the vehicle.

This bill would authorize the Sacramento Regional Transit District to install folding devices attached to the front of its buses that are designed and used exclusively for transporting bicycles if the use of the device meets certain requirements, including, but not limited to, that the device does not extend more than 40 inches from the front of

the bus when fully deployed, and that the handlebars of the bicycles being transported do not extend more than 46 inches from the front of the bus. *This bill would also establish, for a specified purpose, a route review committee prior to the installation of the initial folding device on a bus that is 45 feet in length. This bill would require the committee to perform an initial review of the routes on which the district proposes to operate a 45-foot bus equipped with a front-mounted bicycle rack and would require the committee to make a determination of, by unanimous vote of all members, the routes that are suitable for the safe operation of a 45-foot bus that is equipped with a front-mounted bicycle rack.* The bill would require the district to submit a report, containing specified requirements, to the Assembly Committee on Transportation and the Senate Committee on Transportation and Housing on or before December 31, 2018.

This bill would make legislative findings and declarations as to the necessity of a special statute for the Sacramento Regional Transit District.

The people of the State of California do enact as follows:

- 1 SECTION 1. Section 35400.8 is added to the Vehicle Code,
2 to read:
3 35400.8. (a) Notwithstanding Section 35400, the Sacramento
4 Regional Transit District, created pursuant to Article 1
5 (commencing with Section 6500) of Chapter 5 of Division 7 of
6 Title 1 of the Government Code as a joint powers agency, may
7 install a folding device attached to the front of a bus that is
8 designed and used exclusively for transporting bicycles if the
9 following conditions are met:
10 (1) The device does not extend more than 40 inches from the
11 front body of the bus when fully deployed.
12 (2) The device, including all bicycles transported on the device,
13 is mounted in a manner that does not materially affect efficiency
14 or visibility of vehicle safety equipment.
15 (3) The handlebars of a bicycle that is transported on a device
16 described in this subdivision do not extend more than 46 inches
17 from the front of the bus.

1 (b) For purposes of this section, “district” means the Sacramento
2 Regional Transit District.

3 (c) (1) *The district shall establish a route review committee*
4 *prior to the installation of the initial folding device, pursuant to*
5 *subdivision (a), on a bus that is 45 feet in length. The purpose of*
6 *the committee is to ensure the safe operation of a 45-foot bus that*
7 *is equipped with a front-mounted bicycle rack.*

8 (2) *The committee established pursuant to this subdivision shall*
9 *perform an initial review of the routes on which the district*
10 *proposes to operate a 45-foot bus equipped with a front-mounted*
11 *bicycle rack. The review shall include a field review of the*
12 *proposed routes, including consultation with licensed traffic*
13 *engineers from affected public agencies that have jurisdiction over*
14 *segments of the route or routes under review in order to ensure*
15 *coordination with all affected state and local public road agencies*
16 *that may potentially be impacted due to the operation of a 45-foot*
17 *bus with a front-mounted bicycle rack.*

18 (3) (A) *By unanimous vote of all members, the committee shall*
19 *make a determination of the routes that are suitable for the safe*
20 *operation of a 45-foot bus that is equipped with a front-mounted*
21 *bicycle rack.*

22 (B) *Before conducting a vote pursuant to subparagraph (A),*
23 *the committee shall obtain certification approved by a licensed*
24 *traffic engineer that all proposed routes are safe for travel by*
25 *45-foot buses equipped with the bicycle racks specified in*
26 *subdivision (a).*

27 (4) *Upon any proposal to make substantive changes to additions*
28 *to approved routes, those changes shall be subject to review and*
29 *certification pursuant to paragraph (2) prior to being approved*
30 *by the committee.*

31 (5) *The members of the committee shall be selected not more*
32 *than 30 days after receipt of the district’s proposal to equip a*
33 *45-foot bus with a front-mounted bicycle rack and shall be*
34 *comprised of the following members:*

35 (A) *One member from the district who shall be appointed by*
36 *the district’s general manager and who shall be a voting member*
37 *of the committee.*

38 (B) *One member who is a licensed traffic engineer selected by*
39 *the governing board of the district and who shall be a voting*
40 *member of the committee.*

1 (C) One member appointed by the labor organization that is
2 the exclusive representative of the busdrivers of the district. This
3 member shall be a voting member of the committee.

4 (D) One member appointed by the governing board of the
5 district who shall be a representative of the bicycling community
6 and who shall reside within the area of the district jurisdiction.
7 This member shall be a nonvoting member of the committee.

9 (d) If a folding device is installed pursuant to subdivision (a),
10 the district shall submit a report in compliance with Section 9795
11 of the Government Code to the Assembly Committee on
12 Transportation and the Senate Committee on Transportation and
13 Housing on or before December 31, 2018. The report shall include
14 a summary of any vehicular or traffic incidents where the size of
15 the folding device was a factor, and a summary of the mobility
16 improvements that these folding devices provide.

17 SEC. 2. The Legislature finds and declares that a special law
18 is necessary and that a general law cannot be made applicable
19 within the meaning of Section 16 of Article IV of the California
20 Constitution because of the unique circumstances of a large number
21 of bicycle riders using buses operated by the Sacramento Regional
22 Transit District and the need to determine whether there are safety
23 considerations in having 40-inch bicycle racks on the front of the
24 district's buses.
