LEGISLATIVE COUNSEL'S DIGEST

AB 467, as amended, Stone. ~~Family law: adoption.~~ *Freshwater Protection Act.*

Under the Porter-Cologne Water Quality Control Act, the State Water Resources Control Board and the California regional water quality control boards are the principal state agencies with authority over matters relating to water quality. The state board and the regional boards prescribe waste discharge requirements for the discharge of waste that could affect the quality of the waters of the state. Existing law authorizes local agencies to adopt groundwater management laws that include contamination cleanup provisions.

This bill would establish the Freshwater Protection Fund in the State Treasury, under the administration of the State Water Resources Control Board, and would provide that money in the fund at the close of the fiscal year shall remain in the fund and shall not revert to the general fund. This bill would require the State Water Resources Control Board, upon appropriation, to expend money from the fund for various purposes generally relating to groundwater and water quality.

Existing law provides procedures for the adoption of an unmarried minor. Under existing law, the consent of a child is necessary to the child's adoption, if the child is over 12 years of age.

6 81100. (a) There is in the State Treasury a Freshwater
7 Protection Fund.

8 (b) The Treasurer may receive money or other assets from any
9 source for deposit into the fund, including gifts, grants, and
10 bequests.

11 (c) Moneys in the fund at the close of the fiscal year shall remain
12 in the fund and shall not revert to the General Fund.

13 (d) The board shall be the administrator of the fund for auditing
14 purposes.

15 (e) The board shall expend money from the fund, upon
16 appropriation by the Legislature, only for one or more of the
17 following purposes:

18 (1) Direct assistance.

19 (2) Indirect assistance.

20 (3) Emergency response and removal of potential sources of
21 contamination.

22 (4) Natural resource protection.

23 (5) Administrative costs. Expenditures pursuant to this
24 paragraph shall not exceed 20 percent of the annual appropriation
25 from the fund.

26 81101. (a) "Administrative costs" includes, but is not limited
27 to, costs incurred during any of the following:

28 (1) Groundwater monitoring for fertilizers.

29 (2) Development and enforcement of natural resource protection
30 rules.

2 *States Environmental Protection Agency and state programs to*
3 *protect human and environmental health.*

4 (4) *Management of fertilizer sales information.*

5 (b) *“Direct assistance” includes, but is not limited to, any of*

7 (1) *Programs that provide for alternate water supplies, including*
8 *consolidation with an existing noncontaminated water system.*

9 (2) *Programs that provide for closure of wells that may impact*
10 *groundwater, such as abandoned, improperly constructed, or*
11 *drainage wells.*

12 (3) *Programs devoted to integrated natural resources*
13 *conservation that encourage the judicious use of fertilizers and*
14 *other agricultural inputs and practices that are protective of water*
15 *quality.*

16 (4) *Programs that provide monitoring of private wells to detect*
17 *fertilizers or fertilizers with other contaminants.*

18 (5) *Programs that enhance investment of private and federal*
19 *funds in fertilizer management and remediation for freshwater*
20 *protection.*

21 (6) *Programs that provide verification of actions taken pursuant*
22 *to this section.*

23 (7) *Other programs established pursuant to this division.*

24 (c) *“Indirect assistance” includes, but is not limited to, any of*
25 *the following:*

26 (1) *Programs that provide education about fertilizers and*
27 *fertilizer management.*

28 (2) *Programs that provide technical assistance on fertilizers*
29 *and fertilizer management.*

30 (3) *Programs that provide for the promotion and implementation*
31 *of onsite evaluation systems and freshwater protection practices.*

32 (4) *Research programs for the determination of the impacts of*
33 *alternate management practices.*

35 *resources sensitivity and vulnerability to contamination.*
