An act to amend Sections 23986, 24013, and 24014 of, ~~and to add and repeal Section 23059 of,~~ the Business and Professions Code, relating to alcoholic beverages.

LEGISLATIVE COUNSEL'S DIGEST

AB 593, as amended, Quirk. Alcoholic beverages: Department of Alcoholic Beverage Control.

(1) The Alcoholic Beverage Control Act is administered by the Department of Alcoholic Beverage Control and requires the department to perform various duties relating to the issuance of alcoholic beverage licences.

~~This bill would require the department to evaluate its onsite license review process for restaurants in order to implement a more expedited licensing process. This bill would also require the department to prepare and submit a report to the Legislature, on or before December 31, 2015, relating to the review.~~

(2) ~~The~~

The Alcoholic Beverage Control Act requires specified applicants for on-sale or off-sale licensees to have a notice of the application published, as provided.

This bill would exempt from that requirement applicants that are required to provide specified notices via mail of applications for licenses, including retail licenses, and transfer of licenses, as provided.

(2) Existing law provides that protests against the issuance of a liquor license may be filed with the department. Existing law permits the Department of Alcoholic Beverage Control to reject protests, except protests made by a public agency, public official, or governing body of a city or county, it determines to be false, vexatious, or without reasonable or probable cause.

This bill would ~~permit the department to reject protests, except protests made by a public agency, public official, or governing body of a city or county, it determines are invalid or unreasonable, as described require the department, by January 1, 2016, to promulgate regulations regarding responding to protests filed under these provisions.~~ The bill would also require a protest submitted by a person other than an employee of the department or a public officer to be submitted by an individual and limit the protest to one signatory.

5 notice of the application, giving the name or names of the applicant
6 and the premises where the business is to be conducted, to be
7 published pursuant to Section 6061 of the Government Code in a
8 newspaper of general circulation, other than a legal or professional
9 trade publication, in the city in which the premises are situated, or
10 if the premises are not in a city, the publication shall be made in
11 a newspaper of general circulation nearest the premises where the
12 business is to be conducted. The form of the notice shall be
13 prescribed by the department. Affidavit of publication shall be
14 filed with the department prior to the issuance of any license. The
15 department shall adopt rules and regulations to enforce the
16 provisions of this section.

17 (b) Any applicant for an on-sale or off-sale license at a premises
18 which is located in a census tract which has an undue concentration

36 24013. (a) Protests may be filed at any office of the department
37 within 30 days from the first date of posting the notice of intention
38 to engage in the sale of alcoholic beverages at the premises, within
39 30 days of the mailing of the notification pursuant to Section
40 23985.5, or within 30 days of the mailing of the notices of the

1 department to public officials as required by Section 23987,
 2 whichever is later. The time within which a local law enforcement
 3 agency may file a protest shall be extended by the period prescribed
 4 in Section 23987, pursuant to a request made under that section.

5 (b) (1) The department may reject protests, except protests
 6 made by a public agency or public official or protests made by the
 7 governing body of a city or county, if it determines the protests
 8 are false, vexatious, frivolous, invalid or unreasonable, or without
 9 reasonable or probable cause at any time before hearing thereon,
 10 notwithstanding Section 24016 or 24300. If, after investigation,
 11 the department recommends that a license be issued
 12 notwithstanding a protest by a public agency, a public official, or
 13 the governing body of a city or county, the department shall notify
 14 the agency, official, or governing body in writing of its
 15 determination and the reasons therefor, in conjunction with the
 16 notice of hearing provided to the protestant pursuant to Section
 17 11509 of the Government Code. If the department rejects a protest
 18 as provided in this section and issues a license, a protestant whose
 19 protest has been rejected may, within 10 days after the issuance
 20 of the license, file an accusation with the department alleging the
 21 grounds of protest as a cause for revocation of the license and the
 22 department shall hold a hearing as provided in Chapter 5
 23 (commencing with Section 11500) of Part 1 of Division 3 of Title
 24 2 of the Government Code.
