An act to amend Section 2872.2 of the Business and Professions Code, relating to vocational nursing.

LEGISLATIVE COUNSEL'S DIGEST

AB 1028, as introduced, Patterson. Vocational nursing: interim permits.

Existing law, the Vocational Nursing Practice Act, provides for the licensure and regulation of the practice of licensed vocational nursing by the Board of Vocational Nursing and Psychiatric Technicians. Existing law requires an applicant for a vocational nurse license to have successfully completed specified courses of studies from a school accredited by the board, and provides for the issuance of a license upon successful completion of a written examination, among other criteria. Existing law provides that if the application for licensure by examination is received by the board no later than 4 months after completion of a board-approved nursing program and approval of the application, the board may issue an interim permit authorizing the applicant to practice vocational nursing pending the results of the first licensing examination, or for a period of 9 months, whichever occurs first.

This bill would require the board to make a decision whether to issue the interim permit, and, if the board decides to issue the permit, issue the interim permit to the applicant within 30 days of receiving the completed application.

17 (c) *If the applicant passes the examination, the interim permit*
18 *shall remain in effect until an initial license is issued by the board*
19 *or for a maximum period of six months after passing the*
20 *examination, whichever occurs first. If the applicant fails the*
21 *examination, the interim permit shall terminate upon notice by*
22 *certified mail, return receipt requested, or if the applicant fails to*
23 *receive the notice, upon the date specified in the interim permit,*
24 *whichever occurs first.*

26 (d) *A permittee shall function under the supervision of a licensed*
27 *vocational nurse or a registered nurse, who shall be present and*
28 *available on the premises during the time the permittee is rendering*
29 *professional services. The supervising licensed vocational nurse*
30 *or registered nurse may delegate to the permittee any function*
31 *taught in the permittee’s basic nursing program.*

33 (e) *An interim permittee shall not use any title or designation*
34 *other than vocational nurse interim permittee or “V.N.I.P.”*
