LEGISLATIVE COUNSEL'S DIGEST

AB 1217, as amended, Lowenthal. ~~Home Care Services Consumer Protection Act of 2013.~~ *Home Care Services Consumer Protection Act.*

Existing law provides for the In-Home Supportive Services (IHSS) program, a county-administered program under which qualified aged, blind, and disabled persons receive services enabling them to remain in their own homes. The IHSS program includes various eligibility requirements for individuals who provide services to recipients under

the program. Under existing law, a private provider of in-home care services is not subject to the requirements of the IHSS program.

Existing law provides for the licensing and regulation of various community care facilities by the State Department of Social Services.

This bill would enact the Home Care Services Consumer Protection Act, which would provide, on and after January 1, 2015, for the licensure and regulation of home care organizations, as defined, by the State Department of Social Services, and the registration of home care aides. The bill would exclude specified entities from the definition of a home care organization and would not include certain types of individuals as home care aides for the purposes of these provisions.

This bill would require the department to establish and continuously update a home care aid registry, which would include specified information relating to home care aid applicants and registered home care aides. This bill would require background clearances for home care aides, as prescribed, and would set forth specific duties of the home care organization, the department, and the Department of Justice in this regard. The bill would require a home care aide applicant to submit to the Department of Justice a signed declaration under penalty of perjury regarding any prior criminal convictions. The bill would require home care aides to demonstrate they are free of active tuberculosis.

The bill would require the department to impose various fees to be deposited in the Home Care Aide Fund to be created by this bill. This bill, in addition, would prescribe enforcement procedures, fines, and penalties for violations of the act by a home care organization or a home care aide. The bill would require any fines and penalties collected under these provisions to be deposited into the Home Care Penalties subaccount within the Home Care Fund to be created by this bill.

This bill would provide that it is a misdemeanor for a person to falsely represent or present himself or herself as a home care aide applicant or registered home care aide. The bill would also provide that any person who violates these provisions or willfully or repeatedly violated a rule or regulation promulgated under these provisions is guilty of a misdemeanor. Because this bill creates new crimes, this bill imposes a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

~~This bill would enact the Home Care Services Consumer Protection Act of 2013, which would provide, on and after July 1, 2014, for the licensure and regulation of home care organizations, as defined, by the State Department of Social Services, and the certification of home care aides. The bill would exclude specified entities from the definition of a home care organization. The bill would impose various licensure requirements on a home care organization. The bill would also impose a civil penalty on an individual or entity that operates a home care organization without a license, except as specified. The bill would require a home care organization to provide a client with specified information before arranging for the provision of home care services, as defined, to that client, including, but not limited to, the types and hours of available home care services, and the extent to which payment may be expected from specified sources. In addition, this bill would require a home care organization, among other things, to distribute to the client its advance directive policy and provide a written notice to the client of certain rights. The bill would also prohibit a home care organization from hiring an individual as a home care aide unless that individual meets certain requirements, including, but not limited to, demonstrating that he or she has specified language skills and providing proof of certification as a home care aide, as specified.~~

~~The bill would require certain employment agencies to maintain liability insurance, as specified, and ensure that any person it refers to provide home care services has been certified prior to the referral.~~

~~This bill would require background clearances for home care aides, as prescribed, and would set forth specific duties of the home care organization, the department, and the Department of Justice in this regard. The bill would require home care aides to demonstrate they are free of active tuberculosis. The bill would also require a home care~~

organization to conduct regular evaluations of its home care aides, as specified. The bill would require the department to impose various fees to be deposited in the Home Care Organization and Home Care Aide Fund to be created by this bill. This bill, in addition, would prescribe enforcement procedures, fines, and penalties for violations of the act by a home care organization or a home care aide and violations of specified requirements by an employment agency, as defined.

This bill would specify that the provisions do not supersede local laws regulating home care organizations and home care services, including licensing, reporting, registration, and providing for civil penalties.

6 Article 1. General Provisions

8 1796.10 This chapter shall be known, and may be cited, as the
9 Home Care Services Consumer Protection Act.

10 1796.11. The State Department of Social Services shall
11 administer and enforce this chapter.

12 1796.12. For purposes of this chapter, the following definitions
13 shall apply:

14 (a) "Affiliated home care aide" means an individual, 18 years
15 of age or older, who is employed by a home care organization to
16 provide home care services to a client and is listed on the home
17 care aide registry.

18 (b) "Child" or "children" means an individual or individuals
19 under 18 years of age.

20 (c) "Client" means an individual who receives home care
21 services from a registered home care aide.

22 (d) "Department" means the State Department of Social
23 Services.

24 (e) "Director" means the Director of Social Services.

- 1 (f) “Family member” means any spouse, by marriage or
2 otherwise, child or stepchild, by natural birth or by adoption,
3 parent, brother, sister, half-brother, half-sister, parent-in-law,
4 brother-in-law, sister-in-law, nephew, niece, aunt, uncle, first
5 cousin, or any person denoted by the prefix “grand” or “great,”
6 or the spouse of any of these persons, even if the marriage has
7 been terminated by death or dissolution.
- 8 (g) “Home care aide applicant” means an individual, 18 years
9 of age or older, who is requesting to become an registered home
10 care aide and the department has received and is processing the
11 individual’s complete home care aide application and fees.
- 12 (h) “Home care aide application” means the official form,
13 designated by the department, to request to become a registered
14 home care aide.
- 15 (i) “Home care aide registry” means a department-established
16 and department maintained Internet Web site of registered home
17 care aides and home care aide applicants, which includes all of
18 the following: the individual’s name, registration number,
19 registration status, registration expiration date, and, if applicable,
20 the home care organization to which the affiliated home care aide
21 or affiliated home care aide applicant is associated.
- 22 (j) “Home care organization” means an individual, 18 years
23 of age or older, firm, partnership, corporation, limited liability
24 company, joint venture, association, or other entity that arranges
25 for home care services by an affiliated home care aide to a client,
26 and is licensed pursuant to this chapter.
- 27 (k) “Home care organization application” means the official
28 form, designated by the department, to request to become a licensed
29 home care organization.
- 30 (l) “Home care organization licensee” means an individual, 18
31 years of age or older, firm, partnership, corporation, limited
32 liability company, joint venture, association, or other entity having
33 the authority and responsibility for the operation of a licensed
34 home care organization.
- 35 (m) “Home care services” means nonmedical services and
36 assistance provided by a registered home care aide to a client
37 who, because of advanced age or physical or mental disability,
38 cannot perform these services. These services enable the client to
39 remain in his or her residence and include, but are not limited to,
40 assistance with the following: bathing, dressing, feeding,

1 *exercising, personal hygiene and grooming, transferring,*
 2 *ambulating, positioning, toileting and incontinence care, assisting*
 3 *with medication that the client self-administers, housekeeping,*
 4 *meal planning and preparation, laundry, transportation,*
 5 *correspondence, making telephone calls, shopping for personal*
 6 *care items or groceries, and companionship. This subdivision shall*
 7 *not authorize a registered home care aide to assist with medication*
 8 *that the client self-administers that would otherwise require*
 9 *administration or oversight by a licensed health care professional.*

10 (n) *“Registered home care aide” means an affiliated home care*
 11 *aide or independent home care aide, 18 years of age or older, who*
 12 *is listed on the home care aide registry.*

13 (o) *“Independent home care aide” means an individual, 18*
 14 *years of age or older, who is not employed by a home care*
 15 *organization, but who is listed on the home care aide registry and*
 16 *is providing home care services through a direct agreement with*
 17 *a client.*

Article 2. Registry and Exemptions

21 *1796.14. (a) Individuals who are not employed by a home care*
 22 *organization but who provide home care services to a client may*
 23 *be listed on the home care aide registry.*

24 (b) *An affiliated home care aide shall be listed on the home care*
 25 *aide registry prior to providing home care services to a client.*

26 (c) *Any registered home care aide providing home care services*
 27 *to a child shall also obtain a Child Abuse Central Index check, as*
 28 *set forth in paragraph (2) of subdivision (a) of Section 1796.19,*
 29 *unless the individual is exempt.*

30 (d) *Any registered home care aide who, after being placed on*
 31 *the home care registry, will provide home care services to a child,*
 32 *shall obtain a Child Abuse Central Index check, as set forth in*
 33 *paragraph (2) of subdivision (a) of Section 1796.19, unless the*
 34 *individual is exempt.*

35 (e) *An individual providing home care services to a child is*
 36 *exempt from any requirement to be listed on the home care aide*
 37 *registry if the individual is one of the following:*

38 (1) *A family member of the child.*

39 (2) *A guardian of the child.*

40 (3) *A conservator of the child.*

- 1 (4) A foster parent of the child, in a foster family home, as
2 defined in paragraph (5) of subdivision (a) of Section 1502, or a
3 certified family home, as defined in subdivision (d) of Section 1506.
- 4 (5) Nonrelative extended family member, as defined in Section
5 362.7 of the Welfare and Institutions Code.
- 6 (6) Providing home care services in a facility in which only
7 Indian children who are eligible under the federal Indian Child
8 Welfare Act (25 U.S.C. 1901 et seq.) are placed and is one of the
9 following:
- 10 (A) An extended family member of the Indian child, as defined
11 in Section 1903 of Title 25 of the United States Code.
- 12 (B) A foster home that is licensed, approved, or specified by the
13 Indian child's tribe pursuant to Section 1915 of Title 25 of the
14 United States Code.
- 15 (7) Providing home care services as part of his or her job duties
16 through one of the following entities:
- 17 (A) A home health agency licensed under Chapter 8
18 (commencing with Section 1725).
- 19 (B) A hospice licensed under Chapter 8.5 (commencing with
20 Section 1745).
- 21 (C) A health facility licensed under Chapter 2 (commencing
22 with Section 1250).
- 23 (D) Any clinic licensed under Sections 1204 or 1204.1.
- 24 (E) A county providing in-home supportive services pursuant
25 to Article 7 (commencing with Section 12300) of Chapter 3 of Part
26 3 of Division 9 of the Welfare and Institutions Code, without regard
27 to whether the county provides these services as a public authority
28 or through a nonprofit consortium established pursuant to Section
29 12301.6 of the Welfare and Institutions Code.
- 30 (F) A home medical device retail facility licensed under Section
31 111656.
- 32 (G) An organization vendored or contracted through a regional
33 center or the State Department of Developmental Services pursuant
34 to the Lanterman Developmental Disabilities Services Act (Division
35 4.5 (commencing with Section 4500) of the Welfare and Institutions
36 Code) and the California Early Intervention Services Act (Title
37 14 (commencing with Section 95000) of the Government Code) to
38 provide services and supports for persons with developmental
39 disabilities, as defined in Section 4512 of the Welfare and
40 Institutions Code, when funding for those services is provided

1 through the State Department of Developmental Services and more
2 than 50 percent of the recipients of the home care services provided
3 by the organization are persons with developmental disabilities.

4 (H) A community care facility as licensed under Chapter 3
5 (commencing with Section 1500), a residential care facility for
6 persons with special health care needs licensed under Chapter
7 3.01 (commencing with Section 1568.01), a residential care facility
8 for the elderly licensed under Chapter 3.2 (commencing with
9 Section 1569), or a child day care licensed under Chapter 3.4
10 (commencing with Section 1596.70).

11 (I) Any alcoholism or drug abuse recovery or treatment facility
12 as defined by Section 11834.02.

13 (J) Any other entity providing services similar to those described
14 in this paragraph, as determined by the director.

15 (8) Providing services authorized pursuant to Section 2731 of
16 the Business and Professions Code

17 (f) (1) Home care aides shall not include individuals who are
18 providing home care services as part of their job duties through
19 one of the following entities:

20 (A) Services authorized to be provided by a licensed home health
21 agency under Chapter 8 (commencing with Section 1725).

22 (B) Services authorized to be provided by a licensed hospice
23 pursuant to Chapter 8.5 (commencing with Section 1745).

24 (C) Services authorized to be provided by a licensed health
25 facility pursuant to Chapter 2 (commencing with Section 1250).

26 (D) In-home supportive services provided pursuant to Article
27 7 (commencing with Section 12300) of Chapter 3 of Part 3 of
28 Division 9 of the Welfare and Institutions Code.

29 (E) Services authorized to be provided by one of the following:

30 (i) A licensed residential care facility for the elderly pursuant
31 to Chapter 3.2 (commencing with Section 1569).

32 (ii) A licensed community care facility pursuant to Chapter 3
33 (commencing with Section 1500).

34 (iii) A licensed residential care facility for persons with chronic
35 life-threatening illness pursuant to Chapter 3.01 (commencing
36 with Section 1568.01).

37 (iv) A licensed facility, pursuant to the California Child Day
38 Care Act (Chapter 3.4 (commencing with Section 1596.70)), which
39 includes day care centers under Chapter 3.5 (commencing with

1 Section 1596.90) and family day care homes under to Chapter 3.6
2 (commencing with Section 1597.30).

3 (2) Home care aides shall not include individuals providing
4 services authorized to be provided pursuant to Section 2731 of the
5 Business and Professions Code.

6 1796.15. This chapter shall not prohibit an individual from
7 employing an individual not listed on the home care aide registry
8 to provide home care services. The department shall have
9 responsibility only for the maintenance of the home care aide
10 registry regarding registered home care aides.

11 1796.16. A registered home care aide may provide home care
12 services to more than one child for a family, but may not provide
13 home care services for a child or children from more than one
14 family at the same time. This section shall not preclude a registered
15 home care aide from providing home care services for a child or
16 children of multiple families at different times. This chapter shall
17 not override provisions of the California Child Day Care Act
18 (Chapter 3.4 (commencing with Section 1596.70)), Chapter 3.5
19 (commencing with Section 1596.90), and Chapter 3.6 (commencing
20 with Section 1597.30).

21 1796.17. A home care organization shall not include the
22 following:

23 (a) A home health agency licensed under Chapter 8
24 (commencing with Section 1725).

25 (b) A hospice licensed under Chapter 8.5 (commencing with
26 Section 1745).

27 (c) A health facility licensed under Chapter 2 (commencing with
28 Section 1250).

35 (e) A home medical device retail facility licensed under Section

40 4.5 (commencing with Section 4500) of the Welfare and Institutions

1 Code) and the California Early Intervention Services Act (Title

 4 disabilities, as defined in Section 4512 of the Welfare and
 5 Institutions Code, when funding for those services is provided

 14 Chapter 3.2 (commencing with Section 1569).

15 (i) A community care facility licensed under Chapter 3
 16 (commencing with Section 1500), or a residential care facility for
 17 persons with chronic life-threatening illness licensed under
 18 Chapter 3.01 (commencing with Section 1568.01).

19 (j) An person or organization performing activities that fall
 20 under the jurisdiction of a child day care facility licensed under
 21 Chapter 3.4 (commencing with Section 1596.70), a day care center
 22 licensed under Chapter 3.5 (commencing with Section 1596.60),
 23 or a family day care home licensed under Chapter 3.6
 24 (commencing with Section 1597.30).

Article 3. Home Care Aide Applicants

28 1796.19. (a) The department shall consider, but is not limited
 29 to, the following when determining whether to approve a
 30 registration application:

31 (1) Evidence satisfactory to the department of the ability of the
 32 independent home care aide applicant or the affiliated home care
 33 aide applicant to comply with this chapter and the rules and
 34 regulations promulgated under this chapter by the department.

35 (2) Evidence satisfactory to the department that the independent
 36 home care aide applicant or the affiliated home care aide applicant
 37 is of reputable and responsible character. The evidence shall
 38 include, but is not limited to, a review of the independent home
 39 care aide applicant's or the affiliated home care aide applicant's
 40 criminal offender record information pursuant to Section 1522. If

1 *home care services are to be provided to a child by an affiliated*
2 *home care aide, the evidence shall also include a review of the*
3 *Child Abuse Central Index pursuant to Section 1522.1. If home*
4 *care services are to be provided to a child by an independent home*
5 *care aide and the aide elects to be subject to a Child Abuse Central*
6 *Index review, the evidence shall also include a review of the Child*
7 *Abuse Central Index pursuant to Section 1522.1.*

8 (3) *Disclosure of any revocation or other disciplinary action*
9 *taken, or in the process of being taken, related to the care of*
10 *individuals against the independent home care aide applicant or*
11 *the affiliated home care aide applicant.*

12 (4) *A signed statement that the independent home care aide*
13 *applicant or the affiliated home care aide applicant has read and*
14 *understood this chapter and any rules and regulations promulgated*
15 *under this chapter by the department.*

16 (5) *Any other information that may be required by the*
17 *department for the proper administration and enforcement of this*
18 *chapter.*

19 (b) *Failure of the home care aide applicant to cooperate with*
20 *the department in the completion of the Home Care Aide*
21 *application shall result in the withdrawal of the registration*
22 *application. "Failure to cooperate" means that the information*
23 *described in this chapter and by any rules and regulations*
24 *promulgated under this chapter has not been provided, or has not*
25 *been provided in the form requested by the department, or both.*

29 1796.21. *A registered home care aide shall be 18 years of age*
30 *or older.*

31 1796.22. *Any individual who has submitted an application and*
32 *who possesses any one of the following identification cards may*
33 *initiate a background examination to be a registered home care*
34 *aide:*

35 (a) *A valid California driver's license.*

36 (b) *A valid identification card issued by the Department of Motor*
37 *Vehicles.*

38 (c) *A valid Alien Registration Card.*

1 (d) *In the case of a person living in a state other than California,*
2 *a valid numbered photo identification card issued by an agency*
3 *of the state other than California.*

4 1796.23. (a) *Each person initiating a background examination*
5 *to be a registered home care aide shall submit his or her*
6 *fingerprints to the Department of Justice by electronic transmission*
7 *in a manner approved by the State Department of Social Services,*
8 *unless exempt under subdivision (d). Each person initiating a*
9 *background examination to be a registered home care aide shall*
10 *also submit to the State Department of Social Services a signed*
11 *declaration under penalty of perjury regarding any prior criminal*
12 *convictions pursuant to Section 1522 and a completed home care*
13 *aide application.*

14 (b) *A law enforcement agency or other local agency authorized*
15 *to take fingerprints may charge a reasonable fee to offset the costs*
16 *of fingerprinting for the purposes of this chapter.*

17 (c) *The Department of Justice shall use the fingerprints to search*

24 *provider need not submit fingerprints to the State Department of*
25 *Social Services and may transfer his or her current criminal record*
26 *clearance or exemption pursuant to paragraph (1) of subdivision*
27 *(h) of Section 1522. The person shall instead submit to the State*
28 *Department of Social Services, along with the person's registration*
29 *application, a copy of the person's identification card described*

32 1796.24. (a) (1) *The department shall establish a home care*
33 *aide registry pursuant to this chapter and shall continuously update*
34 *the registry information. Upon submission of the home care aid*
35 *application and fingerprints or other identification documents*
36 *pursuant to Section 1796.23, the department shall enter into the*
37 *home care aide registry the person's name, identification number,*
38 *and an indicator that the person has submitted a home care aide*
39 *application and fingerprints or identification documentation. This*
40 *person shall be known as a "home care aide applicant."*

1 (2) A person shall not be entitled to apply to be a registered
2 home care aide and shall have his or her registration application
3 returned without the right to appeal if the person would not be
4 eligible to obtain a license pursuant to Section 1558.1.

5 (b) (1) Before approving an individual for registration, the
6 department shall check the individual's criminal history pursuant
7 to Section 1522. Upon completion of the searches of the state
8 summary criminal offender record information and the records of
9 the Federal Bureau of Investigation, the applicant shall be issued
10 a criminal record clearance or granted a criminal record
11 exemption if grounds do not exist for denial pursuant to Section
12 1522. The department shall enter that finding in the person's
13 record in the home care aide registry and shall notify the person
14 of the action. This person shall be known as an "independent home
15 care aide" or an "affiliated home care aide." If the applicant
16 meets all of the conditions for registration, except receipt of the
17 Federal Bureau of Investigation's criminal offender record
18 information search response, the department may issue a clearance
19 if the applicant has signed and submitted a statement that he or
20 she has never been convicted of a crime in the United States, other
21 than a minor traffic violation. If, after approval, the department
22 determines that the registrant has a criminal record, registration
23 may be revoked pursuant to Section 1796.26.

24 (2) For purposes of compliance with this section, the department
25 may permit an applicant to request the transfer of a current
26 criminal record clearance or exemption for a licensed care facility
27 issued by the department or a county with delegated licensing
28 authority. A signed criminal record clearance or exemption
29 transfer request shall be submitted to the department and shall
30 include a copy of the person's driver's license or valid
31 identification card issued by the Department of Motor Vehicles,
32 or a valid photo identification issued by another state or the United
33 States government if the person is not a California resident. Upon
34 request of the licensee, who shall enclose a self-addressed envelope
35 for this purpose, the State Department of Social Services shall
36 verify whether the individual has a clearance or exemption that
37 can be transferred pursuant to the requirements of this chapter.

38 (3) The State Department of Social Services shall hold criminal
39 record clearances and exemptions in its active files for a minimum

1 of three years after the individual is no longer on the registry in
2 order to facilitate a transfer request.

3 1796.25 (a) (1) If the department finds that the home care
4 aide applicant or the registered home care aide has been convicted
5 of a crime, other than a minor traffic violation, the department
6 shall deny the home care aide application, or revoke the registered
7 home care aide's registration unless the director grants an
8 exemption pursuant to subdivision (g) of Section 1522.

9 (2) If the department finds that the independent home care aide
10 applicant, the independent home care aide, the affiliated home
11 care aide applicant, or the affiliated home care aide has an arrest
12 as described in subdivision (a) of Section 1522, the department
13 may deny the registration application or registration renewal
14 application, or revoke the registered home care aide's registration,
15 if the independent home care aide applicant, independent home
16 care aide, affiliated home care aide applicant, or affiliated home
17 care aide may pose a risk to the health and safety of any person
18 who is or may become a client and the department complies with
19 subdivision (e) of Section 1522.

20 (3) The department may deny the home care aide application
21 or the renewal application of a registered home care aide if the
22 department discovers that it had previously revoked a license or
23 certificate of approval to be a certified family home, a certified
24 administrator, or a registered TrustLine provider held by the home
25 care aide applicant or registered home care aide, or that it had
26 excluded the home care aide applicant or registered home care
27 aide from a licensed facility.

28 (4) The department may deny the home care aide application
29 or registered home care aide registration renewal application, for
30 placement or retention upon the home care aide registry or revoke
31 the registered home care aide's registration if the department
32 discovers that it had previously denied the home care aide
33 applicant's or registered home care aide's application for a license
34 from the department or certificate of approval to be a certified
35 family home, a certified administrator, or a registered TrustLine
36 provider.

37 (b) (1) If the department revokes or denies a home care aide
38 application or registered home care aide's renewal application
39 pursuant to subdivision (a), the department shall advise the home
40 care aide applicant or registered home care aide of the right to

1 *appeal. The home care aide applicant or registered home care*
2 *aide shall have 15 days to appeal the denial or revocation.*

3 *(2) Upon receipt by the department of the appeal, the appeal*
4 *shall be set for hearing. The hearing shall be conducted in*
5 *accordance with Section 1551.*

6 *(c) If the home care aide application or registered home care*
7 *aide renewal application has been denied, the home care aide*
8 *applicant or registered home care aide shall not reapply until he*
9 *or she meets the timeframe set forth by the department in*
10 *regulation, not to exceed one year.*

11 *1796.26. (a) (1) The department may revoke or deny a*
12 *registered home care aide's registration or request for registration*
13 *renewal if the registered home care aide does any of the following:*

14 *(A) Procures or attempts to procure his or her registered home*
15 *care aide registration or renewal by fraud or misrepresentation.*

16 *(B) Knowingly makes or gives any false statement or information*
17 *in conjunction with the registered home care aide application or*
18 *renewal application.*

19 *(C) Has a criminal conviction, unless an exemption is granted*
20 *pursuant to Section 1522.*

21 *(D) Engages or has engaged in an incident of abuse or neglect*
22 *or other conduct that poses a threat to the health and safety of any*
23 *person who is or may become a client.*

24 *(E) Violates this chapter or of the rules or regulations*
25 *promulgated under this chapter.*

26 *(F) Aids, abets, or permits the violation of this chapter or of the*
27 *rules and regulations promulgated under this chapter.*

28 *(G) Engages or has engaged in conduct which is inimical to the*
29 *health, morals, welfare, or safety of the people of the state or an*
30 *individual receiving or seeking to receive home care services.*

31 *(H) Engages or has engaged in acts of financial malfeasance*
32 *concerning a client, including, but not limited to, improper use or*
33 *embezzlement of client moneys and property or fraudulent*
34 *appropriation for personal gain of client moneys and property, or*
35 *willful or negligent failure to provide services.*

36 *(2) An individual whose registered home care aide registration*
37 *has been revoked shall not reapply until he or she meets the*
38 *timeframe as set forth in Section 1558.1.*

1 (3) An individual whose registered home care aide criminal
2 record exemption has been denied shall not reapply for two years
3 from the date of the exemption denial.

4 (4) The hearing to revoke or deny the registered home care aide
5 registration or registration renewal request shall be conducted in
6 accordance with Section 1551.

7 (b) (1) The registered home care aide's registration shall be
8 considered forfeited under the following conditions:

9 (A) The registered home care aide has had a license or
10 certificate of approval revoked, suspended, or denied as authorized
11 under Section 1534, 1550, 1568.082, 1569.50, or 1596.885.

12 (B) The registered home care aide has been denied employment,
13 residence, or presence in a facility or client's home based on action
14 resulting from an administrative hearing pursuant to Section 1558,
15 1568.092, 1569.58, or 1596.8897.

16 (C) The registered home care aide fails to maintain a current
17 mailing address with the department.

18 (D) The registered home care aide's registration is not renewed.

19 (E) The registered home care aide surrenders his or her
20 registration to the department.

21 (F) The registered home care aide dies.

22 (2) An individual whose registered home care aide registration
23 has been forfeited shall not reapply until he or she meets the
24 timeframe set forth by the department in Section 1558.1.

25 (c) A registered home care aide's registration shall not be
26 transferred or sold to another individual or entity.

27 1796.28. (a) The Department of Justice shall maintain and
28 continually update pertinent criminal offender record information
29 of registered home care aides and shall inform the department of
30 subsequent reports received pursuant to Section 11105.2 of the
31 Penal Code. The department shall continually update the home
32 care aide registry pursuant to the actions required in this chapter.

33 (1) Registered home care aides and home care aide applicants
34 shall maintain a current mailing address with the department.

35 (2) Registered home care aides and home care aide applicants
36 shall inform the department of any new mailing address in writing
37 within 10 days of a change in address.

38 (b) Notwithstanding any other law, including Part 3
39 (commencing with Section 900) of Division 3.6 of Title 1 of the
40 Government Code, state officers or employees shall not be liable

1 *for any damages caused by their conduct pursuant to this chapter*
2 *except for intentional acts or gross negligence.*

3 *1796.29. The department shall do both of the following in the*
4 *administration of the home care aide registry:*

5 *(a) Establish and maintain on the department's Internet Web*
6 *site the registry of registered home care aides and home care aide*
7 *applicants.*

8 *(1) To expedite the ability of a consumer to search and locate*
9 *a registered home care aide or home care aide applicant, the*
10 *Internet Web site shall enable consumers to look up the registration*
11 *status by providing the registered home care aide's or home care*
12 *aide applicant's name, registration number, registration status,*
13 *registration expiration date, and Child Abuse Central Index status,*
14 *if applicable.*

15 *(2) The Internet Web site shall not provide any additional,*
16 *individually identifiable information about a registered home care*
17 *aide or home care aide applicant. The department may request*
18 *and may maintain additional information for registered home care*
19 *aides or home care aide applicants, as necessary for the*
20 *administration of this chapter, which shall not be publicly available*
21 *on the home care aide registry.*

22 *(b) Update the home care registry upon receiving notification*
23 *from a home care organization that an affiliated home care aide*
24 *is no longer employed by the home care organization.*

25

26

Article 5. Renewal

27

28 *1796.31. (a) To remain on the home care aide registry, a*
29 *registered home care aide shall renew his or her registration every*
30 *two years.*

31 *(1) A registered home care aide's registration shall expire every*
32 *two years, on the anniversary date of the initial registration date.*
33 *If the registration is not renewed on or prior to its expiration date,*
34 *the registration shall be forfeited pursuant to subdivision (b) of*
35 *Section 1796.26.*

36 *(2) To renew a registration, the registered home care aide shall,*
37 *on or before the registration expiration date, request renewal by*
38 *submitting to the department the registration renewal application*
39 *form and paying the registration renewal application fee in the*
40 *amount determined by the department.*

1 (b) *Renewal of a registered home care aide’s registration is*
 2 *conditioned on compliance with all of the following:*

3 (1) *Submitting a complete registration renewal application form*
 4 *and payment of fees, both of which shall be postmarked on or*
 5 *before the expiration of the registration.*

6 (2) *Continuing to satisfy the requirements set forth in this*
 7 *chapter.*

8 (3) *Cooperating with the department in the completion of the*
 9 *renewal process. Failure of the registered home care aide to*
 10 *cooperate shall result in the withdrawal of the registration renewal*
 11 *application by the department. For purposes of this section, a*
 12 *failure to cooperate means that the information described in this*
 13 *chapter and in any rules and regulations promulgated under this*
 14 *chapter has not been provided, or has not been provided in the*
 15 *form requested by the department, or both.*

16 (c) *A revoked registered home care aide’s registration is subject*
 17 *to expiration as provided for in this section. If reinstatement of*
 18 *the registered home care aide’s registration is approved by the*
 19 *department, the individual, as a condition precedent to*
 20 *reinstatement, shall pay a fee in an amount equal to the renewal*
 21 *fee accrued at the time of its revocation.*

22

23 *Article 6. Licensure of Home Care Organizations*

24

25 1796.33. *Any individual who has submitted an application and*
 26 *who possesses any one of the following identification cards may*
 27 *initiate a background examination to be a licensed home care*
 28 *organization:*

29 (a) *A valid California driver’s license.*

30 (b) *A valid identification card issued by the Department of Motor*
 31 *Vehicles.*

32 (c) *A valid Alien Registration Card.*

33 (d) *In the case of a person living in a state other than California,*
 34 *a valid numbered photo identification card issued by an agency*
 35 *of the state other than California.*

36 1796.34. *In order to obtain a home care organization license,*
 37 *the following individual or individuals shall consent to the*
 38 *background examination described in Section 1796.23:*

39 (a) *The owner or owners of the home care organization, if the*
 40 *owners are individuals.*

1 (b) If the owner of a home care organization is a corporation,
2 limited liability company, joint venture, association, or other entity,
3 an individual having a 10-percent or greater interest in that entity.

4 1796.35. (a) A person or a private or public organization,
5 with the exception of a county providing in-home supportive
6 services pursuant to Article 7 (commencing with Section 12300)
7 of Chapter 3 of Part 3 of Division 9 of the Welfare and Institutions
8 Code, and the exceptions provided for in subdivision (b), shall not
9 do any of the following, unless it is licensed under this chapter:

10 (1) Represent himself, herself or itself to be a home care
11 organization by name, advertising, soliciting, or any other
12 presentments to the public, or in the context of services within the
13 scope of this chapter, imply that he, she, or it is licensed to provide
14 those services or to make any reference to employee bonding in
15 relation to those services.

16 (2) Use the terms “home care organization,” “home care,”
17 “in-home care,” or any combination of those terms, within its
18 name.

19 (b) This section does not apply to either of the following:

20 (1) A county providing in-home supportive services pursuant
21 to Article 7 (commencing with Section 12300) of Chapter 3 of Part
22 3 of Division 9 of the Welfare and Institutions Code.

23 (2) An employment agency, as defined in Section 1812.5095 of
24 the Civil Code, that procures, offers, refers, provides, or attempts
25 to provide an affiliated home care aide who provides home care
26 to clients.

27 1796.36. (a) Subject to the exceptions set forth in Section
28 1796.17, an individual, partnership, corporation, limited liability
29 company, joint venture, association, or other entity shall not
30 arrange for the provision of home care services by a registered
31 home care aide to a client in this state before obtaining a license
32 pursuant to this chapter. This shall be deemed “unlicensed home
33 care services.”

34 (b) Upon discovering an individual or entity is in violation of
35 subdivision (a), the department shall send a written notice of
36 noncompliance to the individual or entity and assess a civil penalty
37 of nine hundred dollars (\$900) per day for each calendar day of
38 each violation.

39 (c) Upon discovering that an individual or entity is in violation
40 of subdivision (a), the department shall send a copy of the written

1 notice of noncompliance to the individual or entity and to the
2 Attorney General or appropriate district attorney or city attorney.

3 (d) Upon receiving this notice, the Attorney General, district
4 attorney, or city attorney may do any or all of the following:

5 (1) Issue a cease and desist order, which shall remain in effect
6 until the individual or entity has obtained a license pursuant to
7 this chapter. If the individual or entity fails to comply with the
8 cease and desist order within 20 calendar days, the Attorney
9 General, district attorney, or city attorney may apply for an
10 injunction.

11 (2) Impose the civil penalty described in subdivision (b).

12 (3) Bring an action against the individual or entity under
13 Chapter 5 (commencing with Section 17200) of Part 2 of Division
14 7 of the Business and Professions Code.

15 1796.37. (a) A home care organization that has its principal
16 place of business in another state, in addition to the other
17 requirements of this chapter, before arranging for home care
18 services provided by an affiliated home care aide to a client in the
19 state, shall comply with all of the following:

20 (1) Have an office in California.

21 (2) Obtain authorization from the Secretary of State to conduct
22 business in California.

23 (3) Maintain all pertinent records of the operation in California
24 at the California office. All records shall be available to review,
25 copy, audit, and inspect by the licensing agency.

26 (b) If the home care organization is a foreign corporation,
27 foreign limited liability company, foreign limited partnership,
28 foreign association, or a foreign limited liability partnership, as
29 defined in Sections 170, 171, 171.03, 171.05, and 16101 of the
30 Corporations Code, before arranging for home care services
31 provided by an affiliated home care aide to a client in the state,
32 the home care organization shall have an office in California and
33 shall comply with both of the following:

34 (1) Register with the Secretary of State to conduct intrastate
35 business in California.

36 (2) Maintain all pertinent records of the operation in California
37 at the California office. All records shall be available to review,
38 copy, audit, and inspect by the licensing agency.

39 1796.38. The department may issue a home care organization
40 license to an individual or other entity that satisfies all of the

1 requirements set forth in this chapter, including all of the
2 following:

3 (a) Files a home care organization application, including the
4 fees required pursuant to Section 1796.49.

5 (b) Submits proof of general and professional liability insurance
6 in the amount of at least one million dollars (\$1,000,000) per
7 occurrence and three million dollars (\$3,000,000) in the aggregate.

8 (c) Submits proof of a valid workers' compensation policy
9 covering its affiliated home care aides. The proof shall consist of
10 the policy number, the effective and expiration dates of the policy,
11 and the name and address of the policy carrier.

12 (d) Provides the department, upon request, with a complete list
13 of its affiliated home care aides, and proof that each satisfies the
14 requirements of Section 1796.43.

15 (e) The owner or owners of the home care organization pass a
16 background examination, as required pursuant to Section 1796.34.

17 (f) The applicant does not have any outstanding fees or civil
18 penalties due to the department.

19 1796.39. (a) A home care organization licensee shall renew
20 the home care organization license every two years.

21 (b) Renewal shall be conditioned upon the licensee doing both
22 of the following:

23 (1) Submitting a complete home care organization licensee
24 renewal application form and payment of fees, both of which shall
25 be postmarked on or before the expiration of the license.

26 (2) Continuing to satisfy the requirements set forth in this
27 chapter, and cooperating with the department in the completion
28 of the home care organization licenses renewal process.

29 (c) Failure of the home care organization licensee to cooperate
30 may result in the withdrawal of the home care organization license
31 renewal application. "Failure to cooperate" means that the
32 information described in this chapter and in any rules and
33 regulations promulgated under this chapter has not been provided,
34 or not provided in the form requested by the department, or both.

35

36 Article 7. Home Care Organization Operating Requirements

37

38 1796.41. A home care organization licensee shall do all of the
39 following:

1 (a) Post its license and business hours in its place of business
2 in a conspicuous location, visible both to clients and affiliated
3 home care aides.

4 (b) Maintain and abide by a valid workers' compensation policy
5 covering its affiliated home care aides.

6 (c) Maintain and abide by an employee dishonesty bond,
7 including third-party coverage, with a minimum limit of ten
8 thousand dollars (\$10,000).

9 (d) Report any suspected or known adult abuse as required by
10 Section 15630 of the Welfare and Institutions Code and suspected
11 or known child abuse as required by Sections 11164 to 11174.3,
12 inclusive, of the Penal Code. A copy of each suspected abuse report
13 shall be maintained and available for review by the department
14 during normal business hours.

15 1796.42. (a) Home care organizations that employ affiliated
16 home care aides shall ensure the affiliated home care aides are
17 cleared on the home care aide registry before placing the
18 individual in direct contact with clients. In addition, the home care
19 organization shall do all of the following:

20 (1) Ensure any staff person, volunteer, or employee of a home
21 care organization who has contact with clients, prospective clients,
22 or confidential client information that may pose a risk to the
23 clients' health and safety has met the requirements of Section
24 1796.23 before being hired.

25 (2) Require home care aides to demonstrate that they are free
26 of active tuberculosis disease, pursuant to Section 1796.46.

27 (3) Immediately notify the department when the home care
28 organization no longer employs an individual as an affiliated home
29 care aide.

30 (b) This section shall not prevent a licensee from requiring a
31 criminal record clearance of any individual exempt from the
32 requirements of this section, provided that the individual has client
33 contact.

34

35 Article 8. Affiliated Home Care Aides

36

37 1796.44. (a) A home care organization licensee shall ensure
38 that prior to providing home care services, an affiliated home care
39 aide shall complete the training requirements specified in this
40 section.

1 (b) An affiliated home care aide shall complete a minimum of
2 five hours of entry-level training prior to presence with a client,
3 as follows:

4 (1) Two hours of orientation training regarding his or her role
5 as caregiver and the applicable terms of employment.

6 (2) Three hours of safety training, including basic safety
7 precautions, emergency procedures, and infection control.

8 (c) In addition to the requirements in subdivision (b), an
9 affiliated home care aide shall complete a minimum of five hours
10 of annual training. The annual training shall relate to core
11 competencies and be population specific, which shall include, but
12 not be limited to, the following areas:

13 (1) Clients' rights and safety.

14 (2) How to provide for and respond to a client's daily living
15 needs.

16 (3) How to report, prevent, and detect abuse and neglect.

17 (4) How to assist a client with personal hygiene and other home
18 care services.

19 (5) If transportation services are provided, how to safely
20 transport a client.

21 (d) The entry-level training and annual training on
22 department-approved job-related topics described in subdivisions
23 (b) and (c) may be completed through an online training program.

24 1796.45. (a) An individual hired to be an affiliated home care
25 aide on or after January 1, 2015, shall be submitted to an
26 examination 90 days prior to employment or within seven days
27 after employment to determine that the individual is free of active
28 tuberculosis disease.

29 (b) For purposes of this section, "examination" means a test
30 for tuberculosis infection that is recommended by the federal
31 Centers for Disease Control and Prevention (CDC) and that is
32 licensed by the federal Food and Drug Administration (FDA) and,
33 if that test is positive, an X-ray of the lungs. The aide shall not
34 work as an affiliated home care aide unless he or she obtains
35 documentation from a licensed medical professional that there is
36 no risk of spreading the disease.

37 (c) An affiliated home care aide whose employment with a home
38 care organization began before January 1, 2015, shall submit to
39 the examination described in subdivision (a) before July 1, 2015.

1 (d) After submitting to an examination, an affiliated home care
2 aide whose test for tuberculosis infection is negative shall be
3 required to undergo an examination at least once every two years.
4 Once an affiliated home care aide has a documented positive test
5 for tuberculosis infection that has been followed by an X-ray, the
6 examination is no longer required.

7 (e) After the examination, an affiliated home care aide shall
8 submit, and the home care organization shall keep on file, a
9 certificate from the examining practitioner showing that the
10 affiliated home care aide was examined and found free from active
11 tuberculosis disease.

12 (f) The examination is a condition of initial and continuing
13 employment with the home care organization. The affiliated home
14 care aide shall pay the cost of the examination.

15 (g) An affiliated home care aide who transfers employment from
16 one home care organization to another shall be deemed to meet
17 the requirements of subdivision (a) or (c) if the affiliated home
18 care aide can produce a certificate showing that he or she
19 submitted to the examination within the past two years and was
20 found to be free of active tuberculosis disease, or if it is verified
21 by the home care organization previously employing him or her
22 that it has a certificate on file that contains that showing.

23

24

Article 9. Revenues

25

26 1796.47. (a) (1) Administration of this program shall be fully
27 supported by fees and not civil penalties. Initial costs to implement
28 this chapter may be provided through a General Fund loan that
29 is to be repaid in accordance with a schedule provided by the
30 Department of Finance. The department shall assess fees for home
31 care organization licensure, and home care aide registration
32 related to activities authorized by this chapter. The department
33 may adjust fees as necessary to fully support the administration
34 of this chapter. Except for General Fund moneys that are otherwise
35 transferred or appropriated for the initial costs of administering
36 this chapter, or penalties collected pursuant to this chapter that
37 are appropriated by the Legislature for the purposes of this
38 chapter, no General Fund moneys shall be used for any purpose
39 under this chapter.

1 (2) A portion of moneys collected in the administration of this
2 chapter, as designated by the department, may be used for
3 community outreach consistent with this chapter.

4 (b) The Home Care Fund is hereby created within the State
5 Treasury for the purpose of this chapter. All licensure and
6 registration fees authorized by this chapter shall be deposited into
7 the Home Care Fund. Moneys in this fund shall, upon
8 appropriation by the Legislature, be made available to the
9 department for purposes of administering this chapter.

10 1796.48. (a) The department may charge an application and
11 renewal fee to become a registered home care aide and to renew
12 a registered home care aide's registration.

13 (b) The maximum fee shall not exceed the total actual costs,
14 which include, but are not limited to, of all of the following:

15 (1) The searches for criminal offender records and, if applicable,
16 Child Abuse Central Index checks performed by the Department
17 of Justice. The cost to check the criminal offender records and, if
18 applicable, child abuse information shall not subsidize the cost to
19 check the criminal or child abuse history of other persons by the
20 department who are not charged a fee by the Department of Justice.

21 (2) The cost incurred by the Department of Justice for the
22 searches of the records of the Federal Bureau of Investigation.

23 (3) The cost to the department to process the applications and
24 maintain the home care aide registry and perform the duties
25 required by this chapter and any rules and regulations promulgated
26 under this chapter.

27 (c) The fees collected shall be deposited into the Home Care
28 Fund pursuant to subdivision (b) of Section 1796.47.

29 1796.49. (a) A home care organization licensee shall pay the
30 following fees:

31 (1) A 24-month initial license fee, as prescribed by the
32 department, for a new home care organization licensee not
33 currently licensed to provide home care services in the state.

34 (2) Two-year renewal fee, as determined by the department,
35 based on the number of full-time equivalents (FTEs), including
36 paid personnel or contractors needed to oversee the enforcement
37 of this chapter.

38 (3) Other reasonable fees as prescribed by the department
39 necessary for the administration of this chapter.

1 (b) The fees collected shall be deposited into the Home Care
2 Fund pursuant to subdivision (b) of Section 1796.47.

3

4 Article 10. Complaints, Inspections, and Investigations

5

6 1796.51. In order to carry out the provisions of this chapter,
7 the department may establish procedures for the receipt,
8 investigation, and resolution of complaints against home care
9 organizations.

10 1796.52. (a) The department may review and, if it determines
11 necessary, investigate complaints filed against home care
12 organizations regarding violations of this chapter or any rules or
13 regulations promulgated under this chapter.

14 (b) The department shall verify through random, unannounced
15 inspections that a home care organization meets the requirements
16 of this chapter and the rules and regulations promulgated under
17 this chapter.

18 (c) An investigation or inspection conducted by the department
19 pursuant to this chapter may include, but is not limited to,
20 inspection of the books, records, or premises of a home care
21 organization. A home care organization's refusal to make records,
22 books, or premises available shall constitute cause for the
23 revocation of the home care organization's license.

24 (d) Other than maintaining the home care registry, the
25 department shall have no oversight responsibility regarding
26 registered home care aides.

27 1796.53. A duly authorized officer, employee, or agent of the
28 department may, upon presentation of proper identification, enter
29 a home care organization during posted business hours, with or
30 without advance notice, to secure compliance with, or to prevent
31 a violation of, any provision of this chapter or any provision
32 promulgated under this chapter.

33

34 Article 11. Enforcement

35

36 1796.55. (a) A home care organization that operates in
37 violation of any requirement or obligation imposed by this chapter
38 or any rule or regulation promulgated under this chapter may be
39 subject to the fines levied or licensure action taken by the
40 department as specified in this chapter.

1 (b) When the department determines that a home care
2 organization is in violation of this chapter or any rules or
3 regulations promulgated under this chapter, a notice of violation
4 shall be served upon the licensee. Each notice of violation shall
5 be prepared in writing and shall specify the nature of the violation
6 and the statutory provision, rule, or regulation alleged to have
7 been violated. The notice shall inform the licensee of any action
8 the department may take under this chapter, including the
9 requirement of a plan of correction, assessment of a penalty, or
10 action to suspend, revoke, or deny renewal of the license. The
11 director or his or her designee shall also inform the licensee of
12 rights to a hearing under this chapter.

13 (c) The department may impose a fine of up to nine hundred
14 dollars (\$900) per violation per day commencing on the date the
15 violation was identified and ending on the date each violation is
16 corrected, or action is taken to suspend, revoke, or deny renewal
17 of the license, whichever comes first.

18 (d) The department shall adopt regulations establishing
19 procedures for notices, correction plans, appeals, and hearings.

20 1796.56. Any fines and penalties collected pursuant to this
21 chapter shall be deposited into the Home Care Penalties
22 Subaccount, which is hereby created within the Home Care Fund
23 created pursuant to Section 1796.47. Moneys in this account shall,

31 chapter, is guilty of a misdemeanor and, upon conviction thereof,
32 shall be punished by a fine not to exceed one thousand dollars

13 *1796.62. This chapter and any rules and regulations*
14 *promulgated pursuant to this chapter shall only be implemented*
15 *to the extent that funds are made available through an*
16 *appropriation in the annual Budget Act.*

17 *1796.63. The department shall adopt, amend, or repeal, in*
18 *accordance with Chapter 3.5 (commencing with Section 11340)*
19 *of the Government Code, any reasonable rules, regulations, and*
20 *standards as may be necessary or proper to carry out the purpose*
21 *and intent of this chapter and to enable the department to exercise*
