An act to add Section 66014.8 to the Education Code, relating to postsecondary education.

LEGISLATIVE COUNSEL'S DIGEST

AB 2247, as amended, Williams. Postsecondary education: accreditation documents.

Under existing law, there are 4 segments of postsecondary education in this state. These segments include the three public segments: the University of California, the California State University, and the California Community Colleges. Private postsecondary educational institutions and independent institutions of higher education constitute the other segment.

This bill would require each campus or other unit of the segments listed above that receives public funding through state or federal financial aid programs, is institutionally accredited by an accrediting agency recognized by the United States Department of Education, and offers education and training programs to California students to make final institutional accreditation documents available to the public via the institution's Internet Web site, as specified.

To the extent that this bill would require community college districts to provide this service, the bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to these statutory provisions.

Vote: majority. Appropriation: no. Fiscal committee: yes. State-mandated local program: yes.

The people of the State of California do enact as follows:

1 SECTION 1. Section 66014.8 is added to the Education Code,
2 to read:

3 66014.8. (a) For purposes of this section, the following terms
4 have the following meanings:

5 (1) “Institutional accreditation documents” means the
6 institution’s institutional accreditation visiting team reports and
7 the institutional accreditation agency action letters following an
8 accreditation agency’s ~~action~~ *action relating to a comprehensive*
9 *review, special visit, or any sanction or adverse action taken*
10 *against an affiliated institution.*

11 (2) “Segment of postsecondary education” means the California
12 Community Colleges, the California State University, the
13 University of California, the independent institutions of higher
14 education, as defined in Section 66010, or the private
15 postsecondary educational institutions, as defined in Section 94858.

16 (b) All campuses or other units of any segment of postsecondary
17 education that receive public funding through state or federal
18 financial aid programs, are institutionally accredited by an
19 accrediting agency recognized by the United States Department
20 of Education, and offer education and training programs to
21 California students shall make final institutional accreditation
22 documents available to the ~~public~~ *public, once those documents*
23 *have been made final through an action of the accrediting agency,*
24 *via display in a prominent location on the institution’s Internet*

1 Web site, with a link to these documents on the institutional
2 *Internet* Web site homepage.

3 (c) A campus or other unit of any segment of postsecondary
4 education whose documents are not currently available to the public
5 shall make all institutional accreditation documents ~~completed~~
6 ~~after January 1, 2015~~, *finalized by the accrediting agency based*
7 *on reviews that take place after July 1, 2015*, available to the public
8 pursuant to subdivision (b).

9 SEC. 2. If the Commission on State Mandates determines that
10 this act contains costs mandated by the state, reimbursement to
11 local agencies and school districts for those costs shall be made
12 pursuant to Part 7 (commencing with Section 17500) of Division
13 4 of Title 2 of the Government Code.
