An act to amend Section 172g of the Penal Code, relating to intoxicating liquors, and declaring the urgency thereof, to take effect immediately.

LEGISLATIVE COUNSEL'S DIGEST

SB 120, as introduced, Roth. Intoxicating liquors.

Existing law makes it a misdemeanor to sell, or expose for sale, any intoxicating liquor within one mile of the entrance to La Sierra College in the City of Riverside, as provided. A person who violates this provision is subject to a fine of not less than \$100, imprisonment in a county jail of not less than 50 days nor more than one year, or both that fine and imprisonment.

This bill would reduce that distance to one-half mile.

This bill would declare that it is to take effect immediately as an urgency statute.

The people of the State of California do enact as follows:

- 7 Linda University in the County of San Bernardino, or within one

 3 guilty of a misdemeanor, and upon conviction thereof shall be
 4 punished by a fine of not less than one hundred dollars (\$100), or
 5 by imprisonment in the county jail of not less than 50 days nor
 6 more than one year, or by both ~~such~~ *that* fine and imprisonment
 7 in the discretion of the court.

9 (b) The provisions of this section shall not apply to the sale or
 10 exposing or offering for sale of ale, porter, wine, similar fermented
 11 malt or vinous liquor or fruit juice containing one-half of 1 percent
 12 or more of alcohol by volume and not more than 3.2 percent of
 13 alcohol by weight nor the sale or exposing or offering for sale of
 14 beer.

16 (c) Distances provided in this section shall be measured not by
 17 air line but by following the shortest road or roads connecting the
 18 points in question except those applying to La Sierra College.

19 SEC. 2. This act is an urgency statute necessary for the
 20 immediate preservation of the public peace, health, or safety within
 21 the meaning of Article IV of the Constitution and shall go into
 22 immediate effect. The facts constituting the necessity are:

23 In order to preserve the public peace, health, and safety by
 24 stimulating local economic development at the earliest possible
 25 time, it is necessary that this act take effect immediately.
