SENATE BILL

No. 195

Introduced by Senator Liu

February 7, 2013

An act to add Chapter 13 (commencing with Section 67050) to Part 40 of Division 5 of Title 3 of the Education Code, relating to postsecondary education.

LEGISLATIVE COUNSEL'S DIGEST

SB 195, as amended, Liu. California postsecondary education: state goals.

Existing law establishes the University of California, under the administration of the Regents of the University of California, the California State University, under the administration of the Trustees of the California State University, and the California Community Colleges, under the administration of the Board of Governors of the California Community Colleges, and independent institutions of higher education as the 4 segments of postsecondary education in this state.

Existing law states the intent of the Legislature to urge the continued development and implementation of assessment processes whereby institutions of higher education establish mechanisms, through program review and improvement, for the assessment of their performance in attempting to improve student learning and comprehension and achieving the expressed state policy goals for higher education of quality, educational equity, employee diversity, student transfer, and student retention.

This bill would state the intent of the Legislature that budget and policy decisions regarding postsecondary education generally adhere to 3 specified goals and that appropriate metrics be identified, defined,

and formally ~~adopted~~ *adopted, based upon recommendations provided by a working group*, to monitor progress toward the achievement of the goals. The bill would require ~~the Governor's Office of Planning and Research~~ *an appropriate educational administrative body, as determined by the Governor*, to convene a working group, composed of specified participants, to assist with the development of those metrics. The bill also would require ~~the Governor's Office of Planning and Research~~ *administrative body*, in consultation with the Department of Finance and the Legislative Analyst's Office, to submit recommended metrics to specified persons and entities on or before January 31, 2014.

The people of the State of California do enact as follows:

8 67050. The Legislature finds and declares all of the following:

9 (a) Since the enactment of the Master Plan for Higher Education
10 in 1960, California's system of postsecondary education has
11 provided access and high-quality educational opportunities that
12 have fueled California's economic growth and promoted social
13 mobility.

14 (b) In today's global information economy, California's national
15 and international success as an educational and economic leader
16 will require strategic investments in, and improved management
17 of, state educational resources.

18 (c) Several factors, including changing demographics, rising
19 costs, increased competition for scarce state funding, and employer
20 concerns about graduates' skills, present new challenges to higher
21 education and state policymakers in effectively meeting the
22 postsecondary education needs of Californians.

23 (d) Although the public segments of postsecondary education
24 have each undertaken efforts to improve reporting and
25 transparency, these efforts do not combine to indicate whether the

1 postsecondary system as a whole is on track to meet the state's
2 needs.

3 (e) The absence of a common vision and goals for California's
4 postsecondary education system hinders the state's ability to
5 effectively make critical fiscal and policy decisions.

6 (f) Policy and educational leaders should collectively hold
7 themselves accountable for meeting the state's civic and workforce
8 needs, for ensuring the efficient and responsible management of
9 public resources, and for ensuring that California residents have
10 the opportunity to successfully pursue and achieve their
11 postsecondary educational goals.

12 67051. In order to promote the state's competitive economic
13 position and quality of civic life, it is necessary to increase the
14 level of educational attainment of California's adult population to
15 meet the state's civic and workforce needs. To achieve that
16 objective, it is the intent of the Legislature that budget and policy
17 decisions regarding postsecondary education generally adhere to
18 all of the following goals:

19 (a) Improve student access and success, which shall include,
20 but not be limited to, all of the following goals: greater participation
21 by demographic groups that have historically participated at lower
22 rates, greater completion rates by all students, and improved
23 outcomes for graduates.

24 (b) Better align degrees and credentials with the state's
25 economic, workforce, and civic needs.

26 (c) Ensure the effective and efficient use of resources in order
27 to increase high-quality postsecondary educational outcomes and
28 maintain affordability.

29 67052. (a) It is the intent of the Legislature that appropriate
30 metrics be identified, defined, and formally ~~adopted to monitor~~
31 *adopted, based upon the recommendations provided by the working*
32 *group established pursuant to Section 67053, for the purpose of*
33 *monitoring* progress toward the achievement of the goals specified
34 in Section 67051. It is further the intent of the Legislature that all
35 of the following occur:

36 (1) The metrics take into account the distinct missions of the
37 different segments of postsecondary education.

38 (2) At least six, and no more than 12, metrics be developed that
39 can be derived from publicly available data sources for purposes

1 of periodically assessing the state's progress toward meeting each
 2 of the goals specified in Section 67051.

3 (3) The metrics be disaggregated and reported by gender, race
 4 or ethnicity, income, age group, and full-time or part-time
 5 enrollment status, where appropriate and applicable.

6 (4) The metrics be ~~utilized~~ *used* for purposes of the requirements
 7 of subdivision (a) of Section 69433.2.

8 (b) It is the intent of the Legislature to promote progress on the
 9 statewide educational and economic policy goals specified in
 10 Section 67051 through budget and policy decisions regarding
 11 postsecondary education. It is the intent of the Legislature that the
 12 metrics be used to ensure the effective and efficient use of state
 13 resources available to postsecondary education.

14 ~~67053. (a) The Governor's Office of Planning and Research~~
 15 *An appropriate educational administrative body, as determined*
 16 *by the Governor,* shall convene a working group to assist with the
 17 development of the metrics specified in Section 67052. Participants
 18 in the working group shall include all of the following:

19 (1) (A) One representative from each of the postsecondary
 20 education segments, as defined in Section 67054, and a
 21 representative of the State Department of Education.

22 (B) The representative of the independent institutions of higher
 23 education shall be from the official organization representing the
 24 largest number of independent institutions of higher education in
 25 the state. The representative of the private postsecondary
 26 educational institutions shall be the Chief of the Bureau for Private
 27 Postsecondary Education, or the chief's designee.

28 (2) One representative of the Department of Finance.

29 (3) At least one member, but no more than three members, with
 30 expertise in similar state accountability efforts, who is not a regular
 31 employee of a postsecondary education segment.

32 (4) A representative of the Legislative Analyst's Office.

33 ~~(b) The Governor's Office of Planning and Research~~ *appropriate*
 34 *educational administrative body, as determined by the Governor*
 35 *pursuant to subdivision (a),* may request technical input from any
 36 agency that maintains data that would be helpful in developing the
 37 metrics and assessing progress toward achieving the goals specified
 38 in Section 67051.

39 ~~(c) The Governor's Office of Planning and Research,~~
 40 *appropriate educational administrative body, as determined by*

1 *the Governor pursuant to subdivision (a)*, in consultation with the
2 Department of Finance and the Legislative Analyst’s Office, shall
3 submit recommended metrics developed pursuant to subdivision
4 (a) to the appropriate policy committees of the Legislature, the
5 Joint Legislative Budget Committee, and the Governor on or before
6 January 31, 2014.

7 67054. For the purposes of this chapter, “segments of
8 postsecondary education” means the California Community
9 Colleges, the California State University, the University of
10 California, independent institutions of higher education, as defined
11 in Section 66010, and private postsecondary educational
12 institutions, as defined in Section 94858.
