An act to amend Sections 32280 and 32282 of, ~~and to add Chapter 5.8 (commencing with Section 51950) to, to add Chapter 5.9 (commencing with Section 51970) to, and to repeal Article 5 (commencing with Section 51260) of Chapter 2 of, Part 28 of Division 4 of Title 2 of,~~ the Education Code, relating to school safety.

LEGISLATIVE COUNSEL'S DIGEST

SB 634, as amended, Price. School safety plans: safety drills ~~and instruction.~~

Existing law requires each school district and county office of education to be responsible for the overall development of a comprehensive school safety plan for each of their constituent schools. Existing law requires the comprehensive school safety plan to both assess the current status of school crime committed on school campuses and at school-related functions, and identify appropriate strategies and programs that will provide or maintain a high level of school safety, as specified.

This bill would, in addition, require a comprehensive school safety plan to establish procedures for conducting school safety drills. The bill would require each school during each school year to conduct a minimum number of school evacuation drills relating to fire incidents, as provided, and authorize schools to conduct other school evacuations, as specified. The bill would also require schools to conduct at least one law enforcement school lockdown drill. The bill would authorize

schools, school districts, and county offices of education preparing for and executing these drills to work with local first responders and law enforcement agencies, as specified. By imposing additional duties on school districts, county offices of education, and schools, the bill would impose a state-mandated local program.

~~This bill would require the State Department of Education to make available information on model comprehensive school safety plans and training programs. The bill would require the department to prepare and distribute to school districts and county offices of education guidelines for incorporating in-service training in comprehensive school safety plan implementation, as provided. The bill would require the department, upon request, to assist school districts and county offices of education in developing comprehensive school safety plan in-service training programs, as defined, and assist the school districts and county offices of education to qualify for federal and state funds for these purposes. The bill would require the department to collaborate with other state agencies that administer emergency and crisis preparedness, safety planning, and violence prevention education programs to streamline the process whereby local education agencies apply for state and federal school safety funds. The bill would require the department to develop an ongoing statewide monitoring and assessment system to provide current and reliable data on the use of resources for programs for school safety.~~

~~The bill would move existing law relating to drug and gang violence to a new chapter of the Education Code and make conforming changes to that law.~~

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to these statutory provisions.

The people of the State of California do enact as follows:

- 1 SECTION 1. Section 32280 of the Education Code is amended
- 2 to read:

1 32280. (a) It is the intent of the Legislature that all California
2 public schools, in kindergarten, and grades 1 to 12, inclusive,
3 operated by school districts, in cooperation with local law
4 enforcement agencies, community leaders, parents, pupils, teachers,
5 administrators, and other persons who may be interested in the
6 prevention of campus crime and violence, develop a comprehensive
7 school safety plan that addresses the safety concerns identified
8 through a systematic planning process.

9 (b) For the purposes of this section:

10 (1) Law enforcement agencies include local police departments,
11 county sheriffs' offices, school district police or security
12 departments, probation departments, and district attorneys' offices.

13 (2) First responders include local fire departments, emergency
14 medical responders, and emergency management officials.

15 (3) "Safety plan" means a developed plan of strategies that are
16 coordinated with first responders and law enforcement agencies
17 and aimed at the prevention of, education about, and response to
18 potential incidents involving natural disasters, crime, and violence
19 on or near the school campus.

20 SEC. 2. Section 32282 of the Education Code is amended to
21 read:

22 32282. (a) The comprehensive school safety plan shall include,
23 but not be limited to, all of the following:

24 (1) Assessing the current status of school crime committed on
25 school campuses and at school-related functions.

26 (2) Identifying appropriate strategies and programs that will
27 provide or maintain a high level of school safety and address the
28 school's procedures for complying with existing laws related to
29 school safety, which shall include the development of all of the
30 following:

31 (A) Child abuse reporting procedures consistent with Article
32 2.5 (commencing with Section 11164) of Chapter 2 of Title 1 of
33 Part 4 of the Penal Code.

34 (B) Disaster procedures, routine and emergency, including
35 adaptations for pupils with disabilities in accordance with the
36 federal Americans with Disabilities Act of 1990 (42 U.S.C. Sec.
37 12101 et seq.). The disaster procedures shall also include, but not
38 be limited to, both of the following:

39 (i) Establishing an earthquake emergency procedure system in
40 every public school building having an occupant capacity of 50

1 or more pupils or more than one classroom. A school district or
2 county office of education may work with the California
3 Emergency Management Agency and the Seismic Safety
4 Commission to develop and establish the earthquake emergency
5 procedure system. The system shall include, but not be limited to,
6 all of the following:

7 (I) A school building disaster plan, ready for implementation
8 at any time, for maintaining the safety and care of pupils and staff.

9 (II) A drop procedure whereby each pupil and staff member
10 takes cover under each table or desk, dropping to his or her knees,
11 with the head protected by the arms, and the back to the windows.
12 A drop procedure practice shall be held at least once each school
13 quarter in elementary schools and at least once each semester in
14 secondary schools.

15 (III) Protective measures to be taken before, during, and
16 following an earthquake.

17 (IV) A program to ensure that pupils and both the certificated
18 and classified staff are aware of, and properly trained in, the
19 earthquake emergency procedure system.

20 (ii) Establishing a procedure to allow a public agency, including
21 the American Red Cross, to use school buildings, grounds, and
22 equipment for mass care and welfare shelters during disasters or
23 other emergencies affecting the public health and welfare. The
24 school district or county office of education shall cooperate with
25 the public agency in furnishing and maintaining the services as
26 the school district or county office of education may deem
27 necessary to meet the needs of the community.

28 (C) Policies pursuant to subdivision (d) of Section 48915 for
29 pupils who committed an act listed in subdivision (c) of Section
30 48915 and other school-designated serious acts that would lead to
31 suspension, expulsion, or mandatory expulsion recommendations
32 pursuant to Article 1 (commencing with Section 48900) of Chapter
33 6 of Part 27 of Division 4 of Title 2.

34 (D) Procedures to notify teachers of dangerous pupils pursuant
35 to Section 49079.

36 (E) A discrimination and harassment policy consistent with the
37 prohibition against discrimination contained in Chapter 2
38 (commencing with Section 200) of Part 1.

39 (F) The provisions of a schoolwide dress code, pursuant to
40 Section 35183, that prohibits pupils from wearing “gang-related

1 apparel,” if the school has adopted that type of a dress code. For
2 those purposes, the comprehensive school safety plan shall define
3 “gang-related apparel.” The definition shall be limited to apparel
4 that, if worn or displayed on a school campus, reasonably could
5 be determined to threaten the health and safety of the school
6 environment. A schoolwide dress code established pursuant to this
7 section and Section 35183 shall be enforced on the school campus
8 and at any school-sponsored activity by the principal of the school
9 or the person designated by the principal. For purposes of this
10 paragraph, “gang-related apparel” shall not be considered a
11 protected form of speech pursuant to Section 48950.

12 (G) Procedures for safe ingress and egress of pupils, parents,
13 and school employees to and from school.

14 (H) A safe and orderly environment conducive to learning at
15 the school.

16 (I) The rules and procedures on school discipline adopted
17 pursuant to Sections 35291 and 35291.5.

18 (3) Establishing procedures for conducting school safety drills.

19 School safety drills shall be incorporated into the comprehensive
20 school safety plan, and each school shall administer the drills as
21 follows:

22 (A) During each school year, each school shall conduct at least
23 the minimum number of school evacuation drills to prepare pupils
24 and school personnel for fire incidents as are required by Section
25 32001. A school may conduct additional evacuation drills for other
26 incidents that may require evacuation, including, but not limited
27 to, suspicious items, bomb threats, hazardous materials incidents,
28 on-campus shooting incidents, and other situations under which
29 conditions outside of school buildings are safer than conditions
30 inside school buildings.

31 (B) During each school year, each school shall conduct a
32 minimum of one law enforcement school lockdown drill to prepare
33 pupils, school personnel, and law enforcement personnel to respond
34 to situations in which conditions inside school buildings are safer
35 than conditions outside school buildings. This drill may include,
36 but is not limited to, responses to suspicious items or persons,
37 hazardous materials incidents, bomb threats, and shooting incidents
38 on or near school grounds.

39 (C) In the preparation for and execution of the drills referred to
40 in subparagraph (A) or (B), the school, school district, or county

1 office of education conducting these drills may work with local
2 first responders and law enforcement agencies to formulate safety
3 plans and to prepare and execute safety drills.

4 (b) It is the intent of the Legislature that schools develop
5 comprehensive school safety plans using existing resources,
6 including the materials and services of the partnership, pursuant
7 to this chapter. It is also the intent of the Legislature that schools
8 use the handbook developed and distributed by the School/Law
9 Enforcement Partnership Program entitled “Safe Schools: A
10 Planning Guide for Action” in conjunction with developing their
11 plan for school safety.

12 (c) Grants to assist schools in implementing their comprehensive
13 school safety plan shall be made available through the partnership
14 as authorized by Section 32285.

15 (d) Each schoolsite council or school safety planning committee
16 in developing and updating a comprehensive school safety plan
17 shall, where practical, consult, cooperate, and coordinate with
18 other schoolsite councils or school safety planning committees.

19 (e) The comprehensive school safety plan may be evaluated and
20 amended, as needed, by the school safety planning committee, but
21 shall be evaluated at least once a year, to ensure that the
22 comprehensive school safety plan is properly implemented. An
23 updated file of all safety-related plans and materials shall be readily
24 available for inspection by the public.

25 (f) As comprehensive school safety plans are reviewed and
26 updated, the Legislature encourages all plans, to the extent that
27 resources are available, to include policies and procedures aimed
28 at the prevention of bullying.

29 (g) The comprehensive school safety plan, as written and
30 updated by the schoolsite council or school safety planning
31 committee, shall be submitted for approval under subdivision (a)
32 of Section 32288.

9 violence and drug and alcohol abuse prevention education.

10 (b) “Gang violence and drug and alcohol abuse prevention
11 in-service training,” for purposes of this chapter, means the
12 presentation of programs, instruction, and curricula that will help
13 educators develop competencies in interacting in a positive manner
14 with children and youth to assist them in developing the positive
15 values, self-esteem, knowledge, and skills to lead productive,
16 gang-free, and drug-free lives; develop knowledge of the causes
17 of gang violence and substance abuse, and the properties and effects

20 safety plan developed pursuant to Article 5 (commencing with
21 Section 32280) of Chapter 2.5 of Part 19 of Division 1 of Title 1.

22 51971. (a) The Legislature hereby finds and declares that
23 training teachers and staff to follow a comprehensive school safety
24 plan developed pursuant to Article 5 (commencing with Section
25 32280) of Chapter 2.5 of Part 19 of Division 1 of Title 1 is essential
26 to emergency preparedness, crisis management, and school safety.

27 (b) It is the intent of the Legislature in enacting this chapter that
28 schools are encouraged to include instruction on implementing
29 comprehensive school safety plans for teachers and staff.
