An act to amend Sections 27540, 27875, 27880, 27920, 27925, 28160, ~~and~~ 31620, *and* 31810 of, to amend the heading of Chapter 4 (commencing with Section 31500) of Division 10 of Title 4 of Part 6 of, to amend the heading of Article 2 (commencing with Section 31610) of Chapter 4 of Division 10 of Title 4 of Part 6 of, to amend the heading of Article 3 (commencing with Section 31700) of Chapter 4 of Division 10 of Title 4 of Part 6 of, to amend, repeal, and add Sections 26840, 31610, 31615, 31625, 31630, 31635, 31640, 31645, 31650, 31655, 31660, and 31700 of, and to add Sections 16535, 16865, and 26860 to, the Penal Code, relating to firearms, and making an appropriation therefor.

LEGISLATIVE COUNSEL'S DIGEST

SB 683, as amended, Block. Firearms: firearm safety certificate.

Existing law, subject to exceptions, prohibits a person from purchasing or receiving any handgun without a valid handgun safety certificate, and prohibits any person from selling, delivering, loaning, or transferring any handgun to any person who does not have a valid handgun safety certificate, with exceptions, as specified. Under existing law, a violation of these provisions is a misdemeanor.

This bill would instead, commencing January 1, 2015, and subject to exceptions, prohibit a person from purchasing or receiving any firearm without a valid firearm safety certificate, and would, subject to exceptions, prohibit any person from selling, delivering, loaning, or transferring any firearm to any person who does not have a valid firearm safety certificate. The bill would make conforming changes. The bill would also make technical, nonsubstantive changes. The bill would, commencing January 1, 2015, and subject to exceptions, require a safe handling demonstration for purchasers of long guns, and would require the Department of Justice to adopt regulations to establish a long gun safe handling demonstration no later than January 1, 2015. The bill would define the term “long gun” for these purposes. By expanding the scope of a crime, this bill would impose a state-mandated local program.

Existing law allows the Department of Justice to charge a certified instructor up to \$15 for each handgun safety certificate issued by that instructor and requires the funds to be deposited in the Firearms Safety and Enforcement Special Fund, which is a continuously appropriated fund.

This bill would, commencing January 1, 2015, allow the department to collect \$15 for each firearm safety certificate and would require the funds to be deposited in the Firearms Safety and Enforcement Special Fund, which is continuously appropriated, thereby making an appropriation.

*This bill would incorporate amendments to Section 28160 of the Penal Code proposed by AB 538, to become operative if both bills are enacted and this bill is chaptered last.*

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

1 SECTION 1. Section 16535 is added to the Penal Code, to

3 16535. (a) As used in this part, “firearm safety certificate”  
4 means a certificate issued by the Department of Justice pursuant

1 to Sections 31610 to 31700, inclusive, or pursuant to former Article  
2 8 (commencing with Section 12800) of Chapter 6 of Title 2 of Part  
3 4, as that article was operative at any time from January 1, 2003,  
4 until it was repealed by the Deadly Weapons Recodification Act  
5 of 2010.

6 (b) This section shall become operative on January 1, 2015.

7 SEC. 2. Section 16865 is added to the Penal Code, to read:

8 16865. As used in Section 26860, “long gun” means any  
9 firearm that is not a handgun or a machinegun.

10 SEC. 3. Section 26840 of the Penal Code is amended to read:

11 26840. (a) A dealer shall not deliver a handgun unless the  
12 person receiving the handgun presents to the dealer a valid handgun  
13 safety certificate. The firearms dealer shall retain a photocopy of  
14 the handgun safety certificate as proof of compliance with this  
15 requirement.

16 (b) This section shall remain in effect only until January 1, 2015,  
17 and as of that date is repealed, unless a later enacted statute, that  
18 is enacted before January 1, 2015, deletes or extends that date.

19 SEC. 4. Section 26840 is added to the Penal Code, to read:

20 26840. (a) A dealer shall not deliver a firearm unless the person  
21 receiving the firearm presents to the dealer a valid firearm safety  
22 certificate, or, in the case of a handgun, an unexpired handgun  
23 safety certificate. The firearms dealer shall retain a photocopy of  
24 the firearm safety certificate as proof of compliance with this  
25 requirement.

26 (b) This section shall become operative on January 1, 2015.

27 SEC. 5. Section 26860 is added to the Penal Code, to read:

28 26860. (a) Except as authorized by the department,  
29 commencing January 1, 2015, a firearms dealer shall not deliver  
30 a long gun unless the recipient performs a safe handling  
31 demonstration with that long gun.

32 (b) The department shall, not later than January 1, 2015, adopt  
33 regulations establishing a long gun safe handling demonstration  
34 that shall include, at a minimum, loading and unloading the long  
35 gun.

36 (c) The firearms dealer shall sign and date an affidavit stating  
37 that the requirements of subdivision (a) and the regulations adopted  
38 pursuant to subdivision (b) have been met. The firearms dealer  
39 shall additionally obtain the signature of the long gun purchaser

1 on the same affidavit. The firearms dealer shall retain the original  
2 affidavit as proof of compliance with this section.

3 (d) The recipient shall perform the safe handling demonstration  
4 for a department-certified instructor.

5 (e) A demonstration is not required if the dealer is returning the  
6 long gun to the owner of the long gun.

7 (f) Department-certified instructors who may administer the  
8 safe handling demonstration shall meet the requirements set forth  
9 in subdivision (b) of Section 31635.

10 (g) An individual who is exempt from the requirements of  
11 subdivision (a) of Section 31615, pursuant to Section 31700, is  
12 also exempt from performing the safe handling demonstration.

13 SEC. 6. Section 27540 of the Penal Code is amended to read:  
14 27540. A dealer, whether or not acting pursuant to Chapter 5  
15 (commencing with Section 28050), shall not deliver a firearm to  
16 a person, as follows:

17 (a) Within 10 days of the application to purchase, or, after notice  
18 by the department pursuant to Section 28220, within 10 days of  
19 the submission to the department of any correction to the  
20 application, or within 10 days of the submission to the department  
21 of any fee required pursuant to Section 28225, whichever is later.

22 (b) Unless unloaded and securely wrapped or unloaded and in  
23 a locked container.

24 (c) Unless the purchaser, transferee, or person being loaned the  
25 firearm presents clear evidence of the person’s identity and age to  
26 the dealer.

27 (d) Whenever the dealer is notified by the Department of Justice  
28 that the person is prohibited by state or federal law from possessing,  
29 receiving, owning, or purchasing a firearm.

30 (e) A handgun shall not be delivered unless the purchaser,  
31 transferee, or person being loaned the handgun presents a handgun  
32 safety certificate. Commencing January 1, 2015, any firearm,  
33 including a handgun, shall not be delivered unless the purchaser,  
34 transferee, or person being loaned the firearm presents a firearm  
35 safety certificate to the dealer, except that in the case of a handgun,  
36 an unexpired handgun safety certificate may be presented.

37 (f) A handgun shall not be delivered whenever the dealer is  
38 notified by the Department of Justice that within the preceding  
39 30-day period the purchaser has made another application to  
40 purchase a handgun and that the previous application to purchase

3 SEC. 7. Section 27875 of the Penal Code is amended to read:

4 27875. Section 27545 does not apply to the transfer of a firearm  
5 by gift, bequest, intestate succession, or other means from one  
6 individual to another, if all of the following requirements are met:

7 (a) The transfer is infrequent, as defined in Section 16730.

8 (b) The transfer is between members of the same immediate  
9 family.

10 (c) Within 30 days of taking possession of the firearm, the  
11 person to whom it is transferred shall forward by prepaid mail, or  
12 deliver in person to the Department of Justice, a report that includes  
13 information concerning the individual taking possession of the  
14 firearm, how title was obtained and from whom, and a description  
15 of the firearm in question. The report forms that individuals  
16 complete pursuant to this section shall be provided to them by the  
17 Department of Justice.

18 (d) Until January 1, 2015, the person taking title to the firearm  
19 shall first obtain a handgun safety certificate if the firearm is a  
20 handgun, and commencing January 1, 2015, a firearm safety  
21 certificate for any firearm, except that in the case of a handgun,  
22 an unexpired handgun safety certificate may be used.

23 (e) The person receiving the firearm is 18 years of age or older.

24 SEC. 8. Section 27880 of the Penal Code is amended to read:

25 27880. Section 27545 does not apply to the loan of a firearm  
26 between persons who are personally known to each other, if all of  
27 the following requirements are satisfied:

28 (a) The loan is infrequent, as defined in Section 16730.

29 (b) The loan is for any lawful purpose.

30 (c) The loan does not exceed 30 days in duration.

31 (d) Until January 1, 2015, if the firearm is a handgun, the  
32 individual being loaned the firearm shall have a valid handgun  
33 safety certificate. Commencing January 1, 2015, for any firearm,  
34 the individual being loaned the firearm shall have a valid firearm  
35 safety certificate, except that in the case of a handgun, an unexpired  
36 handgun safety certificate may be used.

37 SEC. 9. Section 27920 of the Penal Code is amended to read:

38 27920. Section 27545 does not apply to a person who takes  
39 title or possession of a firearm by operation of law if the person  
40 is not prohibited by state or federal law from possessing, receiving,

1 owning, or purchasing a firearm and all of the following conditions  
2 are met:

3 (a) If the person taking title or possession is neither a levying  
4 officer as defined in Section 481.140, 511.060, or 680.260 of the  
5 Code of Civil Procedure, nor a person who is receiving that firearm  
6 pursuant to subdivision (g), (i), or (j) of Section 16990, the person  
7 shall, within 30 days of taking possession, forward by prepaid mail  
8 or deliver in person to the Department of Justice, a report of  
9 information concerning the individual taking possession of the

4 is a person described in subdivision (j) of Section 16990, on the  
5 date that the person is delivered the firearm, the name and other  
6 information concerning the person taking possession of the firearm,  
7 how title or possession of the firearm was obtained and from whom,  
8 and a description of the firearm by make, model, serial number,  
9 and other identifying characteristics shall be entered into the AFS  
10 via the CLETS by the law enforcement or state agency that  
11 transferred or delivered the firearm, provided, however, that if the  
12 firearm is not a handgun and does not have a serial number,  
13 identification number, or identification mark assigned to it, that  
14 fact shall be noted in AFS. An agency without access to AFS shall  
15 arrange with the sheriff of the county in which the agency is located  
16 to input this information via this system. In addition, that law  
17 enforcement agency shall not deliver the firearm to the person  
18 referred to in this subdivision unless, prior to the delivery of the  
19 firearm, the person presents proof to the agency that the person is  
20 the holder of a handgun safety certificate if the firearm is a  
21 handgun, and commencing January 1, 2015, a firearm safety  
22 certificate for any firearm, except that in the case of a handgun,  
23 an unexpired handgun safety certificate may be presented.

24 (e) The reports that individuals complete pursuant to this section  
25 shall be provided to them by the Department of Justice.

31 (b) Until January 1, 2015, in the case of a handgun, the  
32 individual shall obtain a handgun safety certificate prior to  
33 transferring ownership to himself or herself, or taking possession  
34 of a handgun in an individual capacity. Beginning January 1, 2015,  
35 the individual shall obtain a firearm safety certificate prior to  
36 transferring ownership to himself or herself, or taking possession  
37 of a firearm in an individual capacity, except that in the case of a  
38 handgun, an unexpired handgun safety certificate may be used.
