An act ~~relating to the Budget Act of 2014.~~ *to repeal Chapter 3.131 (commencing with Section 15820.93) of Part 10b of Division 3 of Title 2 of the Government Code, relating to correctional facilities, and making an appropriation therefor, to take effect immediately, bill related to the budget.*

LEGISLATIVE COUNSEL'S DIGEST

SB 877, as amended, Committee on Budget and Fiscal Review. ~~Budget Act of 2014.~~ *Correctional facilities: construction.*

(1) Existing law authorizes the Board of State and Community Corrections or the Department of Corrections and Rehabilitation, a participating county, as defined, and the State Public Works Board to acquire, design, and construct an adult local justice facility, as defined. Existing law authorizes the State Public Works Board to issue up to \$500,000,000 in revenue bonds, notes, or bond anticipation notes to finance the acquisition, design, and construction of the approved adult local criminal justice facilities and establishes the procedures for approving and funding these projects. Existing law includes duplicative provisions of this authorization.

This bill would repeal the duplicative provision.

(2) This bill would appropriate \$5,000 from the General Fund to the Board of State and Community Corrections for purposes of administering the bond financing program established pursuant the above provisions.

(3) *This bill would declare that it is to take effect immediately as a bill providing for appropriations related to the Budget Bill.*

The people of the State of California do enact as follows:

1 *SECTION 1. Chapter 3.131 (commencing with Section*
2 *15820.93) of Part 10b of Division 3 of Title 2 of the Government*
3 *Code, as added by Section 6 of Chapter 26 of the Statutes of 2014,*
4 *is repealed.*

5 *SEC. 2. The sum of five thousand dollars (\$5,000) is hereby*
6 *appropriated from the General Fund to the Board of State and*
7 *Community Corrections for purposes of administering the bond*
8 *financing program established pursuant to Chapter 3.131*
9 *(commencing with Section 15820.93) of Part 10b of Division 3 of*
10 *Title 2 of the Government Code, as added by Section 4 of Chapter*
11 *37 of the Statutes of 2014.*

12 *SEC. 3. This act is a bill providing for appropriations related*
13 *to the Budget Bill within the meaning of subdivision (e) of Section*
14 *12 of Article IV of the California Constitution, has been identified*
15 *as related to the budget in the Budget Bill, and shall take effect*
16 *immediately.*
