SENATE BILL

An act to amend Sections 109.5, 1155, 1503, 2101, 2105, 2107, 2112, 2204, 3304, 5120, 5817, 6211, 6611, 6810, 8211, 8611, 8810, 12571, 12631, 12670, 15901.09, 15901.16, 15902.01, 15902.04, 15902.07, 15903.06, 15906.05, 15909.06, 15909.07, 15911.06, 16309, 16906, 16915, 16953, 16959, 16960, 17701.09, 17701.15, 17702.02, 17702.03, 17702.06, 17707.08, ~~17708.5~~, 17708.05, 17708.06, 17710.06, 17710.14, and 18210 of the Corporations Code, to amend Section 14101.6 of the Financial Code, and to amend Section 12261 of the Government Code, relating to business.

LEGISLATIVE COUNSEL'S DIGEST

SB 1041, as amended, Jackson. Business: filings.

Existing law requires certain business entities, including, but not limited to, a corporation, a limited partnership, a foreign corporation, a foreign limited partnership, a limited liability partnership, a foreign limited liability partnership, a flexible purpose corporation, a limited liability company, an unincorporated association, and a credit union, to make various filings with the Secretary of State. Existing law authorizes agents designated for service of process for specified entities to file a written statement of resignation as that agent with the Secretary of State. Existing law allows a person to apply for and reserve a name for a business entity with the Secretary of State. Existing law requires the Secretary of State to reinstate a fraudulently terminated business entity upon court order.

This bill, among other things, would require the written statement of resignation to be made on a form prescribed by the Secretary of State for filing, as specified, and would allow the Secretary of State to destroy or otherwise dispose of a resignation after a new form is filed, replacing the agent. This bill would allow a person to cancel the registration of the name of specified business entities by delivering to the Secretary of State a certificate of cancellation of the entity's name on a form prescribed by the Secretary of State. This bill would require a foreign limited liability company that adopts a new name to relinquish an alternate name, as provided. This bill would additionally condition reinstatement of a fraudulently terminated business entity upon the business entity concurrently submitting for filing an amendment to change its name to eliminate conflict, if there is a conflict with the entity name, as provided.

The people of the State of California do enact as follows:

1 SECTION 1. Section 109.5 of the Corporations Code is
2 amended to read:
3 109.5. (a) Provisions of the articles described in paragraph (3)
4 of subdivision (g) of Section 202 and subdivisions (a) and (b) of
5 Section 204 may be made dependent upon facts ascertainable
6 outside the articles, if the manner in which those facts shall operate
7 upon those provisions is clearly and expressly set forth in the
8 articles. Similarly, any of the terms of an agreement of merger
9 pursuant to Section 1101 may be made dependent upon facts
10 ascertainable outside that agreement, if the manner in which those
11 facts shall operate upon the terms of the agreement is clearly and
12 expressly set forth in the agreement of merger.
13 (b) Notwithstanding subdivision (a), when any provisions or
14 terms of articles or an agreement of merger are made dependent
15 upon facts ascertainable outside the filed instrument through a
16 reference to an agreement or similar document, the corporation
17 filing that instrument shall (1) maintain at its principal executive
18 office a copy of any such agreement or document and all
19 amendments and (2) provide to its shareholders, in the case of
20 articles, or to shareholders of any constituent corporation, in the

1 case of an agreement of merger, a copy of them upon written
2 request and without charge.

3 (c) If the reference to an agreement or contract is a reference to
4 an agreement or contract to which the corporation is a party (a
5 “referenced agreement” in this section), any amendment or revision
6 of the referenced agreement requires shareholder approval, in
7 addition to approvals otherwise required, in the following instances
8 and no other:

9 (1) If the amendment or revision of the referenced agreement
10 would result in a material change in the rights, preferences,
11 privileges, or restrictions of a class or series of shares, the
12 amendment or revision of the referenced agreement is required to
13 be approved by the outstanding shares (Section 152) of that class
14 or series.

15 (2) If the amendment or revision of the referenced agreement
16 would result in a material change in the rights or liabilities of any
17 class or series of shares with respect to the subject matter of
18 paragraph (1), (2), (3), (5), or (9) of subdivision (a) of Section 204,
19 the amendment or revision of the referenced agreement is required
20 to be approved by the outstanding shares (Section 152) of that
21 class or series.

22 (3) If the amendment or revision of the referenced agreement
23 would result in a material change in the restrictions on transfer or
24 hypothecation of any class or series of shares, the amendment or
25 revision of the referenced agreement is required to be approved
26 by the outstanding shares (Section 152) of that class or series.

27 (4) If the amendment or revision of the referenced agreement
28 would result in a change of any of the principal terms of an
29 agreement of merger, the amendment or revision of the referenced
30 agreement is required to be approved in the same manner as
31 required by Section 1104 for a change in the principal terms of an
32 agreement of merger.

33 SEC. 2. Section 1155 of the Corporations Code is amended to
34 read:

35 1155. (a) To convert a corporation:

36 (1) If the corporation is converting into a domestic limited
37 partnership, a statement of conversion shall be completed on the
38 certificate of limited partnership for the converted entity.

39 (2) If the corporation is converting into a domestic partnership,
40 a statement of conversion shall be completed on the statement of

1 partnership authority for the converted entity, or if no statement
2 of partnership authority is filed then a certificate of conversion
3 shall be filed separately.

4 (3) If the corporation is converting into a domestic limited
5 liability company, a statement of conversion shall be completed
6 on the articles of organization for the converted entity.

7 (4) If the corporation is converting into a flexible purpose
8 corporation, a statement of conversion shall be completed on the
9 articles for the converted entity.

10 (b) Any statement or certificate of conversion of a converting
11 corporation shall be executed and acknowledged by those officers
12 of the converting corporation as would be required to sign an
13 officers' certificate (Section 173), and shall set forth all of the
14 following:

15 (1) The name *of the converting corporation* and the Secretary
16 of State's file number of the converting corporation.

17 (2) A statement of the total number of outstanding shares of
18 each class entitled to vote on the conversion, that the principal
19 terms of the plan of conversion were approved by a vote of the
20 number of shares of each class which equaled or exceeded the vote
21 required under Section 1152, specifying each class entitled to vote
22 and the percentage vote required of each class.

23 (3) The name, form, and jurisdiction of organization of the
24 converted entity.

25 (4) The name and street address of the corporation's agent for
26 service of process. If a corporation qualified under Section 1505
27 is designated, no address for it shall be set forth.

28 (c) For the purposes of this chapter, the certificate of conversion
29 shall be on a form prescribed by the Secretary of State.

30 (d) The filing with the Secretary of State of a statement of
31 conversion on an organizational document or a certificate of
32 conversion as set forth in subdivision (a) shall have the effect of
33 the filing of a certificate of dissolution by the converting
34 corporation and no converting corporation that has made the filing
35 is required to file a certificate of election under Section 1901 or a
36 certificate of dissolution under Section 1905 as a result of that
37 conversion.

38 (e) Upon the effectiveness of a conversion pursuant to this
39 chapter, a converted entity that is a flexible purpose corporation,
40 domestic partnership, domestic limited partnership, or domestic

1 limited liability company shall be deemed to have assumed the
2 liability of the converting corporation (1) to prepare and file or
3 cause to be prepared and filed all tax and information returns
4 otherwise required of the converting corporation under the
5 Corporation Tax Law (Part 11 (commencing with Section 23001)
6 of Division 2 of the Revenue and Taxation Code) and (2) to pay
7 any tax liability determined to be due pursuant to that law.

8 SEC. 3. Section 1503 of the Corporations Code is amended to
9 read:

10 1503. (a) An agent designated for service of process pursuant
11 to Section 202, 1502, 2105, or 2117 may deliver to the Secretary
12 of State, on a form prescribed by the Secretary of State for filing,
13 a signed and acknowledged written statement of resignation as an
14 agent for service of process. The form shall contain the name of
15 the corporation, the Secretary of State's file number of the
16 corporation, the name of the resigning agent for service of process,
17 and a statement that the agent is resigning. Thereupon the authority
18 of the agent to act in such capacity shall cease and the Secretary
19 of State forthwith shall mail or otherwise provide written notice
20 of the filing of the statement of resignation to the corporation at
21 its principal executive office.

22 (b) The resignation of an agent may be effective if, on a form
23 prescribed by the Secretary of State containing the name of the
24 corporation, the Secretary of State's file number for the corporation,
25 and the name of the resigning agent for service of process, the
26 agent disclaims having been properly appointed as the agent.
27 Similarly, a person named as an officer or director may indicate
28 that the person was never properly appointed as the officer or
29 director.

30 (c) The Secretary of State may destroy or otherwise dispose of
31 any resignation filed pursuant to this section after a new form is
32 filed pursuant to Section 1502 or 2117 replacing the agent for
33 service of process that has resigned.

34 SEC. 4. Section 2101 of the Corporations Code is amended to
35 read:

36 2101. (a) Any foreign corporation (other than a foreign
37 association) not transacting intrastate business may register its
38 corporate name with the Secretary of State, provided its corporate
39 name would be available pursuant to Section 201 to a new

1 corporation organized under this division at the time of such
2 registration.

3 (b) Such registration may be made by filing (1) an application
4 for registration signed by a corporate officer stating the name of
5 the corporation, the state or place under the laws of which it is
6 incorporated, the date of its incorporation, and that it desires to
7 register its name under this section; and (2) a certificate of an
8 authorized public official of the state or place in which it is
9 organized stating that such corporation is in good standing under
10 those laws. Such registration shall be effective until the close of
11 the calendar year in which the application for registration is filed.

12 (c) A corporation that has in effect a registration of its corporate
13 name may renew such registration from year to year by annually
14 filing an application for renewal setting forth the facts required to
15 be set forth in an original application for registration and a
16 certificate of good standing as required for the original registration
17 between the first day of October and the 31st day of December in
18 each year. Such renewal application shall extend the registration
19 for the following calendar year.

20 (d) A corporation that has in effect a registration of its corporate
21 name may cancel the registration by delivering to the Secretary of
22 State, on a form prescribed by the Secretary of State for filing, a
23 certificate of cancellation of foreign name registration signed by
24 a corporate officer containing the name of the corporation and the
25 Secretary of State's file number of the corporation.

26 SEC. 5. Section 2105 of the Corporations Code is amended to
27 read:

28 2105. (a) A foreign corporation shall not transact intrastate
29 business without having first obtained from the Secretary of State
30 a certificate of qualification. To obtain that certificate it shall file,
31 on a form prescribed by the Secretary of State, a statement and
32 designation signed by a corporate officer or, in the case of a foreign
33 association that has no officers, signed by a trustee stating:

34 (1) Its name and the state or place of its incorporation or
35 organization.

36 (2) The street address of its principal executive office.

37 (3) The street address of its principal office within this state, if
38 any.

1 (4) The mailing address of its principal executive office, if
2 different from the addresses specified pursuant to paragraphs (2)
3 and (3).

4 (5) The name of an agent upon whom process directed to the
5 corporation may be served within this state. The designation shall
6 comply with the provisions of subdivision (b) of Section 1502.

7 (6) (A) Its irrevocable consent to service of process directed to
8 it upon the agent designated and to service of process on the
9 Secretary of State if the agent so designated or the agent's successor
10 is no longer authorized to act or cannot be found at the address
11 given.

12 (B) Consent under this paragraph extends to service of process
13 directed to the foreign corporation's agent in California for a search
14 warrant issued pursuant to Section 1524.2 of the Penal Code, or
15 for any other validly issued and properly served search warrant,
16 for records or documents that are in the possession of the foreign
17 corporation and are located inside or outside of this state. This
18 subparagraph shall apply to a foreign corporation that is a party
19 or a nonparty to the matter for which the search warrant is sought.
20 For purposes of this subparagraph, "properly served" means
21 delivered by hand, or in a manner reasonably allowing for proof
22 of delivery if delivered by United States mail, overnight delivery
23 service, or facsimile to a person or entity listed in Section 2110.

24 (7) If it is a corporation which will be subject to the Insurance
25 Code as an insurer, it shall so state that fact.

26 (b) Annexed to that statement and designation shall be a
27 certificate by an authorized public official of the state or place of
28 incorporation of the corporation to the effect that the corporation
29 is an existing corporation in good standing in that state or place
30 or, in the case of an association, an officers' certificate stating that
31 it is a validly organized and existing business association under
32 the laws of a specified foreign jurisdiction.

33 (c) Before it may be designated by any foreign corporation as
34 its agent for service of process, any corporate agent must comply
35 with Section 1505.

36 SEC. 6. Section 2107 of the Corporations Code is amended to
37 read:

38 2107. (a) If any foreign corporation (but not a foreign
39 association) qualified to transact intrastate business shall change
40 its name or make a change affecting an assumed name under

1 Section 2106, it shall file, on a form prescribed by the Secretary
2 of State, an amended statement signed by a corporate officer setting
3 forth the change made. The amended statement shall set forth the
4 name relinquished as well as the new name assumed and there
5 shall be annexed to the amended statement a certificate of an
6 authorized public official of its state or place of incorporation that
7 the change of name was made in accordance with the laws of that
8 state or place. Upon the filing of the amended statement, the
9 Secretary of State shall issue a new certificate of qualification.

10 (b) If any foreign association qualified to transact intrastate
11 business shall change its name, the address of its principal office
12 in this state, the address of its principal executive office or its agent
13 for the service of process, or if the stated address of any natural
14 person designated as agent is changed, it shall file, on a form
15 prescribed by the Secretary of State, an amended statement and
16 designation signed by an officer or, in the case of a foreign
17 association that has no officers, signed by a trustee setting forth
18 the change or changes made. In the case of a change of name, the
19 amended statement and designation shall set forth the name
20 relinquished as well as the new name assumed and there shall be
21 annexed to the amended statement and designation an officer's
22 certificate, or trustee's certificate, if applicable, stating that such
23 change of name was made in accordance with its declaration of
24 trust. If the change includes a change of name, or a change affecting
25 an assumed name pursuant to Section 2106, upon the filing of the
26 amended statement, the Secretary of State shall issue a new
27 certificate of qualification.

28 (c) If the change includes a change of name of an insurer subject
29 to the Insurance Code, the form shall include a statement that the
30 corporation is such an insurer if it does not already so appear.

31 (d) If a foreign corporation qualified to transact business in this
32 state shall change the address of its principal office in this state,
33 the address of its principal executive office, or its agent for the
34 service of process, or if the stated address of any natural person
35 designated as agent is changed, the filing of a statement pursuant
36 to Section 2117 shall supersede the statement and designation with
37 respect thereto.

38 SEC. 7. Section 2112 of the Corporations Code is amended to
39 read:

1 2112. (a) Subject to Section 2113, a foreign corporation which
2 has qualified to transact intrastate business may surrender its right
3 to engage in that business within this state by filing a certificate
4 of surrender signed by a corporate officer or, in the case of a
5 foreign association that has no officers, signed by a trustee stating:

6 (1) The name of the corporation as shown on the records of the
7 Secretary of State, and the state or place of incorporation or
8 organization.

9 (2) That it revokes its designation of agent for service of process.

10 (3) That it surrenders its authority to transact intrastate business.

11 (4) That it consents that process against it in any action upon
12 any liability or obligation incurred within this state prior to the
13 filing of the certificate of withdrawal may be served upon the
14 Secretary of State.

15 (5) A post office address to which the Secretary of State may
16 mail a copy of any process against the corporation that is served
17 upon the Secretary of State, which address or the name to which
18 the process should be sent may be changed from time to time by
19 filing a statement signed by a corporate officer or, in the case of
20 a foreign association that has no officers, signed by a trustee stating
21 the new address or name or both.

22 (6) Except in the case of a foreign association, that a final
23 franchise tax return, as described by Section 23332 of the Revenue
24 and Taxation Code, has been or will be filed with the Franchise
25 Tax Board, as required under Part 10.2 (commencing with Section
26 18401) of Division 2 of the Revenue and Taxation Code.

27 (b) The Secretary of State shall notify the Franchise Tax Board
28 of the surrender.

29 SEC. 8. Section 2204 of the Corporations Code is amended to
30 read:

31 2204. (a) Upon the failure of a corporation to file the statement
32 required by Section 1502, the Secretary of State shall provide a
33 notice of that delinquency to the corporation. The notice shall also
34 contain information concerning the application of this section,
35 advise the corporation of the penalty imposed by Section 19141
36 of the Revenue and Taxation Code for failure to timely file the
37 required statement after notice of the delinquency has been
38 provided by the Secretary of State, and shall advise the corporation
39 of its right to request relief from the Secretary of State because of
40 reasonable cause or unusual circumstances that justify the failure

1 to file. If, within 60 days of providing notice of the delinquency,
2 a statement pursuant to Section 1502 has not been filed by the
3 corporation, the Secretary of State shall certify the name of the
4 corporation to the Franchise Tax Board.

5 (b) Upon certification pursuant to subdivision (a), the Franchise
6 Tax Board shall assess against the corporation the penalty provided
7 in Section 19141 of the Revenue and Taxation Code.

8 (c) The penalty herein provided shall not apply to a corporation
9 that on or prior to the date of certification pursuant to subdivision
10 (a) has dissolved, has converted to another type of business entity,
11 or has been merged into another corporation or other business
12 entity.

13 (d) The penalty herein provided shall not apply and the Secretary
14 of State need not provide a notice of the delinquency to a
15 corporation if the corporate powers, rights, and privileges have
16 been suspended by the Franchise Tax Board pursuant to Section
17 23301, 23301.5, or 23775 of the Revenue and Taxation Code on
18 or prior to, and remain suspended on, the last day of the filing
19 period pursuant to Section 1502. The Secretary of State need not
20 provide notice of the filing requirement pursuant to Section 1502
21 to a corporation if the corporate powers, rights, and privileges have
22 been so suspended by the Franchise Tax Board on or prior to, and
23 remain suspended on, the day the Secretary of State prepares the
24 notice for sending.

25 (e) If, after certification pursuant to subdivision (a), the Secretary
26 of State finds (1) the required statement was filed before the
27 expiration of the 60-day period after providing notice of the
28 delinquency, or (2) the failure to provide notice of delinquency
29 was due to an error of the Secretary of State, the Secretary of State
30 shall promptly decertify the name of the corporation to the
31 Franchise Tax Board. The Franchise Tax Board shall then promptly
32 abate any penalty assessed against the corporation pursuant to
33 Section 19141 of the Revenue and Taxation Code.

34 (f) If the Secretary of State determines that the failure of a
35 corporation to file the statement required by Section 1502 is
36 excusable because of reasonable cause or unusual circumstances
37 that justify the failure, the Secretary of State may waive the penalty
38 imposed by this section and by Section 19141 of the Revenue and
39 Taxation Code, in which case the Secretary of State shall not certify
40 the name of the corporation to the Franchise Tax Board, or if

1 already certified, the Secretary of State shall promptly decertify
2 the name of the corporation.

3 SEC. 9. Section 3304 of the Corporations Code is amended to
4 read:

5 3304. (a) To convert a flexible purpose corporation:

6 (1) If the flexible purpose corporation is converting into a
7 domestic limited partnership, a statement of conversion shall be
8 completed on the certificate of limited partnership for the converted
9 entity.

10 (2) If the flexible purpose corporation is converting into a
11 domestic partnership, a statement of conversion shall be completed
12 on the statement of partnership authority for the converted entity,
13 or if no statement of partnership authority is filed, then a certificate
14 of conversion shall be filed separately.

15 (3) If the flexible purpose corporation is converting into a
16 domestic limited liability company, a statement of conversion shall
17 be completed on the articles of organization for the converted
18 entity.

19 (4) If the flexible purpose corporation is converting into a
20 domestic corporation, a statement of conversion shall be completed
21 on the articles for the converted entity.

22 (b) Any statement or certificate of conversion of a converting
23 flexible purpose corporation shall be executed and acknowledged
24 by those officers of the converting flexible purpose corporation as
25 would be required to sign an officers' certificate, and shall set forth
26 all of the following:

27 (1) The name and the Secretary of State's file number of the
28 converting flexible purpose corporation.

29 (2) A statement of the total number of outstanding shares of
30 each class entitled to vote on the conversion, that the principal
31 terms of the plan of conversion were approved by a vote of the
32 number of shares of each class which equaled or exceeded the vote
33 required under Section 3301, specifying each class entitled to vote
34 and the percentage vote required of each class.

35 (3) The name, form, and jurisdiction of organization of the
36 converted entity.

37 (4) The name and street address of the converted entity's agent
38 for service of process. If a corporation qualified under Section
39 1505 is designated as the agent, no address for it shall be set forth.

1 (c) The certificate of conversion shall be on a form prescribed
2 by the Secretary of State.

3 (d) The filing with the Secretary of State of a statement of
4 conversion on an organizational document or a certificate of
5 conversion as set forth in subdivision (a) shall have the effect of
6 the filing of a certificate of dissolution by the converting flexible
7 purpose corporation and no converting flexible purpose corporation
8 that has made the filing is required to file a certificate of election
9 under Section 1901 or a certificate of dissolution under Section
10 1905 as a result of that conversion.

11 (e) Upon the effectiveness of a conversion pursuant to this
12 chapter, a converted entity that is a domestic partnership, domestic
13 limited partnership, or domestic limited liability company shall
14 be deemed to have assumed the liability of the converting flexible
15 purpose corporation to prepare and file or cause to be prepared
16 and filed all tax and information returns otherwise required of the
17 converting flexible purpose corporation under the Corporation Tax
18 Law (Part 11 (commencing with Section 23001) of Division 2 of
19 the Revenue and Taxation Code) and to pay any tax liability
20 determined to be due pursuant to that law.

21 SEC. 10. Section 5120 of the Corporations Code is amended
22 to read:

23 5120. (a) One or more persons may form a corporation under
24 this part by executing and filing articles of incorporation.

25 (b) If initial directors are named in the articles, each director
26 named in the articles shall sign and acknowledge the articles; if
27 initial directors are not named in the articles, the articles shall be
28 signed by one or more persons who thereupon are the incorporators
29 of the corporation.

30 (c) The corporate existence begins upon the filing of the articles
31 and continues perpetually, unless otherwise expressly provided by
32 law or in the articles.

33 (d) At the time of filing pursuant to this section, the Secretary
34 of State shall forward a copy of the filed articles of incorporation
35 to the Attorney General.

36 (e) If the corporation was created by the elected legislative body
37 in order to exercise authority that may lawfully be delegated by
38 the elected governing body to a private corporation or other entity,
39 the Secretary of State shall forward a copy of the filed articles of
40 incorporation to the Controller.

1 SEC. 11. Section 5817 of the Corporations Code is amended
2 to read:

3 5817. Upon the filing of the certificate of amendment, the
4 articles shall be amended in accordance with the certificate and
5 any change, reclassification, or cancellation of memberships shall
6 be effected, and a copy of the certificate, certified by the Secretary
7 of State, is prima facie evidence of the performance of the
8 conditions necessary to the adoption of the amendment. The
9 Secretary of State shall forward a copy of the filed certificate of
10 amendment to the Attorney General.

11 SEC. 12. Section 6211 of the Corporations Code is amended
12 to read:

13 6211. (a) An agent designated for service of process pursuant
14 to Section 6210 may deliver to the Secretary of State, on a form
15 prescribed by the Secretary of State for filing, a signed and
16 acknowledged written statement of resignation as an agent for
17 service of process containing the name of the corporation, the
18 Secretary of State's file number of the corporation, the name of
19 the resigning agent for service of process, and a statement that the
20 agent is resigning. Thereupon the authority of the agent to act in
21 that capacity shall cease and the Secretary of State forthwith shall
22 mail or otherwise provide written notice of the filing of the
23 statement of resignation to the corporation at its principal office.

24 (b) The resignation of an agent may be effective if, on a form
25 prescribed by the Secretary of State containing the name of the
26 corporation, the Secretary of State's file number for the corporation,
27 and the name of the agent for service of process, the agent disclaims
28 having been properly appointed as the agent. Similarly, a person
29 named as an officer or director may indicate that the person was
30 never properly appointed as the officer or director.

31 (c) The Secretary of State may destroy or otherwise dispose of
32 any resignation filed pursuant to this section after a new form is
33 filed pursuant to Section 6210 replacing the agent for service of
34 process that has resigned.

35 SEC. 13. Section 6611 of the Corporations Code is amended
36 to read:

37 6611. (a) Whenever a corporation has elected to wind up and
38 dissolve a certificate evidencing that election shall forthwith be
39 filed and a copy thereof filed with the Attorney General.

1 (b) The certificate shall be an officers’ certificate or shall be
2 signed and verified by at least a majority of the directors then in
3 office or by one or more members authorized to do so by approval

29 credit union's designee to receive those notices; and (5) the mailing
30 address of the credit union, if different from the street address of
31 its principal office.

32 (b) The statement required by subdivision (a) shall also
33 designate, as the agent of the credit union for the purpose of service
34 of process, a natural person residing in this state or any domestic
35 or foreign business corporation that has complied with Section
36 1505 of the Corporations Code and whose capacity to act as an
37 agent has not terminated. If a natural person is designated, the
38 statement shall set forth that person's complete business or
39 residence street address. If a corporate agent is designated, no
40 address for it shall be set forth.

1 (c) For the purposes of this section, the applicable filing period
2 for a credit union shall be the calendar month during which its
3 original articles were filed and the immediately preceding five
4 calendar months. The Secretary of State shall provide a notice to
5 each credit union to comply with this section approximately three
6 months prior to the close of the applicable filing period. The notice
7 shall state the due date for compliance and shall be sent to the last
8 address of the credit union according to the records of the Secretary
9 of State if the credit union has elected to receive notices from the
10 Secretary of State by electronic mail. Neither the failure of the
11 Secretary of State to provide the notice nor the failure of the credit
12 union to receive it is an excuse for failure to comply with this
13 section.

14 (d) Whenever any of the information required by subdivision
15 (a) is changed, the credit union may file a current statement
16 containing all the information required thereby. In order to change
17 its agent for service of process or the address of the agent, the
18 corporation must file a current statement containing all the
19 information required by subdivisions (a) and (b). Whenever any
20 statement is filed pursuant to this section, it supersedes any
21 previously filed statement and the statement in the articles as to
22 the agent for service of process and the address of the agent.

23 (e) An agent designated for service of process pursuant to
24 subdivision (b) may deliver to the Secretary of State, on a form
25 prescribed by the Secretary of State for filing, a signed and
26 acknowledged written statement of resignation as an agent for
27 service of process containing the name of the credit union and
28 Secretary of State's file number of the credit union, the name of
29 the agent, and a statement that the agent is resigning. Thereupon
30 the authority of the agent to act in such capacity shall cease and
31 the Secretary of State forthwith shall notify the credit union of the
32 filing of the statement of resignation.

33 (f) If a natural person who has been designated agent for service
34 of process pursuant to subdivision (b) dies or resigns or no longer
35 resides in the state, or if the corporate agent for such purpose
36 resigns, dissolves, withdraws from the state, forfeits its right to
37 transact intrastate business, has its corporate rights, powers, and
38 privileges suspended or ceases to exist, the credit union shall
39 forthwith file a new statement designating a new agent conforming
40 to the requirements of subdivision (a).

1 (g) The resignation of an agent may be effective if, on a form
2 prescribed by the Secretary of State containing the name of the
3 credit union and Secretary of State's file number for the credit
4 union and the name of the agent for service of process, the agent
5 disclaims having been properly appointed as the agent.

6 (h) The Secretary of State may destroy or otherwise dispose of
7 any statement or resignation filed pursuant to this section after it
8 has been superseded by the filing of a new statement.

9 (i) This section shall not be construed to place any person
10 dealing with the credit union on notice of or in any duty to inquire
11 about the existence or content of the statement filed pursuant to
12 this section.

31 (2) That if there is a conflict with the entity name under

35 15901.08, subdivision (b) of Section 17701.08 of the Corporations
