An act to add ~~Section~~ *Sections 66010.96 and 66010.97* to the Education Code, relating to public postsecondary education.

LEGISLATIVE COUNSEL'S DIGEST

SB 1196, as amended, Liu. Public postsecondary education: state goals.

Existing law establishes the University of California, under the administration of the Regents of the University of California, the California State University, under the administration of the Trustees of the California State University, and the California Community Colleges, under the administration of the Board of Governors of the California Community Colleges, as the 3 public segments of postsecondary education in this state.

Existing law states the intent of the Legislature that budget and policy decisions regarding postsecondary education generally adhere to 3 specified goals and that appropriate metrics be identified, defined, and formally adopted, based upon metrics recommended by a working group, to monitor progress toward the achievement of the goals.

*This bill would require the Governor, or the Governor's designee, in consultation with private industry and policy research entities, to identify and establish specific postsecondary educational attainment goals for the segments of postsecondary education in the state that satisfy specified criteria and a target date for the segments to achieve these goals. The bill would require the trustees, the board of governors, and, as a condition to receiving a General Fund appropriation from the*

state, the regents to each develop and adopt a 5-year plan for making progress toward these statewide goals, *and would require the Governor, or the Governor’s designee, to convene a technical working group to aid in the development of the 5-year plan, as specified.* The bill would require the 5-year plan to include, but not necessarily be limited to, specific goals for satisfying *the statewide attainment goals and performance measures specified for each segment, respectively.* The bill would also require the California State University, the California Community Colleges, and the University of California to report to the Legislature on the 5-year plans annually until January 1, 2021, as specified.

*The people of the State of California do enact as follows:*

1     SECTION 1. Section 66010.96 is added to the Education Code,

 3     66010.96. (a) *The Governor, or the Governor’s designee,*  
 4     *shall, in consultation with private industry and policy research*  
 5     *entities, identify and establish specific educational attainment*  
 6     *goals for the segments of postsecondary education in the state and*  
 7     *a target date for these segments to achieve these goals.*  
 8     (b) *It is the intent of the Legislature that the goals established*  
 9     *pursuant to subdivision (a) satisfy all of the following:*  
 10    (1) *They shall be challenging and quantifiable.*  
 11    (2) *They shall address achievement gaps for underrepresented*  
 12    *populations.*  
 13    (3) *They shall increase and align the educational attainment of*  
 14    *California’s adult population to the workforce and economic needs*  
 15    *of the state.*  
 16    (4) *They shall be guided by the statewide goals in Section*  
 17    *66010.91.*  
 18    (5) *They shall guide the development of the five-year plans*

2 66010.97. (a) The Trustees of the California State University,  
3 the Board of Governors of the California Community Colleges,  
4 and as a condition of receiving a General Fund appropriation from  
5 the state, the Regents of the University of California, shall each  
6 develop and adopt a five-year plan for making progress toward  
7 the statewide goals outlined in Section 66010.91.

8 (b) (1) *The Governor, or the Governor’s designee, shall convene*  
9 *a technical working group to advise in the development of the*  
10 *five-year plans required pursuant to subdivision (a). The technical*  
11 *working group shall include all of the following:*

12 (A) *One representative from each of the segments of public*  
13 *postsecondary education.*

14 (B) *One representative from the Department of Finance.*

15 (C) *At least one, but no more than three, members with expertise*  
16 *in statewide accountability efforts.*

17 (D) *A representative of the Legislative Analyst’s Office.*

18 (2) *The technical working group shall do all of the following:*

19 (A) *Identify and define specific metrics for measuring*  
20 *performance and progress towards satisfying the statewide goals*  
21 *in Section 66010.91 that align with the performance measures of*  
22 *the California State University in Section 89295, the University*  
23 *of California in Section 92675, and the California Community*  
24 *Colleges pursuant to the outcome priorities provided in the*  
25 *provisions of Chapter 581 of the Statutes of 2004. These metrics*  
26 *shall include performance measures for the awarding degrees and*  
27 *graduating students with job skills that align with California’s*  
28 *workforce and economic needs.*

29 (B) *Develop a coordinated and centralized process for collecting*  
30 *and reporting information required in the five-year plans.*

31 (C) *Determine and prescribe reporting data informational*  
32 *definitions, data informational sources, timeframes, and any other*  
33 *definitions, in order to align reporting of the five-year plans across*  
34 *the three segments of public postsecondary education.*

35 (D) *Provide the results of its efforts pursuant to subparagraphs*  
36 *(A), (B), and (C) to the California State University, the University*  
37 *of California, and the California Community Colleges by January*  
38 *31, 2015, for the development of their respective five-year plans*

24 (2) *Collaborate across their respective segments of*

29 Colleges, and *the* University of California shall annually report to

34 (f) (1) The requirement for submitting a report imposed under
