An act to add Section 18941.11 to the Health and Safety Code, relating to building standards.

LEGISLATIVE COUNSEL'S DIGEST

SB 1358, as amended, Wolk. Building standards: baby diaper changing stations.

The California Building Standards Law provides for the adoption of building standards by state agencies by requiring all state agencies that adopt or propose adoption of any building standard to submit building standards to the California Building Standards Commission for approval and adoption. In the absence of a designated state agency, the commission is required to adopt specific building standards, as prescribed. Existing law requires the commission to publish, or cause to be published, editions of the California Building Standards Code in its entirety once every 3 years.

This bill would require the commission, commencing with the next triennial edition of the California Building Standards Code adopted

after January 1, 2015, to adopt, approve, codify, and publish mandatory building standards for the installation of baby diaper changing accommodations in restroom facilities in ~~places of public accommodation~~, *public use spaces*, as specified.

The people of the State of California do enact as follows:

1 SECTION 1. Section 18941.11 is added to the Health and
2 Safety Code, to read:

3 18941.11. (a) The commission shall, commencing with the
4 next triennial edition of the California Building Standards Code
5 (Title 24 of the California Code of Regulations) adopted after
6 January 1, 2015, adopt, approve, codify, and publish mandatory
7 building standards for the installation of baby diaper changing
8 accommodations in restroom facilities in ~~places of public~~
9 ~~accommodation~~ *public use areas*. These building standards shall
10 apply to newly constructed restrooms and to renovated restrooms
11 for which the renovation requires a building permit and the value
12 of the renovation to the restroom exceeds ten thousand dollars
13 (\$10,000).

14 (b) The commission may expend funds from the Building
15 Standards Administration Special Revolving Fund, upon
16 appropriation pursuant to Section 18931.7, for the development
17 and the adoption of these standards.

18 (c) *For purposes of this section, “public use area” means*
19 *interior or exterior rooms, spaces, or elements that are made*
20 *available to the public.*
