Assembly Concurrent Resolution No. 89—Relative to the Connie Worden-Roberts Memorial Bridge.

LEGISLATIVE COUNSEL’S DIGEST

ACR 89, as amended, Wilk. Connie Worden-Roberts Memorial Bridge.

This measure would designate the Golden Valley Road Bridge over State Highway Route 14 in the City of Santa Clarita as the Connie Worden-Roberts Memorial Bridge. The measure would request the Department of Transportation to determine the cost for appropriate signs showing this special designation and, upon receiving donations from nonstate sources covering that cost, to erect those signs.

Fiscal committee: yes.

- 1 WHEREAS, Connie Worden-Roberts demonstrated
2 extraordinary service to the Santa Clarita Valley community and
3 was known as the Santa Clarita Valley’s “Road Warrior”; and
4 WHEREAS, Connie Worden-Roberts championed the
5 development of the valley’s transportation network for nearly four
6 decades, serving as the vice-chair of the City of Santa Clarita
7 Formation Committee and serving on the city’s first planning
8 commission; and

1 WHEREAS, Connie Worden-Roberts also served as chairwoman
2 of the League of Women Voters of Los Angeles County, founder
3 of the Valley Industry Association, former chairwoman of the
4 board and director of the Santa Clarita Valley Chamber of
5 Commerce, and as a member of many more community
6 organizations; and

7 WHEREAS, Connie Worden-Roberts was an early visionary
8 and tireless advocate for the Golden Valley Road Bridge project,
9 knowing it was necessary to meet the needs of the growing valley;
10 and

11 WHEREAS, Connie Worden-Roberts passed away on August
12 12, 2014; and

13 WHEREAS, Designating the Golden Valley Road Bridge over
14 State Highway Route 14 in the City of Santa Clarita as the Connie
15 Worden-Roberts Memorial Bridge would be an appropriate honor
16 for this community champion; now, therefore, be it

17 *Resolved by the Assembly of the State of California, the Senate*
18 *thereof concurring*, That the Legislature hereby designates the
19 Golden Valley Road Bridge over State Highway Route 14 in the
20 City of Santa Clarita as the Connie Worden-Roberts Memorial
21 Bridge; and be it further

22 *Resolved*, That the Department of Transportation is requested
23 to determine the cost of erecting appropriate signs, consistent with
24 the signing requirements for the state highway ~~system~~ *system*,
25 showing this special designation and, upon receiving donations
26 from nonstate sources covering that cost, to erect those signs; and
27 be it further

28 *Resolved*, That the Chief Clerk of the Assembly transmit copies
29 of this resolution to the Director of Transportation and to the author
30 for appropriate distribution.
