An act to add Section 66073 to the Education Code, relating to postsecondary education.

LEGISLATIVE COUNSEL'S DIGEST

AB 340, as amended, Weber. Postsecondary education: campus climate: report.

Existing law establishes the segments of the public postsecondary education system in the state, including the University of California administered by the Regents of the University of California, the California State University administered by the Trustees of the California State University, and the California Community Colleges administered by the Board of Governors of the California Community Colleges.

This bill would require the board and the trustees, and encourage the regents, to each generate a report once every biennium of the legislative session, commencing with the 2017–18 Regular Session, that includes specified information related to the segment's campus climate, as defined, post the report on its Internet Web site, and submit ~~that~~ *the* report to specified state bodies.

The people of the State of California do enact as follows:

1 SECTION 1. Section 66073 is added to the Education Code,

 3 66073. (a) The Board of Governors of the California
 4 Community Colleges and the Trustees of the California State
 5 University are required, and the Regents of the University of
 6 California are encouraged, to generate a report once every biennium
 7 of the legislative session, commencing with the 2017–18 Regular
 8 Session, that shall include, but not be limited to, all of the following
 9 as to the respective segment:

 12 (1) New and recent administrative efforts intended to affect
 13 campus climate.

 19 (B) Race.

 31 Disclosure of Campus Security Policy and Campus Crime Statistics
 32 Act (20 U.S.C. Sec. 1092(f)) and other hate crime statistics.
 33 (b) The Board of Governors of the California Community
 34 Colleges and the Trustees of the California State University are
 35 required, and the Regents of the University of California are

2 Internet Web site.

3 (c) The report to be generated pursuant to subdivision (a) shall
4 be sent to the Governor, the Attorney General, and the appropriate
5 policy committees of the Legislature.

6 (d) For purposes of this section, "campus climate" means a
7 measure of an individual's experience within a learning
8 environment, specifically focusing on the current attitudes,
9 practices, policies, and behaviors of campus life that impact the
10 success and retention of all members of a campus community.
