An act to add Section 12107 to the Public Contracts Code, relating to public contracts.

LEGISLATIVE COUNSEL'S DIGEST

AB 522, as amended, Burke. Public contracts: information technology: contractor performance assessment report.

Existing law establishes in state government the Department of Technology within the Government Operations Agency. Existing law provides that the Department of Technology is responsible for the approval and oversight of specified information technology projects.

Existing law sets forth requirements for the acquisition of goods and services by state agencies and sets forth the various responsibilities of the Department of General Services and other state agencies in overseeing and implementing state contracting procedures and policies. Existing law generally requires that all contracts for the acquisition of information technology goods or services be made by or under the supervision of the Department of General Services.

This bill would require ~~the Director of General Services and the Director of Technology~~ *Technology*, by January 1, 2017, to develop a standardized contractor performance assessment report system to evaluate the performance of a contractor on any information technology contract or ~~project~~, *project reportable to the Department of Technology*, as provided. The bill would ~~also require the Director of General Services~~

and the Director of Technology to implement that evaluation system for all subsequent reportable information technology contracts and projects, and would require that system to be used in addition to any other procurement procedures when evaluating or awarding those contracts or projects.

The people of the State of California do enact as follows:

1 SECTION 1. Section 12107 is added to the Public Contract
2 Code, to read:

3 12107. (a) (1) On or before January 1, 2017, ~~the Director of~~
4 ~~General Services~~ and the Director of Technology shall develop a
5 standardized contractor performance assessment report system to
6 evaluate the performance of a contractor on any *information*
7 *technology contract or project reportable under Chapter 4800 of*
8 *the State Administrative Manual* entered into pursuant to this
9 chapter.

10 (2) The contractor performance assessment report system shall
11 include, but is not limited to, an objective evaluation of the
12 performance of the contractor, information about the type of
13 contract or project and whether or not that contract or project was
14 completed on time, and information about the number of completed
15 contracts or projects by the contractor.

16 (b) (1) Upon the development of the contractor performance
17 assessment report system described in subdivision (a), ~~the Director~~
18 ~~of General Services~~ and the Director of Technology shall
19 implement the contractor performance assessment report system
20 for all information technology contracts and projects *reportable*
21 *under Chapter 4800 of the State Administrative Manual* entered
22 into pursuant to this chapter.

23 (2) The contractor performance assessment report system shall,
24 in addition to any other applicable information technology
25 procurement procedures, be utilized to evaluate and award any
26 information technology contract or project awarded pursuant to
27 this chapter.
