ASSEMBLY BILL

An act to amend Section 8031 of, and to add Section 8024.8 to, the Business and Professions Code, relating to shorthand reporters.

LEGISLATIVE COUNSEL'S DIGEST

AB 804, as amended, Roger Hernández. Shorthand reporters: continuing education requirements.

Existing law provides for the certification and regulation of shorthand reporters by the Court Reporters Board of California in the Department of Consumer Affairs, and provides for the regulation of shorthand reporting schools by the board. Existing law provides for the renewal of a shorthand reporter's certificate if specified requirements are met. Existing law sets forth specified fees for the examination for, and the issuance and renewal of, a shorthand reporter's certificate.

This bill would require the board, on or before July 1, ~~2016~~, 2017, to adopt regulations to establish, for renewal of a shorthand reporter's certificate, minimum approved continuing education requirements, with certain exceptions, and would require the board to establish a procedure for approving providers of those continuing education courses, as specified. *The bill would also require the board to collaborate with the Judicial Council to develop a list of courses that satisfy the continuing education requirements of both these provisions and a specified rule, applicable to trial court personnel, of the California Rules of Court.*

The bill would also authorize the board to, by regulation, establish a fee for approval of those continuing education providers, not to exceed the reasonable regulatory costs, if any, to the board of approving those providers.

The people of the State of California do enact as follows:

1 SECTION 1. Section 8024.8 is added to the Business and
 2 Professions Code, to read:
 3 8024.8. (a) On or before July 1, ~~2016~~, 2017, the board shall
 4 adopt regulations to establish minimum continuing education
 5 requirements for renewal of a certificate issued pursuant to this
 6 chapter. No earlier than six months after the effective date of the
 7 regulations, to renew his or her certificate, a certificate holder
 8 shall, in addition to the requirements of Section 8024, submit to
 9 the board, on a form prescribed by the board, that he or she has
 10 completed the minimum continuing education requirements.
 11 (b) The board shall ensure that the continuing education required
 12 by this section is relevant to the practice of shorthand reporting.
 13 (c) *The board shall ensure that the continuing education*
 14 *required by this section includes a minimum of two hours of course*
 15 *credits in ethics and professional conduct of shorthand reporting.*
 16 (d) *The board shall ensure that the continuing education*
 17 *required by this section is not less than 8 hours and not more than*
 18 *12 hours of course credits every two years.*

 20 (e) The board shall also establish a procedure for approving
 21 providers of continuing education courses, and all providers of
 22 continuing education shall comply with procedures established by
 23 the board. The board may establish a fee for providers of continuing
 24 education courses pursuant to Section 8031. The board may revoke
 25 or deny the right of a provider to offer continuing education
 26 coursework pursuant to this section for failure to comply with the
 27 requirements of this section or any regulation adopted pursuant to
 28 this section.

 30 (f) The board may establish exceptions to the continuing
 31 education requirements of this section for a certificate holder who

1 cannot meet the continuing education requirements for reasons of
2 health, military service, or undue hardship.

4 (g) The continuing education requirements of this section shall
5 comply with the guidelines for mandatory continuing education
6 established by the Department of Consumer Affairs pursuant to
7 Section 166.

8 (h) *The board shall, in collaboration with the Judicial Council,*
9 *develop a list of courses that satisfy the requirements of both this*
10 *section and Rule 10.474 of Title 10 of the California Rules of Court.*
11 *The courses on this list may be used to satisfy the requirements of*
12 *both this section and Rule 10.474.*

14 (i) The board may adopt regulations as necessary to implement
15 this section.

16 SEC. 2. Section 8031 of the Business and Professions Code is
17 amended to read:

18 8031. The amount of the fees required by this chapter is that
19 fixed by the board in accordance with the following schedule:

20 (a) The fee for filing an application for each examination shall
21 be no more than forty dollars (\$40).

22 (b) The fee for examination and reexamination for the written
23 or practical part of the examination shall be in an amount fixed by
24 the board, which shall be equal to the actual cost of preparing,
25 administering, grading, and analyzing the examination, but shall
26 not exceed seventy-five dollars (\$75) for each separate part, for
27 each administration.

28 (c) The initial certificate fee is an amount equal to the renewal
29 fee in effect on the last regular renewal date before the date on
30 which the certificate is issued, except that, if the certificate will
31 expire less than 180 days after its issuance, then the fee is 50
32 percent of the renewal fee in effect on the last regular renewal date
33 before the date on which the certificate is issued, or fifty dollars
34 (\$50), whichever is greater. The board may, by appropriate
35 regulation, provide for the waiver or refund of the initial certificate
36 fee where the certificate is issued less than 45 days before the date
37 on which it will expire.

38 (d) By a resolution adopted by the board, a renewal fee may be
39 established in such amounts and at such times as the board may
40 deem appropriate to meet its operational expenses and funding

1 responsibilities as set forth in this chapter. The renewal fee shall
2 not be more than one hundred twenty-five dollars (\$125) nor less
3 than ten dollars (\$10) annually, with the following exception:

4 Any person who is employed full time by the State of California
5 as a hearing reporter and who does not otherwise render shorthand
6 reporting services for a fee shall be exempt from licensure while
7 in state employment and shall not be subject to the renewal fee
8 provisions of this subdivision until 30 days after leaving state
9 employment. The renewal fee shall, in addition to the amount fixed
10 by this subdivision, include any unpaid fees required by this section
11 plus any delinquency fee.

12 (e) The duplicate certificate fee shall be no greater than ten
13 dollars (\$10).

14 (f) The penalty for failure to notify the board of a change of
15 name or address as required by Section 8024.6 shall be no greater
16 than fifty dollars (\$50).

17 (g) The fee for approval of a continuing education provider shall
18 be fixed by the board through regulation in an amount to cover the
19 reasonable regulatory cost to the board of approving those
20 continuing education providers, but shall be no greater than forty
21 dollars (\$40).
