ASSEMBLY BILL

An act to amend Sections 11106, 16520, 23910, and 30105 of, and to add Chapter 3 (commencing with Section 29180) to Division 7 of Title 4 of Part 6 of, the Penal Code, relating to firearms.

LEGISLATIVE COUNSEL'S DIGEST

AB 857, as amended, Cooper. Firearms: identifying information.

Existing law authorizes the Department of Justice to assign a distinguishing number or mark of identification to any firearm whenever the firearm lacks a manufacturer's number or other mark of identification, or whenever the manufacturer's number or other mark of identification or distinguishing number or mark assigned by the department has been destroyed or obliterated.

This bill would, commencing July 1, 2018, *and subject to exceptions*, require a person who manufactures or assembles a firearm to first apply to the department for a unique serial number or other identifying mark, as provided. The bill would, by January 1, 2019, *and subject to exceptions*, require any person who, as of July 1, 2018, owns a firearm that does not bear a serial number to likewise apply to the department for a unique serial number or other mark of identification. The bill would, except as provided, prohibit the sale or transfer of ownership of a firearm manufactured or assembled pursuant to these provisions. The bill would prohibit a person from aiding in the manufacture or assembly of a firearm by a person who is prohibited from possessing a firearm. The bill would make a violation of these provisions a misdemeanor. By creating a new crime, this bill would impose a state-mandated local program.

The bill would require the department to issue a serial number or other identifying mark to an applicant meeting specified criteria and would allow the department to charge a fee to recover its costs associated with assigning a distinguishing number or mark pursuant to the above provisions.

This bill would make a conforming change.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

1 information provided to the department on the Dealers' Record of
2 Sale, the Law Enforcement Firearms Transfer (LEFT), as defined

4 pursuant to any provision listed in subdivision (a) of Section 16585,
5 Section 28255 or 29180, or any other law.

6 (B) The name and address of, and other information about, any
7 person (whether a dealer or a private party) from whom the owner
8 acquired or the person being loaned the particular firearm and
9 when the firearm was acquired or loaned as listed on the
10 information provided to the department on the Dealers' Record of
11 Sale, the LEFT, or reports made to the department pursuant to any
12 provision listed in subdivision (a) of Section 16585 or any other
13 law.

14 (C) Any waiting period exemption applicable to the transaction
15 which resulted in the owner of or the person being loaned the
16 particular firearm acquiring or being loaned that firearm.

17 (D) The manufacturer's name if stamped on the firearm, model
18 name or number if stamped on the firearm, and, if applicable, the
19 serial number, other number (if more than one serial number is
20 stamped on the firearm), caliber, type of firearm, if the firearm is
21 new or used, barrel length, and color of the firearm, or, if the
22 firearm is not a handgun and does not have a serial number or any
23 identification number or mark assigned to it, that shall be noted.

24 (3) Information in the registry referred to in this subdivision
25 shall, upon proper application therefor, be furnished to the officers
26 referred to in Section 11105, to a city attorney prosecuting a civil
27 action, solely for use in prosecuting that civil action and not for
28 any other purpose, or to the person listed in the registry as the
29 owner or person who is listed as being loaned the particular firearm.

30 (4) If any person is listed in the registry as the owner of a firearm
31 through a Dealers' Record of Sale prior to 1979, and the person
32 listed in the registry requests by letter that the Attorney General
33 store and keep the record electronically, as well as in the record's
34 existing photographic, photostatic, or nonerasable optically stored
35 form, the Attorney General shall do so within three working days
36 of receipt of the request. The Attorney General shall, in writing,
37 and as soon as practicable, notify the person requesting electronic
38 storage of the record that the request has been honored as required

28 inclusive, of Section 6211 of the Family Code and is being
29 prosecuted or is serving a sentence for the crime, or the subject of
30 the record is the subject of an emergency protective order, a
31 temporary restraining order, or an order after hearing, which is in
32 effect and has been issued by a family court under the Domestic
33 Violence Protection Act set forth in Division 10 (commencing
34 with Section 6200) of the Family Code.

35 (B) The information is disseminated only to the victim of the
36 crime or to the person who has obtained the emergency protective
37 order, the temporary restraining order, or the order after hearing
38 issued by the family court.

39 (C) Whenever a law enforcement officer disseminates the
40 information authorized by this subdivision, that officer or another

1 officer assigned to the case shall immediately provide the victim
2 of the crime with a “Victims of Domestic Violence” card, as
3 specified in subparagraph (H) of paragraph (9) of subdivision (c)
4 of Section 13701.

5 (3) The victim or person to whom information is disseminated
6 pursuant to this subdivision may disclose it as he or she deems
7 necessary to protect himself or herself or another person from
8 bodily harm by the person who is the subject of the record.

CHAPTER 3. ASSEMBLY OF FIREARMS

11 29180. (a) For purposes of this chapter, “manufacturing” or
12 “assembling” a firearm means to fabricate or construct a firearm,
13 or to fit together the component parts of a firearm to construct a
14 firearm.

15 (b) Commencing July 1, 2018, prior to manufacturing or
16 assembling a firearm, a person manufacturing or assembling the
17 firearm shall do all of the following:

18 (1) Apply to the Department of Justice for a unique serial
19 number or other mark of identification pursuant to Section 29182.

20 (2) (A) Within 10 days of manufacturing or assembling a
21 firearm in accordance with paragraph (1), the unique serial number
22 or other mark of identification provided by the department shall
23 be engraved or permanently affixed to the firearm in a manner that
24 meets or exceeds the requirements imposed on licensed importers
25 and licensed manufacturers of firearms pursuant to subsection (i)
26 of Section 923 of Title 18 of the United States Code and regulations
27 issued pursuant thereto.

28 (B) If the firearm is manufactured or assembled from polymer
29 plastic, 3.7 ounces of material type 17-4 PH stainless steel shall
30 be embedded within the plastic upon fabrication or construction
31 with the unique serial number engraved or otherwise permanently
32 affixed in a manner that meets or exceeds the requirements imposed
33 on licensed importers and licensed manufacturers of firearms
34 pursuant to subsection (i) of Section 923 of Title 18 of the United
35 States Code and regulations issued pursuant thereto.

36 (3) After the serial number provided by the department is
37 engraved or otherwise permanently affixed to the firearm, the
38 person shall notify the department of that fact in a manner and
39 within a time period specified by the department, and with
40 sufficient information to identify the owner of the firearm, the

1 unique serial number or mark of identification provided by the
2 department, and the firearm in a manner prescribed by the
3 department.

4 (c) By January 1, 2019, any person who, as of July 1, 2018,
5 owns a firearm that does not bear a serial number assigned to it
6 pursuant to either Section 23910 or pursuant to Chapter 44
7 (commencing with Section 921) of Part 1 of Title 18 of the United
8 States Code and the regulations issued pursuant thereto, shall do
9 all of the following:

10 (1) Apply to the Department of Justice for a unique serial
11 number or other mark of identification pursuant to Section 29182.

12 (2) Within 10 days of receiving a unique serial number or other
13 mark of identification from the department, the unique serial
14 number or other mark of identification provided by the department
15 shall be engraved or permanently affixed to the firearm in
16 accordance with regulations prescribed by the department pursuant
17 to Section 29182 and in a manner that meets or exceeds the
18 requirements imposed on licensed importers and licensed
19 manufacturers of firearms pursuant to subsection (i) of Section
20 923 of Title 18 of the United States Code and regulations issued
21 pursuant thereto.

22 (3) After the serial number provided by the department is
23 engraved or otherwise permanently affixed to the firearm, the
24 person shall notify the department of that fact in a manner and
25 within a time period specified by the department, and with
26 sufficient information to identify the owner of the firearm, the
27 unique serial number or mark of identification provided by the
28 department, and the firearm in a manner prescribed by the
29 department.

30 (d) (1) The sale or transfer of ownership of a firearm
31 manufactured or assembled pursuant to this section is prohibited.

32 (2) Paragraph (1) shall not apply to the transfer, surrender, or
33 sale of a firearm to a law enforcement agency.

34 (3) Any firearms surrendered, transferred, or sold to a local law
35 enforcement agency pursuant to paragraph (2) shall be destroyed
36 as provided in Section 18005.

38 31615, shall not apply to the transfer, sale, or surrender of firearms
39 to a law enforcement agency pursuant to paragraph (2).

1 (e) A person, corporation, or firm shall not knowingly allow,
2 facilitate, aid, or abet the manufacture or assembling of a firearm
3 pursuant to this section by a person who is within any of the classes
4 identified by Chapter 2 (commencing with Section 29800) or
5 Chapter 3 (commencing with Section 29900) of Division 9 of this
6 code, or Section 8100 or 8103 of the Welfare and Institutions Code.

7 (f) If the firearm is a handgun, a violation of this section is
8 punishable by imprisonment in a county jail not to exceed one
9 year, or by a fine not to exceed one thousand dollars (\$1,000), or
10 by both that fine and imprisonment. For all other firearms, a
11 violation of this section is punishable by imprisonment in a county
12 jail not to exceed six months, or by a fine not to exceed one
13 thousand dollars (\$1,000), or by both that fine and imprisonment.
14 Each firearm found to be in violation of this section constitutes a
15 distinct and separate offense. This section does not preclude
16 prosecution under any other law providing for a greater penalty.

37 29182. (a) (1) The Department of Justice shall accept
38 applications from, and shall grant applications in the form of serial
39 numbers pursuant to Section 23910 to, persons who wish to

1 manufacture or assemble firearms pursuant to subdivision (b) of
2 Section 29180.

3 (2) The Department of Justice shall accept applications from,
4 and shall grant applications in the form of serial numbers pursuant
5 to Section 23910 to, persons who wish to own a firearm described
6 in subdivision (c) of Section 29180.

7 (b) An application made pursuant to subdivision (a) shall only
8 be granted by the department if the applicant does all of the
9 following:

10 (1) For each transaction, completes a personal firearms eligibility
11 check, demonstrating that the applicant is not prohibited by state
12 or federal law from possessing, receiving, owning, or purchasing
13 a firearm.

14 (2) Presents proof of age and identity as specified in Section
15 16400. The applicant shall be 18 years of age or older to obtain a
16 unique serial number or mark of identification for a firearm that
17 is not a handgun, and shall be 21 years of age or older to obtain a

20 intends to manufacture or assemble, in a manner prescribed by the

26 (d) All applications shall be granted or denied within 15 calendar

37 fee for each distinguishing number or mark it issues in an amount

13 30105. (a) An individual may request that the Department of
 14 Justice perform a firearms eligibility check for that individual. The
 15 applicant requesting the eligibility check shall provide the personal
 16 information required by Section 28160 or 28165, as applicable,
 17 but not any information regarding any firearm, to the department,
 18 in an application specified by the department.

19 (b) The department shall charge a fee of twenty dollars (\$20)
 20 for performing the eligibility check authorized by this section, but
 21 not to exceed the actual processing costs of the department. After
 22 the department establishes fees sufficient to reimburse the
 23 department for processing costs, fees charged may increase at a
 24 rate not to exceed the legislatively approved cost-of-living
 25 adjustment for the department’s budget or as otherwise increased
 26 through the Budget Act.

27 (c) An applicant for the eligibility check pursuant to subdivision
 28 (a) shall complete the application, have it notarized by any licensed
 29 California Notary Public, and submit it by mail to the department.

30 (d) Upon receipt of a notarized application and fee, the
 31 department shall do all of the following:

32 (1) Examine its records, and the records it is authorized to
 33 request from the State Department of State Hospitals pursuant to
 34 Section 8104 of the Welfare and Institutions Code, to determine
 35 if the purchaser is prohibited by state or federal law from
 36 possessing, receiving, owning, or purchasing a firearm.

37 (2) Notify the applicant by mail of its determination of whether
 38 the applicant is prohibited by state or federal law from possessing,
 39 receiving, owning, or purchasing a firearm. The department’s
 40 notification shall state either “eligible to possess firearms as of the

1 date the check was completed” or “ineligible to possess firearms
2 as of the date the check was completed.”

3 (e) If the department determines that the information submitted
4 to it in the application contains any blank spaces, or inaccurate,
5 illegible, or incomplete information, preventing identification of
6 the applicant, or if the required fee is not submitted, the department
7 shall not be required to perform the firearms eligibility check.

8 (f) The department shall make applications to conduct a firearms
9 eligibility check as described in this section available to licensed
10 firearms dealers and on the department’s Internet Web site.

11 (g) The department shall be immune from any liability arising
12 out of the performance of the firearms eligibility check, or any
13 reliance upon the firearms eligibility check.

14 (h) Except as provided in Sections 29180 and 29182, a person
15 or agency shall not require or request an individual to obtain a
16 firearms eligibility check or notification of a firearms eligibility
17 check pursuant to this section. A violation of this subdivision is a
18 misdemeanor.

19 (i) The department shall include on the application specified in
20 subdivision (a) and the notification of eligibility specified in
21 subdivision (d) the following statements:

23 “No person or agency may require or request an individual to
24 obtain a firearms eligibility check or notification of firearms
25 eligibility check pursuant to Section 30105 of the Penal Code. A
26 violation of these provisions is a misdemeanor.”

28 “If the applicant for a firearms eligibility check purchases,
29 transfers, or receives a firearm through a licensed dealer as required
30 by law, a waiting period and background check are both required.”

32 SEC. 6. No reimbursement is required by this act pursuant to
