An act to amend Section 9873 of the Business and Professions Code, relating to consumer affairs.

LEGISLATIVE COUNSEL'S DIGEST

AB 1175, as introduced, Ridley-Thomas. Bureau of Electronic and Appliance Repair, Home Furnishings, and Thermal Insulation.

Existing law, the Electronic Appliance Repair Dealer Registration Law, provides for the licensure and regulation of electronic appliance and repair dealers by the Bureau of Electronic and Appliance Repair, Home Furnishings, and Thermal Insulation and makes a failure to comply with its provisions a crime. Existing law establishes the bureau under the supervision and control of the Director of Consumer Affairs. Existing law requires the director to administer and enforce those provisions relating to the licensure and regulation of electronic and appliance repair service dealers and persons engaged in various businesses associated with home furnishings.

Existing law establishes the maximum amount for the initial registration fee for each place of business in the state of an electronic repair industry service dealer, an appliance repair industry service dealer, a service contractor, a person who is engaged in business as both an electronic repair industry service dealer and appliance repair industry service dealer, a service contractor who is engaged in business as either an electronic repair industry service dealer or an appliance industry service dealer, and a service contractor who engages in both the electronic repair industry and the appliance repair industry as a service

dealer. Existing law requires a service dealer or service contractor who does not operate a place of business in the state, but engages in at least some of these activities in the state to pay these fees as if he or she had a place of business in the state.

This bill would increase the maximum amounts of the initial registration fees for each of the above described persons, as specified.

Existing law also establishes, among other things, the maximum amount for the annual registration renewal fee for each place of business for an electronic repair industry service dealer, an appliance repair industry dealer, a service contractor, and a service dealer who is engaged in business as both an electronic repair industry service dealer and an appliance repair industry service dealer.

This bill would increase the maximum amount for each of these annual registration renewal fees, as specified.

*The people of the State of California do enact as follows:*

1 SECTION 1. Section 9873 of the Business and Professions  
2 Code, as amended by Section 19 of Chapter 428 of the Statutes of  
3 2014, is amended to read:

4 9873. The fees prescribed by this chapter shall be set by the  
5 director by regulation, according to the following schedule:

6 (a) (1) The initial registration fee for an electronic repair  
7 industry service dealer or for an appliance repair industry service

10 initial registration fee for a service contractor is not more than

14 business as both an electronic repair industry service dealer and

17 each place of business in this state. The initial registration fee for  
18 a person who is a service contractor and engages in business as  
19 either an electronic repair industry service dealer or an appliance  
20 repair industry service dealer is not more than ~~two hundred forty~~

1 *three hundred* dollars ~~(\$240)~~ (\$300) for each place of business in  
2 this state.

3 (3) The initial registration fee for a person who engages in both  
4 the electronic repair industry and the appliance repair industry as  
5 a service dealer and is a service contractor is not more than ~~four~~  
6 *five* hundred dollars ~~(\$400)~~ (\$500) for each place of business in  
7 this state.

8 (4) A service dealer or service contractor who does not operate  
9 a place of business in this state, but engages in the electronic repair  
10 industry, the appliance repair industry, or sells, issues, or  
11 administers service contracts in this state shall pay the registration  
12 fee specified herein as if he or she had a place of business in this  
13 state.

14 (b) (1) The annual registration renewal fee for an electronic  
15 repair industry service dealer or for an appliance repair industry  
16 service dealer is not more than ~~one hundred sixty-five~~ *two hundred*  
17 dollars ~~(\$165)~~ (\$200) for each place of business in this state, if  
18 renewed prior to its expiration date. The annual registration renewal  
19 fee for a service contractor is ~~seventy-five~~ *ninety-five* dollars ~~(\$75)~~  
20 (\$95) for each place of business in this state, if renewed prior to  
21 its expiration date.

22 (2) The annual renewal fee for a service dealer who engages in  
23 the business as both an electronic repair industry service dealer  
24 and an appliance repair industry service dealer is not more than  
25 ~~three four~~ hundred dollars ~~(\$300)~~ (\$400) for each place of business  
26 in this state.

27 (3) The annual renewal fee for a service dealer who engages in  
28 the electronic repair industry and the appliance repair industry and  
29 is a service contractor is not more than ~~three four~~ hundred  
30 *seventy-five* dollars ~~(\$375)~~ (\$475) for each place of business in  
31 this state.

32 (4) A service dealer or service contractor who does not operate  
33 a place of business in this state, but who engages in the electronic  
34 repair industry, the appliance repair industry, or sells or issues  
35 service contracts in this state shall pay the registration fee specified  
36 herein as if he or she had a place of business in this state.

37 (c) The delinquency fee is an amount equal to 50 percent of the  
38 renewal fee for a license in effect on the date of renewal of the  
39 license, except as otherwise provided in Section 163.5.

1 (d) This section shall remain in effect only until January 1, 2019,  
2 and as of that date is repealed, unless a later enacted statute, which  
3 is enacted before January 1, 2019, deletes or extends that date.

5 as amended by Section 20 of Chapter 428 of the Statutes of 2014,  
6 is amended to read:

7 9873. The fees prescribed by this chapter shall be set by the  
8 director by regulation, according to the following schedule:

9 (a) The initial registration fee for an electronic repair industry  
10 service dealer or for an appliance repair industry service dealer is  
11 not more than ~~one hundred sixty-five~~ *two hundred five* dollars  
12 ~~(\$165)~~ *(\$205)* for each place of business in this state. The initial  
13 registration fee for a person who engages in business as both an  
14 electronic repair industry service dealer and an appliance repair  
15 industry service dealer is not more than ~~three hundred twenty-five~~  
16 *four hundred five* dollars ~~(\$325)~~ *(\$405)*.

17 (b) The annual registration renewal fee for an electronic repair  
18 industry service dealer or for an appliance repair industry service  
19 dealer is not more than ~~one hundred sixty-five~~ *two hundred* dollars  
20 ~~(\$165)~~ *(\$200)* for each place of business in this state, if renewed  
21 prior to its expiration date. The annual renewal fee for a service  
22 dealer who engages in the business as both an electronic repair  
23 industry service dealer and an appliance repair industry service  
24 dealer is not more than ~~three~~ *four* hundred dollars ~~(\$300)~~ *(\$400)*.

25 (c) The delinquency fee is an amount equal to 50 percent of the  
26 renewal fee for a license in effect on the date of renewal of the  
27 license, except as otherwise provided in Section 163.5.

28 (d) This section shall become operative on January 1, 2019.
