An act to add Section 53343.2 to the Government Code, relating to local government.

LEGISLATIVE COUNSEL'S DIGEST

AB 1666, as amended, Brough. Community facilities districts: reports. The Mello-Roos Community Facilities Act of 1982 authorizes the formation of a community facilities district to finance various services. The act requires a community facilities district formed after January 1, 1992, to prepare, if requested by a person who resides in or owns property in the district and within 120 days after the last day of each fiscal year, a separate document titled an "Annual Report."

This bill would require ~~the~~ a legislative body ~~to post, that has an Internet Web site, within 120 days after the last day of each fiscal year of the district, to display prominently on its Internet Web site; site a copy of that annual report, if requested, and other specific~~ information relating to bonded indebtedness incurred by the district, projects funded by, or that may be funded by, the district, expenses and costs of the district, and special taxes imposed by the ~~district, as specified.~~ district. By increasing the duties of local officials, this bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

29 SEC. 2. No reimbursement is required by this act pursuant to  
30 Section 6 of Article XIII B of the California Constitution because  
31 a local agency or school district has the authority to levy service  
32 charges, fees, or assessments sufficient to pay for the program or  
33 level of service mandated by this act, within the meaning of Section  
34 17556 of the Government Code.
