An act relating to state claims, *making an appropriation therefor*, and declaring the urgency thereof, to take effect immediately.

LEGISLATIVE COUNSEL'S DIGEST

AB 1701, as amended, Committee on Appropriations. State claims. Existing law requires the California Victim Compensation and Government Claims Board to ensure that all claims that have been approved by the board, and for which there exists no legally available appropriation, are submitted for legislative approval at least twice each calendar year.

~~This bill declares the intent of the Legislature to appropriate funds would appropriate \$448,458.22 from various funds to the Executive Officer of the California Victim Compensation and Government Claims Board for the payment of claims allowed by the board. The bill would authorize the Controller, upon request of the board, to transfer specified surcharges and fees on claims filed against the state to a specified item of the Budget Act of 2016. The bill would also require the board to provide a report of the amounts recovered pursuant to these provisions to the Department of Finance.~~

This bill would declare that it is to take effect immediately as an urgency statute.

The people of the State of California do enact as follows:

1 SECTION 1. (a) *The sum of four hundred forty-eight thousand*
2 *four hundred fifty-eight dollars and twenty-two cents (\$448,458.22)*
3 *is hereby appropriated from the various funds specified in*
4 *subdivision (b) to the Executive Officer of the California Victim*
5 *Compensation and Government Claims Board for the payment of*
6 *claims accepted by the board in accordance with the schedule set*
7 *forth in subdivision (b).*

8 (b) *Pursuant to subdivision (a), claims accepted by the*
9 *California Victim Compensation and Government Claims Board*
10 *shall be paid in accordance with the following schedule:*

1 *SEC. 2. Upon the request of the California Victim*
2 *Compensation and Government Claims Board, in a form prescribed*
3 *by the Controller, the Controller shall transfer surcharges and*
4 *fees from the Budget Act items of appropriation identified in*
5 *subdivision (b) of Section 1 of this act to Item 7870-001-0001 of*
6 *Section 2.00 of the Budget Act of 2016. For each Budget Act item*
7 *of appropriation, this amount shall not exceed the cumulative total*
8 *of the per claim filing fees authorized by subdivision (c) of Section*
9 *905.2 of the Government Code and the surcharge authorized by*
10 *subdivision (f) of Section 905.2 of the Government Code. For those*
11 *items in subdivision (b) that do not reflect a Budget Act*
12 *appropriation, the Controller shall transfer an amount not to*
13 *exceed the cumulative total of the per claim filing fees authorized*
14 *by subdivision (c) of Section 905.2 of the Government Code and*
15 *the surcharge authorized by subdivision (f) of Section 905.2 of the*

25 *SEC. 3. This act is an urgency statute necessary for the*
26 *immediate preservation of the public peace, health, or safety within*
27 *the meaning of Article IV of the Constitution and shall go into*
28 *immediate effect. The facts constituting the necessity are:*

29 *In order to pay settle claims against the state and end hardship*
30 *to claimants as quickly as possible, it is necessary that this bill go*
31 *into immediate effect.*
