An act to add Section 68052.1 to the Education Code, relating to the University of California: *California*, and declaring the urgency thereof, to take effect immediately.

LEGISLATIVE COUNSEL'S DIGEST

AB 1711, as amended, McCarty. University of California: nonresident student enrollment.

Existing law expresses the intent of the Legislature that the University of California establish nonresident student tuition policies that are consistent with their resident student fee policies. The provisions are applicable to the University of California only if the Regents of the University of California act, by resolution, to make them applicable.

This bill would require the University of California, *in collaboration with the Academic Senate of the University of California*, as a condition of receipt of funds appropriated in the annual Budget Act, to ~~establish a policy to require each campus to admit only nonresident undergraduate~~

~~students who exceed the academic qualifications of resident undergraduate students, as specified; ensure that implementation of any admissions policy regarding admission of nonresident undergraduate students includes guidance that ensures the academic qualifications for admitted nonresident undergraduate students generally exceeds the academic qualifications of resident undergraduate students, and would require the University of California to report specified information to the Legislature annually regarding actions taken to ensure compliance with implementation of the policy.~~

This bill would declare that it is to take effect immediately as an urgency statute.

The people of the State of California do enact as follows:

1 SECTION 1. Section 68052.1 is added to the Education Code,
2 to read:
3 68052.1. As a condition of receipt of funds appropriated in the
4 annual Budget Act, and notwithstanding Section 68134, the
5 University of California shall comply with both of the following:
6 (a) By July 1, 2017, the University of California shall establish
7 a policy California, in collaboration with the Academic Senate of
8 the University of California, shall ensure that implementation of
9 any admissions policy it adopts regarding admission of nonresident
10 undergraduate students to require that each campus of the
11 University of California admit to that campus only shall include
12 guidance that ensures that the academic qualifications for admitted
13 nonresident undergraduate students who exceed the generally
14 exceeds, on average, the academic qualifications of resident
15 undergraduate students admitted to that campus and, in that regard,
16 would stand in the upper one-half of the resident undergraduate
17 students admitted at that specific each campus.
18 (b) The University of California shall report to the Legislature
19 annually regarding actions taken to ensure compliance with
20 implementation of this policy, including, but not limited to, the
21 mean and median scores on academic indicators used in the
22 admission process, the median score of admitted resident and
23 nonresident undergraduate students for each indicator at each
24 campus, and the number of admitted nonresident undergraduate

3 *SEC. 2. This act is an urgency statute necessary for the*
4 *immediate preservation of the public peace, health, or safety within*
5 *the meaning of Article IV of the Constitution and shall go into*
6 *immediate effect. The facts constituting the necessity are:*

7 *In order to ensure the University of California and the Academic*
8 *Senate review policies regarding the academic qualifications of*
9 *nonresident undergraduate students at the earliest possible time,*
10 *it is necessary that this act take effect immediately.*
