An act to add *and repeal* Section ~~68130.6~~ to, and to add Chapter ~~3.67~~ (commencing with Section ~~44778~~) to Part 25 of Division 3 of Title 2 of, ~~66021.8~~ of the Education Code, relating to student support services.

LEGISLATIVE COUNSEL'S DIGEST

AB 2009, as amended, Lopez. Student support services: Dream Resource Liaisons.

(1) Existing law establishes the segments of the public postsecondary education system in the state, including the University of California administered by the Regents of the University of California, the California State University administered by the Trustees of the California State University, and the California Community Colleges administered by the Board of Governors of the California Community Colleges.

Existing law provides that a student, other than a nonimmigrant alien, as defined, who has attended high school in California for 3 or more years, who has graduated from a California high school or attained the equivalent thereof, who has registered at or attends an accredited institution of higher education in California not earlier than the fall semester or quarter of the 2001–02 academic year, and who, if he or she is an alien without lawful immigration status, has filed an affidavit, as specified, is exempt from paying nonresident tuition at the California Community Colleges and the California State University.

This bill would, commencing with the 2017–18 academic year, require the California Community Colleges and the California State University, and would request the University of California to designate a Dream Resource Liaison on each of their respective campuses, as specified, to assist students meeting specified requirements, including undocumented students, by streamlining access to all available financial aid and academic opportunities for those students. By requiring community colleges to designate a Dream Resource Liaison, this bill would impose a state-mandated local program. The bill would encourage those institutions to establish Dream Resource Centers, and would authorize those centers to provide specified support services.

This bill would authorize the trustees, the board of governors, and the regents to seek and accept on behalf of the state any gift, bequest, devise, or donation whenever the gift and the terms and conditions thereof will aid in the creation and operation of Dream Resource Centers for their respective systems.

~~(2) Existing law establishes a system of public elementary and secondary schools in this state, and authorizes local educational agencies throughout the state to operate schools and provide instruction to pupils in kindergarten and grades 1 to 12, inclusive.~~

~~This bill would encourage the governing board of a school district or county office of education that maintains any of grades 9 to 12, inclusive, to have a Dream Resource Liaison at each of their respective campuses that includes any of those grades.~~

*This bill would make these provisions inoperative on July 1, 2022, and would repeal them as of January 1, 2023.*

(2) The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to these statutory provisions.

*The people of the State of California do enact as follows:*

1 SECTION 1. The Legislature finds and declares all of the  
2 following:

3 (a) It is the intent of the Legislature to increase enrollment and  
4 graduation rates among students meeting the requirements of  
5 Assembly Bill 540 of the 2001–02 Regular Session (Firebaugh,  
6 Ch. 814) by requiring the *designation of Dream Resource Liaisons*  
7 *and encouraging the creation of Dream Resource Centers* at public  
8 institutions of higher education.

9 (b) It is estimated that each year approximately 65,000  
10 undocumented students graduate from high schools, and while  
11 California has been a leader in enacting innovative and bold laws  
12 to provide opportunities for undocumented youth to attain higher  
13 education, only 20 percent of these students attend college. Many  
14 undocumented youth and their families are unaware of recent  
15 policy changes, such as the enactment of Assembly Bill 540 of the  
16 2001–02 Regular Session, the California Dream Act of 2011, and  
17 the federal Deferred Action for Childhood Arrivals (DACA), that  
18 make college graduation more attainable. Currently, the majority  
19 of college campuses do not have a centralized location that provides  
20 specialized support services and resources for students meeting  
21 the requirements of Assembly Bill 540 of the 2001–02 Regular  
22 Session.

23 (c) The creation of Dream Resource Centers would save staff  
24 time and resources by streamlining all available financial aid and  
25 academic opportunities for students meeting the requirements of  
26 Assembly Bill 540 of the 2001–02 Regular Session. These Dream  
27 Resource Centers would seek to empower and create a safe and  
28 welcoming environment for those students. These centers would  
29 increase enrollment, transfer, and graduation rates among this  
30 population.

31 (d) A number of college campuses have acknowledged the needs  
32 and challenges of these students and have created Dream Resource  
33 Centers. These include: the University of California, Los Angeles;  
34 the University of California, Davis; the California State University,  
35 Los Angeles; the California State University, Fullerton; and the  
36 California State University, Northridge. These centers provide,  
37 among other things, informational workshops, legal clinics,  
38 information on programs available to undocumented immigrants,

1 and peer mentoring and support services to increase awareness of  
2 existing programs and available resources, enhance professional  
3 development, and increase employment opportunities.

13 to establish Dream Resource Centers on each of their respective  
14 campuses.

15 (2) Dream Resource Centers may offer support services,  
16 including, but not necessarily limited to, state and institutional  
17 financial aid assistance, academic counseling, peer support services,  
18 psychological counseling, referral services, and legal services.

19 (d) (1) This section shall not be construed as ~~requiring~~  
20 *encouraging* the construction of a new or separate space for Dream  
21 Resource Centers.

22 (2) Dream Resource Centers may be housed within existing  
23 student service or academic centers.

24 (3) The space in which the Dream Resource Liaison is located  
25 may be deemed a Dream Resource Center.

26 (e) Notwithstanding Section 11005 of the Government Code  
27 and any other law requiring approval by a state officer of gifts,  
28 bequests, devises, or donations, the Trustees of the California State  
29 University, the Board of Governors of the California Community  
30 Colleges, and the Regents of the University of California may seek  
31 and accept on behalf of the state any gift, bequest, devise, or  
32 donation whenever the gift and the terms and conditions thereof  
33 will aid in the creation and operation of Dream Resource Centers  
34 for their respective systems.

35 (f) *This section shall become inoperative on July 1, 2022, and,*  
36 *as of January 1, 2023, is repealed, unless a later enacted statute,*  
37 *that becomes operative on or before January 1, 2023, deletes or*  
38 *extends the dates on which it becomes inoperative and is repealed.*
