An act to add Section 51226.7 to the Education Code, relating to pupil instruction.

LEGISLATIVE COUNSEL'S DIGEST

AB 2016, as amended, Alejo. Pupil instruction: ethnic studies.

Existing law requires the adopted course of study for grades 7 to 12, inclusive, to include, among other subjects, the social sciences. Existing law requires the State Board of Education, with the assistance of the Superintendent of Public Instruction, to establish a list of textbooks and other instructional materials that highlight the contributions of minorities in the development of California and the United States. Existing law establishes the Instructional Quality Commission and requires the commission to, among other things, recommend curriculum frameworks to the state board.

This bill would require the Instructional Quality Commission to develop, and ~~for~~ the state board to adopt, a model curriculum in ethnic studies, and would ~~require~~ *encourage* each school district and charter

school that maintains any of grades 9 to 12, inclusive, that does not otherwise offer a standards-based ethnic studies curriculum to offer a course of study in ethnic studies based on the model curriculum. ~~By imposing new duties on school districts and charter schools, the bill would impose a state-mandated local program.~~

~~The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.~~

~~This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to these statutory provisions.~~

Vote: majority. Appropriation: no. Fiscal committee: yes.

The people of the State of California do enact as follows:

- 1 SECTION 1. The Legislature finds and declares all of the
- 2 following:
- 3 (a) The State of California is committed to providing excellent
- 4 educational opportunities to all of its pupils.
- 5 (b) There are 92 languages other than English spoken throughout
- 6 the state, with the primary languages being Arabic, Armenian,
- 7 Cantonese, Korean, Russian, Spanish, Tagalog, and Vietnamese.
- 8 (c) There is a growing body of academic research that shows
- 9 the importance of culturally meaningful and relevant curriculum.
- 10 (d) Based on the National Education Association (NEA)
- 11 publication, *The Academic and Social Value of Ethnic Studies*,
- 12 the inclusion of ethnic studies in a curriculum has a positive impact
- 13 on pupils of color.
- 14 (e) Ethnic studies benefit pupils in observable ways, such as
- 15 pupils becoming more academically engaged, increasing their
- 16 performance on academic tests, improving their graduation rates,
- 17 and developing a sense of self-efficacy and personal empowerment.
- 18 (f) The state’s educational standards should be guided by core
- 19 values of equity, inclusiveness, and universally high expectations.
- 20 (g) The state is committed to its efforts to provide all pupils
- 21 with excellent educational opportunities, without regard to race,
- 22 gender, ethnicity, nationality, income, sexual orientation, or
- 23 disability.

1 (h) The state is committed to its obligation to ensure its youth
2 are college prepared and career ready, while graduating 100 percent
3 of its pupils.

4 (i) The implementation of various ethnic studies courses within
5 California’s curriculum that are A-G approved, with the objective
6 of preparing pupils to be global citizens with an appreciation for
7 the contributions of multiple cultures, will close the achievement
8 gap, reduce pupil truancy, increase pupil enrollment, reduce
9 dropout rates, and increase graduation rates.

10 (j) The state should support and work with the Commission on
11 Teacher Credentialing, California State University teaching
12 credential programs, and other relevant parties in establishing a
13 single subject ethnic studies credential. The state should also
14 support efforts in recruiting, training, and retaining teachers who
15 have relevant experience and educational background in the study
16 and teaching of ethnic studies.

17 SEC. 2. Section 51226.7 is added to the Education Code, to
18 read:

19 51226.7. (a) The Instructional Quality Commission shall
20 develop, and the state board shall adopt, a model curriculum in
21 ethnic studies to ensure quality courses of study in ethnic studies.
22 The model curriculum shall be developed with participation from
23 *faculty of ethnic studies programs at universities and colleges with*
24 *ethnic studies programs and a group of representatives of local*
25 *educational agencies, of whom a majority of whom are kindergarten*
26 *to grade 12, inclusive, teachers who have relevant experience or*
27 *education background in the study and teaching of ethnic studies.*

28 (b) The model curriculum shall be written as a guide to allow
29 school districts to adapt their courses to reflect the pupil
30 demographics in their communities. The curriculum shall include
31 examples of courses offered by local educational agencies ~~which~~
32 *that have been approved as meeting the A-G admissions*
33 *requirements of the University of California and the California*
34 *State University, including, to the extent possible, course outlines*
35 *for those courses.*

36 (c) On or before June 30, 2019, the Instructional Quality
37 Commission shall submit the model curriculum to the state board
38 for adoption, and the state board shall adopt the model curriculum
39 on or before November 30, 2019.

1 (d) The Instructional Quality Commission shall provide 45 days
2 for public comment before submitting the model curriculum to the
3 state board.

4 (e) Beginning in the school year following the adoption of the
5 model curriculum pursuant to subdivision (a), each school district
6 or charter school maintaining any of grades 9 to 12, inclusive, that
7 does not otherwise offer a standards-based ethnic studies
8 curriculum ~~shall~~ *is encouraged to* offer to all otherwise qualified
9 pupils a course of study in ethnic studies based on the model
10 curriculum. ~~The course shall be offered~~ *A school district or charter*
11 *school that elects to offer a course of study in ethnic studies*
12 *pursuant to this subdivision shall offer the course as an elective*
13 *in the social sciences or English language arts, arts and shall be*
14 *make the course* available in at least one year during a pupil's
15 enrollment in grades 9 to 12, inclusive.

16 (f) It is the intent of the Legislature that local educational
17 agencies submit course outlines for ethnic studies for approval as
18 A-G courses.

19 ~~SEC. 3.— If the Commission on State Mandates determines that~~
20 ~~this act contains costs mandated by the state, reimbursement to~~
21 ~~local agencies and school districts for those costs shall be made~~
