

ASSEMBLY BILL

Introduced by Assembly Member Santiago

An act to repeal Article 9.5 (commencing with Section 1970) of Chapter 4 of Division 2 of the Business and Professions Code, and to amend Section 128345 of, and to add Article 7 (commencing with Section 128587) to Chapter 5 of Part 3 of Division 107 of, the Health and Safety Code, relating to dentistry.

LEGISLATIVE COUNSEL'S DIGEST

AB 2485, as introduced, Santiago. Dental Corps Loan Repayment Program.

Existing law establishes the Dental Corps Loan Repayment Program of 2002 within the Dental Board of California. Existing law creates the Dentally Underserved Account within the State Dentistry Fund. The program assists dentists who practice in an underserved area with loan repayment pursuant to an agreement between the board and the dentist, as specified.

This bill would repeal those provisions and instead transfer the authority to implement the program to the Health Professions Education Foundation within the Office of Statewide Health Planning and Development and would rename the account the Dental Corps Loan Repayment Account. The bill would make funds in the account available, upon appropriation by the Legislature, for purposes of the program. The bill would require the foundation to submit a report to the Legislature by an unspecified date. The bill would make related findings and declarations.

The people of the State of California do enact as follows:

1 SECTION 1. The Legislature hereby finds and declares all of
2 the following:

3 (a) An adequate supply of dentists is critical to assuring the
4 health and well-being of California residents, particularly those
5 who live in medically underserved areas.

6 (b) It is in the best interest of the state and its residents that
7 dental services be provided throughout the state in a manner that
8 can be effectively accessed by the residents of all communities.

9 (c) The Dental Board of California has established the California
10 Dental Corps Loan Repayment Program of 2002 to improve access
11 to dental care for underserved populations.

12 (d) The Health Professions Education Foundation, established
13 in 1987, is the state’s only nonprofit foundation statutorily created
14 to encourage persons from underserved communities to become
15 health professionals and increase access to health providers in
16 medically underserved areas.

17 (e) The foundation improves access to health care in underserved
18 areas by providing scholarships, loan repayments, and programs
19 to health professional students and graduates who are dedicated
20 to providing direct patient care in those areas.

21 (f) It is the intent of the Legislature to move the California
22 Dental Corps Loan Repayment Program of 2002 from the Dental
23 Board of California to the Health Professions Education Foundation
24 within the Office of Statewide Health Planning and Development.

25 SEC. 2. Article 9.5 (commencing with Section 1970) of Chapter
26 4 of Division 2 of the Business and Professions Code is repealed.

27 SEC. 3. Section 128345 of the Health and Safety Code is
28 amended to read:

29 128345. The Health Professions Education Foundation may
30 do any of the following:

31 (a) Solicit and receive funds from business, industry,
32 foundations, and other private or public sources for the purpose
33 of providing financial assistance in the form of scholarships or
34 loans to African-American students, Native American students,
35 Hispanic-American students, and other students from

1 underrepresented groups. These funds shall be expended by the
2 office after transfer to the Health Professions Education Fund,
3 created pursuant to Section 128355.

4 (b) Recommend to the director the disbursement of private
5 sector moneys deposited in the Health Professions Education Fund
6 to students from underrepresented groups accepted to or enrolled
7 in schools of medicine, dentistry, nursing, or other health
8 professions in the form of loans or scholarships.

9 (c) Recommend to the director a standard contractual agreement
10 to be signed by the director and any participating student, that
11 would require a period of obligated professional service in the
12 areas in California designated by the commission as deficient in
13 primary care services. The agreement shall include a clause
14 entitling the state to recover the funds awarded plus the maximum
15 allowable interest for failure to begin or complete the service
16 obligation.

17 (d) Develop criteria for evaluating the likelihood that applicants
18 for scholarships or loans would remain to practice their profession
19 in designated areas deficient in primary care services.

20 (e) Develop application forms, which shall be disseminated to
21 students from underrepresented groups interested in applying for
22 scholarships or loans.

23 (f) Encourage private sector institutions, including hospitals,
24 community clinics, and other health agencies to identify and
25 provide educational experiences to students from underrepresented
26 groups who are potential applicants to schools of medicine,
27 dentistry, nursing, or other health professions.

28 (g) Prepare and submit an annual report to the office
29 documenting the amount of money solicited from the private sector,
30 the number of scholarships and loans awarded, the enrollment
31 levels of students from underrepresented groups in schools of
32 medicine, dentistry, nursing, and other health professions, and the
33 projected need for scholarships and loans in the future.

34 (h) Recommend to the director that a portion of the funds
35 solicited from the private sector be used for the administrative
36 requirements of the foundation.

37 (i) Implement the Steven M. Thompson Physician Corps Loan
38 Repayment Program and the Volunteer Physician Program, as
39 provided under Article 5 (commencing with Section 128550).

1 (j) *Implement the California Dental Corps Loan Repayment*
2 *Program, as provided under Article 7 (commencing with Section*
3 *128587) of Chapter 5 of Part 3 of Division 107.*

4 SEC. 4. Article 7 (commencing with Section 128587) is added
5 to Chapter 5 of Part 3 of Division 107 of the Health and Safety
6 Code, to read:

8 Article 7. California Dental Corps Loan Repayment Program

10 128587. (a) There is hereby established the California Dental
11 Corps Loan Repayment Program within the Health Professions
12 Education Foundation within the Office of Statewide Health
13 Planning and Development.

14 (b) It is the intent of the Legislature in enacting this article that
15 the foundation and the office provide the ongoing program
16 management for the program.

17 128587.2. For purposes of this article, the following definitions
18 apply:

19 (a) “Account” means the Dentally Underserved Account, which
20 is contained within the fund.

21 (b) “Board” means the Dental Board of California.

22 (c) “Dentally underserved area” means a geographic area eligible
23 to be designated as having a shortage of dental professionals
24 pursuant to Part I of Appendix B to Part 5 of Chapter 1 of Title 42
25 of the Code of Federal Regulations or an area of the state in which
26 unmet priority needs for dentists exist as determined by the
27 California Healthcare Workforce Policy Commission pursuant to
28 Section 128224.

29 (d) “Dentally underserved population” means persons without
30 dental insurance and persons eligible for Denti-Cal who are
31 population groups described as having a shortage of dental care
32 professionals in Part I of Appendix B to Part 5 of Chapter 1 of
33 Title 42 of the Code of Federal Regulations.

34 (e) “Fund” means the State Dentistry Fund.

35 (f) “Medi-Cal threshold languages” means primary languages
36 spoken by limited-English-proficient (LEP) population groups
37 meeting a numeric threshold of 3,000, eligible LEP Medi-Cal
38 beneficiaries residing in a county, 1,000 Medi-Cal eligible LEP
39 beneficiaries residing in a single ZIP Code, or 1,500 LEP Medi-Cal
40 beneficiaries residing in two contiguous ZIP Codes.

1 (g) “Office” means the Office of Statewide Health Planning and
2 Development.

3 (h) “Program” means the California Dental Corps Loan
4 Repayment Program.

5 (i) “Practice setting” means either of the following:

6 (1) A community clinic, as defined in subdivision (a) of Section
7 1204 and subdivision (c) of Section 1206, a clinic owned or
8 operated by a public hospital and health system, or a clinic owned
9 and operated by a hospital that maintains the primary contract with
10 a county government to fulfill the county’s role pursuant to Section
11 17000 of the Welfare and Institutions Code, which is located in a
12 dentally underserved area and at least 50 percent of whose patients
13 are from a dentally underserved population.

14 (2) A dental practice or dental corporation, as defined in Section
15 1800 of the Business and Professions Code, located in a dentally
16 underserved area and at least 50 percent of whose patients are from
17 a dentally underserved population.

18 128587.4. (a) A program applicant shall possess a current
19 valid license to practice dentistry in this state issued by the board
20 pursuant to Section 1626 of the Business and Professions Code.

21 (b) The foundation shall develop the guidelines for selection
22 and placement of applicants.

23 (1) The guidelines shall provide priority consideration to
24 applicants who are best suited to meet the cultural and linguistic
25 needs and demands of dentally underserved populations and who
26 meet one or more of the following criteria:

27 (A) Speak a Medi-Cal threshold language.

28 (B) Come from an economically disadvantaged background.

29 (C) Have received significant training in cultural and
30 linguistically appropriate service delivery.

31 (D) Have worked with dentally underserved populations for at
32 least three years.

33 (E) Recently received a license to practice dentistry.

34 (2) The guidelines shall include a process for determining the
35 needs for dental services identified by the practice setting. At a
36 minimum, the practice setting shall meet all of the following
37 criteria:

38 (A) The practice setting shall be located in a dentally
39 underserved area.

1 (B) The practice setting shall ensure that the program participant
2 serves a patient population that consists of at least 50 percent
3 dentally underserved populations.

4 (3) The guidelines shall seek to place the most qualified
5 applicants under this section in the areas with the greatest need.

6 (4) Guidelines shall include a factor ensuring geographic
7 distribution of placements.

8 (c) A program applicant shall be working in, or have a signed
9 agreement with, an eligible practice setting. The program
10 participant shall be employed on a full-time basis. Full-time basis
11 shall be defined by the board, and the board may establish
12 exemptions to this requirement on a case-by-case basis.

13 (d) A program participant shall commit to a minimum of three
14 years of service in a dentally underserved area. The foundation
15 shall develop the process for determining the maximum length of
16 an absence and the process for reinstatement of a participant. Loan
17 repayment shall be deferred until the dentist is employed on a
18 full-time basis.

19 (e) The foundation shall develop a process to use if a dentist is
20 not able to complete his or her three-year obligation.

21 (f) The foundation shall develop a process for outreach to
22 potentially eligible applicants.

23 (g) The foundation may adopt any other standards of eligibility,
24 placement, and termination appropriate to achieve the aim of
25 providing competent dental services in these approved practice
26 settings.

27 128587.6 (a) The Dentally Underserved Account, formerly
28 established pursuant to subdivision (a) of Section 1973 of the
29 Business and Professions Code, in the State Dentistry Fund in the
30 Professions and Vocations Fund in the State Treasury is hereby
31 renamed the Dental Corps Loan Repayment Account and
32 established by this section in the State Dentistry Fund.

33 (b) (1) Funds placed in the account shall be available upon
34 appropriation by the Legislature.

35 (2) Funds in the account shall be used by the foundation to repay
36 the loans per agreements made with dentists.

37 (3) Funds paid out for loan repayment may have a funding match
38 from foundations or other private sources.

39 (4) Loan repayments may not exceed a total of one hundred five
40 thousand dollars (\$105,000) per individual licensed dentist.

1 (5) Notwithstanding Section 11005 of the Government Code,
2 the foundation may seek and receive funds from foundations and
3 private sources to be placed into the account.

4 128587.8. The terms of loan repayment granted under this
5 article shall be as follows:

6 (a) After a program participant has completed one year of
7 providing services as a dentist in a dentally underserved area, the
8 board shall provide up to twenty-five thousand dollars (\$25,000)
9 for loan repayment.

10 (b) After a program participant has completed two consecutive
11 years of providing services on a full-time basis as a dentist in a
12 dentally underserved area, the board shall provide up to an
13 additional thirty-five thousand dollars (\$35,000) of loan repayment,
14 for a total loan repayment of up to sixty thousand dollars (\$60,000).

15 (c) After a program participant has completed three consecutive
16 years of providing services on a full-time basis as a dentist in a
17 dentally underserved area, the board shall provide up to a maximum
18 of forty-five thousand dollars (\$45,000) of loan repayment, for a
19 total loan repayment of up to one hundred five thousand dollars
20 (\$105,000).

21 128587.9. (a) On or before ____, the foundation shall submit
22 a report to the Legislature regarding the experience of the program,
23 an evaluation of its effectiveness in improving access to dental
24 care for underserved populations, and recommendations for
25 maintaining or expanding its operation, including, but not limited
26 to, all of the following:

- 27 (1) Number of program participants.
- 28 (2) Practice locations.
- 29 (3) Amount of funds expended.
- 30 (4) The information on annual performance reviews by practice
31 settings and program participants.

32 (b) The report to the Legislature pursuant to subdivision (a)
33 shall be submitted in compliance with Section 9795 of the
34 Government Code.

35 (c) This section shall remain in effect only until ____, and as
36 of that date is repealed, unless a later enacted statute, that is enacted
37 before ____, deletes or extends that date.
