Senate Concurrent Resolution No. 20—Relative to peace officers.

LEGISLATIVE COUNSEL’S DIGEST

SCR 20, as introduced, Galgiani. California Peace Officers’ Memorial Day.

This measure would designate Monday, May 4, 2015, as California Peace Officers’ Memorial Day, and would urge all Californians to honor those individuals who have given their lives for our safety and express appreciation to those who continue to dedicate themselves to making California a safer place in which to live and raise our families.

- 1 WHEREAS, Monday, May 4, 2015, is California Peace Officers’
2 Memorial Day, a day Californians observe in commemoration of
3 those noble officers who have tragically sacrificed their lives in
4 the line of duty; and
5 WHEREAS, Although California citizens are indebted to our
6 California peace officers each day of the week, we make particular
7 note of their bravery and dedication and we share in their losses
8 on California Peace Officers’ Memorial Day; and
9 WHEREAS, California peace officers have a job second in
10 importance to none, and it is a job that is as difficult and dangerous
11 as it is important; and
12 WHEREAS, The peace officers of California have worked
13 dutifully and selflessly on behalf of the people of this great state,
14 regardless of the peril or hazard to themselves; and

1 WHEREAS, By the enforcement of our laws, these same officers
2 have safeguarded the lives and property of the citizens of California
3 and have given their full measure to ensure these citizens the right
4 to be free from crime and violence; and

5 WHEREAS, Special ceremonies and observations on behalf of
6 California peace officers provide all Californians with the
7 opportunity to appreciate the heroic men and women who have
8 dedicated their lives to preserving public safety; now, therefore,
9 be it
