Senate Joint Resolution No. 9—Relative to the Chronic Kidney Disease Improvement in Research and Treatment Act.

LEGISLATIVE COUNSEL'S DIGEST

SJR 9, as amended, Stone. The Chronic Kidney Disease Improvement in Research and Treatment Act.

This measure would urge the President and the Congress of the United States to enact the Chronic Kidney Disease Improvement in Research and Treatment Act.

1 WHEREAS, Approximately 50 years ago, kidney failure was
2 a death sentence; and

3 WHEREAS, In 1972, Congress developed the Medicare
4 End-Stage Renal Disease benefit. In doing so, Congress ensured
5 that regardless of age or income, any American would have access
6 to life-saving dialysis care. That was the turning point in kidney
7 care; and

8 WHEREAS, The Chronic Kidney Disease Improvement in
9 Research and Treatment Act (HR 1130) was introduced in the
10 House of Representatives by Representative Tom Marino to address
11 kidney disease care; and

1 WHEREAS, House Resolution 1130 is built on three primary
2 tenets. First, for individuals living with chronic diseases, especially
3 when those diseases are complicated by multiple comorbid
4 conditions, coordinated care is key to improving outcomes and
5 lowering health care costs. Second, increased research can lead to
6 a deeper understanding of kidney disease prevention and ultimately
7 to significant innovations in treatment. Lastly, stability in the
8 Medicare program is central to an end-stage renal disease program
9 that ensures quality and produces optimal results; and

10 WHEREAS, If left untreated, chronic kidney disease can
11 progress to kidney failure, also known as end-stage renal disease,
12 and early cardiovascular death; and

13 WHEREAS, More than 20 million adults in the United States,
14 or more than 10 percent of the adult population, are estimated to
15 have chronic kidney disease and most are undiagnosed; and

16 WHEREAS, Kidney disease is the ninth leading cause of death
17 in the United States; and

18 WHEREAS, In the United States, diabetes and *high blood*
19 *pressure* are the leading causes of kidney failure, accounting for
20 72 percent or about three out of four new cases of kidney failure;
21 and

22 WHEREAS, The number of kidney failure cases in the United
23 States population has more than tripled since 1990 and is expected
24 to grow because of an aging population and the increasing number
25 of people with conditions, such as diabetes and high blood pressure,
26 that place them at the risk of developing chronic kidney disease;
27 now, therefore, be it

28 *Resolved by the Senate and the Assembly of the State of*
29 *California, jointly*, That the Legislature urges the President and
30 the Congress of the United States to enact the Chronic Kidney
31 Disease Improvement in Research and Treatment Act (HR 1130);
32 and be it further

33 *Resolved*, That the Secretary of the Senate transmit copies of
34 this resolution to the President of the United States, to each Senator
35 and Representative from California in the Congress of the United
36 States, and to the author for appropriate distribution.
